# IV. Consideration of the Report of the Executive Council on the Audit of the Union and the Report of the Ministerial Committee on the Union Government

Pursuant to Declaration Assembly/AU/Decl. 2 (IX) adopted by the Assembly in Accra, Ghana, in July 2007, the Assembly shall consider the Report of the Executive Council on the Audit of the African Union submitted by the High Level Panel established by the Chairperson of the Union as well as the Report of the Ministerial Committee on the Union Government together with the recommendations of the Executive Council on it.

# V. Election and Appointment of the Chairperson and Deputy Chairperson - Doc. Assembly/AU/2(X)

Pursuant to Decision Assembly/AU/Dec. 168 (IX), which stipulates inter alia, "Decides to defer the election of members of the Commission to the forthcoming sessions of the policy organs scheduled for January 2008", the Assembly is to elect the Chairperson of the Commission and his or her Deputy.

### VI. Appointment of the Commissioners

The Assembly is to appoint the Commissioners elected, on delegation of power, by the Executive Council and shall adopt a decision in this regard.

### VII. Appointment of the Members of the Peace and Security Council

The Assembly is to appoint the Members of the Peace and Security Council elected, on delegation of power, by the Executive Council and shall adopt a decision in this regard.

### VIII. Adoption of the Budget for 2008

The Draft Budget for 2008 will be first considered by the PRC, then by the Executive Council before it is finally adopted by the Assembly in accordance with the relevant provisions of the Constitutive Act of the African Union and the Rules of Procedure of the Assembly.
