REPORT OF THE COMMISSION ON THE IMPLEMENTATION OF PREVIOUS DECISIONS OF THE EXECUTIVE COUNCIL AND THE ASSEMBLY

INTRODUCTION

In accordance with Decision [Assembly/AU/Dec.318 (XV)], adopted by the 15th Ordinary Session of the Assembly held in Kampala, Uganda in July 2010, and in line with the Conclusions of the PRC/Commission Retreat held from 31 March to 2 April 2011, in Nazareth, Ethiopia, the Commission is pleased to submit this Report which gives an account of actions taken and challenges encountered in the process of implementation of the various Decisions and Declarations taken by the policy organs of the Union, spanning from the Kampala July 2010 Summit to the July 2012 Summit held in Addis Ababa.

At their various Ordinary, Extraordinary and Special Sessions, the Executive Council and the Assembly of the Union, had adopted a number of decisions, declarations and resolutions at the conclusion of their deliberations, which constitute the legal authority for the Commission, Member States, and the other Organs of the Union to pursue actions necessary for the integration process of the Continent. Many of those actions and activities were carried out in collaboration with Member States, the other AU Organs, stakeholders and partners such as the Regional Economic Communities (RECs), in the form of consultation and coordination meetings aimed at harmonizing actions and viewpoints that would facilitate the adoption of common positions and collective policy decisions by the AU Policy Organs.

The activities carried out during the period under consideration range from legal, administrative, financial, political and peace and security issues to economic, social, scientific and cultural matters and cover various subjects and numerous important issues of interest to Member States and to the continent in general, some of which the reports currently being considered under the Agenda of the Executive Council and/or that of the Assembly are based upon. Furthermore, the statements of the Chairperson of the Commission during the opening of both the Executive Council and the Assembly did give an account of stewardship of actions taken during the last twelve months, in the implementation of some decisions of the Executive Council and the Assembly. However, despite the remarkable efforts made, it is pertinent to note that the Decisions that have emanated from such noble creative approaches have witnessed difficulties in their implementation.

In order to present a concise and comprehensible report, the Commission has avoided duplication as much as possible on such Decisions in which detailed and self-explanatory Reports had been submitted for consideration under the Agenda Items of the present sessions of the Executive Council and Assembly.

Problems identified in the implementation of the Decisions and Recommendations:

It is common knowledge that many decisions taken at various sessions of the Executive Council and Assembly have been met with very little degree of implementation. The reasons for the low execution level of the Decisions could be attributable to various factors such as:

- The high number of decisions taken at each Session
- Budgetary, human and Technical constraints
- Quasi dependency on Partners' support
- Short time-frame for reporting

It is also worth highlighting that although majority of the decisions are supposed to be implemented by Member States, feedback by the latter has not been forthcoming.

Recommendations:

1. The Commission should ensure compliance with the Guidelines on the preparation and adoption of decisions and the time-frame for implementation as means of stream-lining and further reducing the number of decisions adopted at each Session of the Executive Council and the Assembly.
2. Financial, human and Technical resources should be made available to facilitate the implementation of decisions where these factors have been identified as constituting an impediment.
3. Member States should endeavour to provide and in a timely manner, their inputs to the report on implementation of previous decisions.
4. Proper scrutiny should be made at all levels of the Financial, Legal, and material implications prior to the adoption of any decision.

**Report on Modalities for Process of Selection of Recipients of
The Wangari Maathai Award for Outstanding African Achievements
in Environment and Biodiversity Conservation**

Report on Modalities for Process of Selection of Recipients of The Wangari Maathai Award for Outstanding African Achievements in Environment and Biodiversity Conservation

1. Purpose

This draft modality is prepared in accordance with Assembly Decision on the Wangari Maathai Award for Outstanding African Achievements in Environment and Biodiversity Conservation (Assembly/AU/Dec.382(XVII), in which the Assembly , among other things (a) approved the proposal to create a Wangari Maathai Award, and (b) requested the commission in collaboration with the Republic of Kenya, the United Nations Environment Programme (UNEP), the Green Belt Movement and other interested parties “to define the modalities of establishing the Award and report thereon to the next Ordinary Session of the Assembly in June/July 2012 on ways to operationalize this Decision.”

The purpose of the modality is, within the framework of the Assembly Decision, to elaborate and clarify the eligibility, nominating, selection and presentation procedures and processes to be used for conferring the Award. It is also intended to propose the value of the prize and possible sources of its funding.

2. Eligibility

The Assembly Decision has identified those eligible for the Award Prize as “individuals committed to preserving the environment”. The reference made to the individuals as eligible may be interpreted as an African individual, community based groups and African institutions. Therefore, all citizens of AU Member States, community based groups and African institutions shall be eligible for the Prize.

3. Value of the Award

The Award will consist of a trophy on which text will be engraved describing the beneficiary and the Prize, and a cash Prize of 100,000 US Dollars which will be shared among five awardees, one from each of the five geographical regions of Africa.

4. Nomination

The nomination process shall commence with a formal announcement by the commission of the African Union inviting Member states and relevant African institutions to submit their proposals for individual nominations. The announcement shall be made by the commission 9 months prior to the Award ceremony. Proposals for nomination shall be received no later than 5 months prior to the Award ceremony at the AU Summit in July.

5. Screening and Selection

5.1. A Technical Committee shall be established for the purpose of screening proposals submitted for consideration and short-listing of three finalists. The Technical Committee shall be composed of:

- Commissioner for Rural Economy and Agriculture, Chair;
- Representative of the United Nations Environment Programme (UNEP);
- Representative of the Green Belt Movement;
- Representative of the African Development Bank;
- Representative of the UN Economic Commission for Africa, ECA;
- Representative of the Wangari Maathai Institute for Peace and Environmental Studies;
- Representative of the Economic, Social and Cultural Council of the African Union (AU- ECOSOCC).

5.2. The Technical committee shall:

- Propose, consistent with the framework as broadly defined in the Assembly Decision, a specific thematic area of focus to be considered for the Award in a particular round;
- Elaborate the selection criteria including the relative weights to be assigned for each of the criterion, for its use in screening the proposals;
- Submit, six months before the award ceremony, its recommendations to the High Level Panel that will be established for making the final selection of the individuals to receive the Award.

5.3. The High Level Panel shall consist of:

- The Chairperson of the Commission of the African Union, Chair;
- Commissioner for Rural Economy and Agriculture;
- Five Ministers of Environment – that is, one Minister of Environment each of the Regions of Africa (however, the country whose citizen is short-listed as finalist cannot sit in the High level panel).

The High Level Panel shall:

- Receive report from the Technical Committee outlining the processes, outcomes and recommendations on the screening process;
- Based on the recommendation of the Technical Committee, and other additional relevant considerations that make it explicit, decide on the selection of the individual who should be awarded the prize;

6. Notification of the Selection Outcome

The individual persons, community based groups or African institutions who are selected shall be notified by the commission of its selection not later than two months before the awarding ceremony.

7. Presentation of the Award

The Award will be conferred and presented to the winners or their representatives by the Chairperson of the AU during the June/July Summit, in a special ceremony.

8. Resource mobilization for the Award

There are several options for resource mobilization. These include:

8.1. Budgetary provision in the African Union Commission's regular budget.

To ensure African ownership, and sustainability of the Award, it is of crucial importance that a budgetary provision is made for the Award in the AUC regular budget as from 2014. The budget should come from the Member States contribution.

8.2. As a start, Member States of the African Union are invited to make voluntary pledges for funding the first award in 2013.

8.3. Contributions from the private sector and partners

Voluntary contributions from Member States, foundations, private sector and partners will be lodged in a trust fund. The trust fund will be managed by a board of trustees that will draw its membership from all relevant stakeholder institutions.

The estimated financial requirements for operationalization of the Award (including the prize itself, facilitation of the screening and selection processes as well as logistics related to conferring of the Award) could be around 250,000 Dollar. To ensure its sustainability, the Award should be given biennially.
