**REPORT ON THE ELECTION OF ONE (1) MEMBER OF THE AFRICAN  
COMMITTEE OF EXPERTS ON THE RIGHTS AND WELFARE OF THE CHILD  
(ACERWC)**

1. The election of members of the African Committee of Experts on the Rights and Welfare of the Child (ACERWC) is governed by the provisions of the African Charter on the Rights and Welfare of the Child (the Charter) and the Rules of Procedure of the Executive Council.
2. The ACERWC is established by Article 33 (1) of the Charter. Under Article 33 (1) of the Charter, the ACERWC shall consist of eleven (11) members of high moral standing, integrity, impartiality and competence in matters of the rights and welfare of the child. Furthermore, Article 33 (3) of the Charter provides that the ACERWC shall not include more than one (1) national from the same State.
3. It should be noted that according to the practices of the Union, during the election, the Executive Council should respect the principles of equitable geographical representation and equitable gender representation.
4. It should be recalled that the Assembly adopted Decision Assembly/AU.356 (XVI) during its Sixteenth Ordinary Session held in Addis Ababa, Ethiopia in January 2011, in which the Commission was requested to *“ensure the respect of the principle of geographical representation in all African Union organs with elected members, except in cases where a region which has been duly informed has not presented candidates”*.
5. Furthermore, during the June 2015 Summit held in Johannesburg, South Africa, the Assembly adopted decisions Assembly/AU/Dec.575 (XXV) and Dec.576 (XXV) wherein it requested the Commission to prepare modalities to ensure the scrupulous respect of the principles of equitable regional and gender representation in all AU organs and institutions, and to submit the modalities during the January 2016 Summit. It is therefore expected that this election will have to be conducted in conformity with the Modalities that will be adopted by the policy organs in January 2016<sup>1</sup>.
6. This election is being conducted due to the expiry of the term of office of Ms. Julia Sloth-Nielsen (South Africa), a member of ACERWC who was elected in January 2011 for a term of five (5) years, pursuant to the provisions of Article 37 (1) of the Charter. Her term shall expire in January 2016.
7. It should be noted that Ms. Julia Sloth-Nielsen (South Africa) is eligible for re-election only once in conformity with decision Assembly/AU/Dec. 548 (XXIV) on Amendment of Article 37 (1) of the African Charter on the Rights and Welfare of the Child adopted during its Twenty Fourth Ordinary Session held in Addis Ababa, Ethiopia in January 2015.
8. In this regard, the current election relate to the election of one (1) Members of the ACERWC for a five (5) year term.

**4 : SUMMARY OF RELEVANT WORK EXPERIENCE**

Mrs KEMBO TAKAM GATSING HERMINE has been in the Magistracy in Cameroon for about 14 years. Since December 2014, she is Sub-Director for Human Rights in the Ministry of Justice in Cameroon, after being, for six years Assistant Research Officer within the Department of Human Rights and International Co-operation of the said Ministry. From 2001 to 2008, she has been posted to the Legal Department as Assistant State counsel and to the Bench as Presiding Magistrate and Examining Magistrate.

In these different capacities, she has developed skills in Human Rights, including Child Rights with regards to protection of children rights in the administration of justice, capacity building, planning and evaluation.

As far as the protection of children rights in the administration of justice is concerned, she has adjudicated numerous criminal matters involving children in conflict with the law, children victim or witness of offences. In civil matters, while posted in courts vested with jurisdiction in family law, she has adjudicated child rights related cases such as divorce, adoption.

Since 2009, she has been managing capacity building programs in Human Rights for the judiciary and the penitentiary administration, with specific courses on Child rights, Women rights,

Refugee law, Rights of persons deprived of liberty, Fight against human trafficking. In light with the foregoing, she participated in the conception of a toolkit for the training of Magistrates on Child Rights in the National School of Administration and Magistracy. She has moderated seminars and workshops on juvenile justice and on alternative measures to deprivation of liberty. She has also been called in some universities in Cameroon, to make a presentation of the African Human Rights System, which is the subject matter of a book she recently published.

With regards to planning, she was member of the team in charge of drafting the National Action Plan for the Promotion and Protection of Human Rights in Cameroon which has a whole section on Child Rights.

Finally, since 2006, she is member of the Drafting Committee of the Report by the Ministry of Justice on Human Rights in Cameroon. She is involved in the follow up of the co-operation of the State of Cameroon with international and regional Human Rights mechanisms. She has also contributed to the drafting and defense of Reports submitted by Cameroon before the African Commission of Human and People's Rights, the African Committee of Experts on the Rights and Welfare of the Child, the Human Rights Committee and the Human Rights Council.
