Following the decision of the Heads of State and Government of the OAU at its 18th Summit held in Nairobi, Kenya in June 1981, to despatch a Pan-African Peace-Keeping Force to Chad in order to ensure the restoration of peace and security in that country, and assist in the training of an Integrated Chadian national army and pursuant to Resolution AHG/110 (XIX) adopted at the 19th OAU Summit of the Assembly of Heads of State and Government requesting the Advisory Committee on Administrative, Budgetary and Financial Matters to study the financial implications of the participation in the operation of the Pan-African Peace-Keeping Force and make recommendations to the next session of the Council The General Secretariat wishes to submit for the of Ministers. consideration of the Advisory Committee, details of expenditure submitted by four of the Member States who participated in the Peace-Keeping Operations.

The countries are:

- 1) the Federal Republic of Nigeria with a claim of US\$82,952,576.35;
- 2) the People's Republic of the Congo with a claim of CFA.858,116,409.80 and
- 3) the Republic of Kenya with a claim of US\$44,878.93.

4) the Republic of Zaire with a claim of US\$9.453,242.00.

Details of these claims are attached as Add. I, II, III and TV to this document.

The Embassy of the Federal Republic of Nigeria presents its compliments to the General Seccretariat of the OAU and has the honour to forward herewith the Aide Memoire giving details of the expenditure incurred by the Federal Republic of Nigeria on behalf of the OAU, in respect of Nigeria's participation in the Pan-African Peace-Keeping efforts in Chad.

The Embassy wishes to recall that this subject was discussed at the recently concluded 19th OAU Summit which adopted Resolution AHG/110(XIX) requesting the Advisory Committee on Budgetary and Financial Matters to study the financial implications of the participation in the operations by the appropriate member—States, namely: Congo, Senegal, Zaire, Nigeria and make recommendations to the next session of the Council of Ministers.

The Embassy wishes also to add that the formal presentation of Nigeria's bill on that operation is being made to the OAU Secretariat through the submission of this Aide Memoire, for necessary and early reimbursement.

The Embassy of the Federal Republic of Nigeria avails itself of this opportunity to renew to the General Secretariat of the OAU the assurances of its highest consideration.

REIMBURSEMENT OF EXPENDITURE INCURRED
BY NIGERIA ON BEHALF OF THE O.A.U. IN
RESPECT OF HER PARTICIPATION IN THE
PAN-AFRICAN PEACE-KEEPING OPERATIONS
IN CHAD: NOVEMBER 1981 TO JUNE 30TH 1982

Following the decision of the Heads of State and Government of the Organisation of African Unity (0.A.U.) at their 18th Summit held in Nairobi, Kenya, in June 1981, to despatch a Pan-African Peace-keeping Force to Chad in order to ensure the restoration of peace and security in that country, and assist in the training of an Integrated Chadian national army, seven (7) 0.A.U. member-states, namely: Benin, Gabon, Guinea, Nigeria, Senegal, Togo and Zaire, volunteered to provide troops to serve in the Force. Out of the three (3) countries - Senegal, Zaire and Nigeria - which did eventually contribute troops, Nigeria had by far the largest contingent consisting of two (2) battalions, in the first instance.

Later, in February 1982 at the peak of the peace-keeping operation, Nigeria provided another battalion at the request of the Chadian government and of the O.A.U. current Chairman, in order to make up for the operational inadequacies resulting from the absence of troops from the member-states that had initially promised but failed to contribute troops to the Force. However, with the subsequent withdrawal by Nigeria of one battalion from the Chadian town of Ati in March 1982, one thousand five hundred and eighty seven (1.587) Nigerian troops remained involved in the Pan-African Peace-Keeping Operation in Chad as at June 12, 1982, that is, about half of the total composition of the Pan-African Army. In spite of the fact that Nigeria assumed the greatest responsibility in the Pan-African Peace-Keeping Force by virtue of the number of troops committed, and of having provided the Force Commander, namely Major-General G.O. Ejiga, Nigeria also had to take on the additional task of providing logistical facilities such as Air Detachment, Maintenance and Engineering Corps, signals and Communications Units, the initial absence of which almost jeopardised the entire operation from the onset. The Nigerian Air Force, for example, provided single-handedly the much needed Air Cover for all the contingents, ensuring transportation for troop and personnel deployment, the ferrying of supplies and the moving of emergency casualty cases to Bama in Nigeria for medical attention. The medical units attached to each contingent were grossly ill-equipped for such serious cases. In addition, the Nigerian contingent sometimes had to extend

its own supplies, including rations, to the other contingents in their times of need. Most of the administrative and logistical wherewithals for the effective functioning of the Force Headquarters were supplied by Nigeria. The abovementioned logistic requirements had either not been envisaged at the inception of the operations, or had been assigned to the contingents of member-states which failed to turn up.

The financial strain on the troop contributors, and on Nigeria in particular, was considerable, as these countries had to bear all alone, what was the financial responsibility of all the member-states of the Organization of African Unity (0.A.U.) The total monthly expenditure for Nigeria, calculated about March 1982, was as high as U.S. \$ 5\frac{1}{2}\$ million.

The O.A.U. had proved incapable of assuming its responsibility to finance the Pan-African Peace-Keeping Force; promises of assistance by some Western nations, notably France and the United States of America, had not materialised.

The Standing Committee on Chad, the current O.A.U. Chairman as well as the Secretary-General made persistent, passionate, but unsuccessful appeals to member-states to pay up their assessed contributions to the Inter-African Force Fund, targeted at U.S. \$192 million for one year, so as to relieve the financial burden on Nigeria and the other troop contributors. Following the initiative of the current O.A.U. Chairman in consultation with the Chadian government, the United Nations Security Council met in April 30th, 1982, and adopted a resolution setting up a "Fund for Assistance to the Peace-Keeping Force of the Organisation of African Unity to be supplied by voluntary contributions." No contribution had however been made at the termination of the Peace-Keeping operations, on June 30th, 1982.

Considering, therefore, that the 19th Summit held at Addis Ababa in June 1983 has, in its resolution AHG/110(XIX) on the "O.A.U. Mission to Chad" mandated "the Advisory Committee on Budgetary and Financial matters to study the financial implications of the peace-keeping missions of the Congo. Senegal, Zaire and Nigeria" and to submit recommendations to the next session of the Council of Ministers, Nigeria is, by this aide memoire, formally presenting to the O.A.U. General Secretariat the total actual expenditure incurred by her in respect of her participation in the Pan-African Force in Chad. It is necessary to also place on record the human losses, incalculable in monetary terms, suffered by the Nigerian contingent. Four Nigerian soldiers died while serving in the Pan-African Force; three of natural causes; and one, as a result of skirmishes with troops of the Chadian government, the GUNT.

The breakdown of the expenditure which totals 55,301,717.53k (fifty five million, three hundred and one thousand, seven hundred and seventeen Naira fifty three kobo.) is as follows:

EXPENSES INCURRED BY THE PEOPLE'S REPUBLIC OF THE CONCO ON THE 36TH MECHANIZED INFANTRY BRIGADE DURING THE OPERATION IN NDJAMENA

The expenses incurred by the People's Republic of the Congo in connection with the Ndjamena operations covered the period November 1979, date on which the first batch of the Congolese Troops arrived in Ndjamena to April 30 when the last batch left Garona where they transited.

However, the attached summary statement shows expenses incurred after April. This was due to the fact that some suppliers contacted by the People's National Army had agreed to supply clothings and other items to the People's Republic of the Congo on credit. Such is the case of the three contracts signed with.

- 1) The "Bureau Technique Huguet S.A. B.P 173
 Brazzaville," for the provision of medical supplies and equipment.
- 2) The "Societe Afric B.P. 396 Brazzaville" for the supply of 265 beds with mosquito net poles.
- 3) The "Societe SOFRANA" and CHINA AFRICA TRADING Corporation the Head Offices of which are located at "14 rue des Rosiers, 93,4000 Saint-Ouen (France)" and 72 Queen's Road, Central, Room 501 5th Floor (Hong-Kong) respectively, for the supply of clothings.

Some explanation needs to be given regarding the bill for the supply.

Indeed, up to the end of 1980, the mobilized officers and men of the 36th Battalion were fed at the barracks with food items provided by the Central Supplies Depot and the cost charged to the CFA 130,000,000 voted for the Ndjamena operation.

INTRODUCTION TO THE DRAFT RESOLUTION ON THE REQUEST BY THE PEOPLE'S REPUBLIC OF THE CONGO TO BE COMPENSATED FOR THE EXPENSES IT HAS INCURRED ON ITS TROOPS THAT SERVED ON THE AFRICAN PEACE-KEEPING FORCE IN CHAD

With the signing of the Charter of the Organization of African Unity in the evening of 25 May 1963, by the African Heads of State and Government, a new framework of consultations and action had been created. The Heads of State and Government were then firmly resolved to safeguard and consolidate their hard won independence and sovereignty, as well as the territorial integrity of their States on the basis of the principle of inviolability of the borders inherited from colonization, and to combat and eradicate colonialism, neo-colonialism and all forms division and disunity.

For almost twenty (20) years, OAU has relentlessly worked to ensure peace, freedom and progress on the African continent. It has scored several political victories with the liberation of a number of African countires. Nonetheless, the struggle continues. Unfortunately, the history of the last two decades has taught us that independence is not always enough and that more often than not several hard won victories are usurped and easily taken back by the enemies of the continent. A proof of this is the existence of hotbeds here and there in Africa.

Such is the case of Chad, a country whose dramatic situation is known to each and everyone in Africa and which the People's Republic of the Congo feels with great sorrow in view of the numerous ties existing between the two countries.

The People's Republic of the Congo is pleased with this spirit of African solidarity demonstrated to Chad so as to help it come out of the crisis.

The dedication of the Government of the People's Republic of the Congo to the cause of Africa is well known. The People's Republic of the Congo remains faithful to the OAU Charter and has never ceased doing everything possible to consolidate the African Unity and strengthen the Pan-African

Organization. This is why it accepted the mission entrusted to it by the Organization of African Unity to form together with Benin and Guinea the Inter-African Peace-Keeping Force. By sending its troops to serve on the said Force to Chad from January to March 1930 at its own expense, the Government of the People's Republic of the Congo knew that it was fulfilling its duty towards Africa, towards the OAU and towards the brotherly people of Chad, thus honouring its obligations.

It is now up to the Organization to face up to its responsibilities by complying with Resolution CM/679(XXXIV) by which it pledged to shoulder the financial burden of the operation of the Inter-African Peace-Keeping Force.

The draft resolution that the People's Republic of the Congo is proposing aims at nothing more than resolving a financial matter. The Council is expected to show a little more understanding.

Mr. President and dear brother,

I thank you for your letter of 5th July, 1983 on the important matter of contributions to the OAU regular budget.

Your Excellency, it is my pleasure to report to you that Kenya's contribution for the year 1982/83 is fully paid. The arrears of US\$124,899.62 referred to in your letter was paid in full to the Inter-African Bureau for Animal Resources (IBAR) in Nairobi on 9th August, 1983.

We have recently been notified by the OAU Secretariat that Kenya's assessment for the year 1983/84 is US\$760,346.20 of this amount US\$490,776.57 was paid to the IBAR office on 9th August, 1983. Out of the balance of US\$269,569.93, a deduction of US\$44,878.93 has been made being the cost of printing the medals for the OAU Peace-Keeping Force in Chad. This amount, as you may recall, was paid by my government on behalf of the OAU. Arrangements are underway to pay the balance of US\$224,690.70 in the near future.
