#### Vision

The Department of Health, Humanitarian Affairs and Social Development (HHS) contributes to the fulfilment of the Aspirations of Agenda 2063, particularly the one that envisions an Africa with a strong cultural identity, a common heritage, and shared ethics and values. My ambition, if I am elected Commissioner, is to make this Department an effective instrument for promoting inclusive and harmonious social development, an essential condition for the Africa we want.

#### **B. Strategic Approach**

Policies rooted in social values will be necessary to realise the Aspirations of the African Agenda and the UN Sustainable Development Goals. My action will be focused on 6 main priorities:

#### Promote Employment, Decent Work and Regular Migration

The political upheavals of the past decade have shown that the stability of the Continent is also dependent on the employability of African youths. I will endeavour to promote decent work and employment through the implementation of the Ouagadougou +10 Declaration and Plan of Action on Employment, Poverty Eradication and Inclusive Development; the Ten-Year Plan of Action 2020-2030 on the Eradication of Child Labour and the Social Protection Plan for the Informal Sector.

Social development policies must take into account the specific rights of people living with disabilities, the elderly and children. Sustained attention will be given to the implementation of related instruments.

Poor governance, socio-political conflicts and natural disasters are factors that aggravate poverty, social discrimination, unemployment and irregular migration.

If elected, the implementation of the revised Migration Policy Framework for Africa (2018-2030) and its Plan of Action, the Joint AU/ILO/IOM/ECA Programme on Labour Migration, Prevention of Trafficking in Persons and Smuggling of Migrants will be a priority.

To this end, the three Migration Centres will be used, in cooperation with State and non-State actors and partners to address the root causes of the migration phenomenon.

The implementation of the Protocol on Free Movement of persons and the issuance of the African Passport will be essential.

I will ensure better protection of the Diaspora investments and facilitation of the remittances and transfer of knowledge in order to better contribute to the fulfilment of the aspirations of Agenda 2063.

## Strengthen the Fight against Drug Trafficking and illicit use of narcotic drugs and Crime prevention

The scourge of drugs transcends the regions of Africa, which has become a transit and consumption space. There is an urgent need to implement the Plan of Action on Drug Control and Crime Prevention (2019-2023) to tackle their trafficking and illicit use.

## 3. Promotion and Protection of African Cultural Industry and Heritage

African arts, culture and heritage contribute to African development and renaissance. I will continue to implement the Roadmap for the 2021 theme on "Arts, Culture and Heritage: Levers for Building the Africa We Want".

The growth of the African cultural economy requires :

- The promotion of cultural initiatives and industries;

- The fight against the illicit trafficking of cultural goods;

- The repatriation of African works of art;

- The promotion of cultural diversity and the development enhancement of tangible and intangible cultural heritage;

- Building the institutional capacities of the cultural sector.

#### Promote the development of sports

Sport has a qualitative impact on health, well-being and development. It is a vector for social cohesion and for bringing people together.

My action will aim at the implementation of the Policy Architecture and Framework for the sustainable development of sport, with particular focus on sport for people living with a disability and the campaign against discrimination and stigmatization in sport

## Establish more efficient Health Systems

Africa is the region most affected by HIV/AIDS, malaria, tuberculosis, infectious and chronic diseases and other pandemics. Some of these, such as obesity and heart disease, have become common. They have a negative impact on development, social cohesion, political stability, life expectancy and human dignity. They entail heavy burdens for the Continent.

To this end, the Union has adopted several Strategies to improve the health of African populations. I will work to:

- Encourage universal access to quality basic social services;

- Implement the African Strategies for nutrition, the fight against the Coronavirus, the reduction of maternal mortality and the Saleema initiative to eradicate FGM;

- Pursue the Zero Malaria Campaign, the common position on tuberculosis and HIV/AIDS;

- Coordinate the Continental response to public health threats and promote a Health Early Warning System;

- Operationalise the African Medicines Agency, encourage the development of a local Pharmaceutical Industry and the implementation of National Medicines Manufacturing Plans;

- Encourage investment by Member States in health care.

## Situation of Refugees, Internally Displaced Persons, Returnees and eradicate Statelessness

The scale of forced displacement on the African Continent remains at unprecedented levels due to multiple factors including weak development and deficit of governance, human rights violations, poverty, inequality, unemployment, violent conflicts, environmental degradation and climate change-related disasters.

Finding durable solutions to address the root causes of forced displacement will include:

- Operationalising the African Humanitarian Agency;

- The eradication of statelessness;

- The positioning of humanitarian issues at the centre of the concerns of the States;

- The search for funding for an adequate response to humanitarian situations;

- Humanitarian Early Warning and preventive diplomacy;

- Ratification and domestication of relevant legal instruments to strengthen protection and assistance to displaced persons.

I became conversant with multilateral diplomacy at an early age, an asset that has been enhanced over time. My professional experiences in positions of responsibility in the international and Burkinabe administration equip me with the appropriate skills to contribute to the fulfilment of the Aspirations of Agenda 2063.

These high positions have enabled me to acquire skills in management, supervision, planning, human and financial resources management, values that are essential to the proper execution of the tasks of Commissioner.

As Minister and Ambassador, I had the experience of chairing meetings and cooperating with different national and international actors. This experience has facilitated my work as Commissioner. My training in the assessment of sensitive political situations and postconflict challenges is an asset in preventing humanitarian and health crises.

The deliberations of the Specialized Technical Committee on Migration, Refugees and the meetings of Africa CDC, in cooperation with the Department of Social Affairs, has been an opportunity to increase my knowledge on migration, diseases and epidemic response.

Within the framework of the implementation of the AU Strategy for response to the Coronavirus pandemic, the Department made available to Member States guidelines on response measures to build resilience to the impact of the Coronavirus on elections, the humanitarian situation, justice and human rights, constitutionalism and the rule of law.

As Permanent Representative to the African Union, I promoted the project that led to the Decision Assembly/AU/Dec.480 (XXI) on "Supporting Film Production to Enhance its Contribution to Africa's Development". This capital of experience will enable me to easily implement the programmes of the HHS Department and contribute to the realisation of the Africa we want.

The promotion and protection of women's rights has always been a priority during my career. In June 2020, I piloted the "Women in Governance and Political Participation" project. A Plan of Action was adopted after a broad international consultation. This flagship project will contribute to the emancipation of women and improve the participation of women and girls in political governance in Africa as well as their enhanced integration in the socio-economic life.

At the national level, in cooperation with the Minister of Foreign Affairs, I contributed to the implementation of the foreign policy of Burkina Faso.

Similarly, the chairmanship of the Joint Cooperation Commissions strengthened relations between Burkina and its neighbors and friendly countries.

The activities of the National Commission for Regional Integration, which was under my responsibility, enhanced the integration process as well as the harmonious life between Burkinabè and Africans living in Burkina Faso.

Burkina Faso won the First prize for the implementation of the ECOWAS Protocol on the Free Movement of Persons, Goods and the Right of Establishment when I was in charge of Regional Integration. I set up a National Committee on this Protocol. This experience will help me in the implementation of the AU Protocol on the Free Movement of Persons and legal instruments on migration, labour and employment issues.

Faced with the illicit traffic and local consumption of drugs, the Government of Burkina Faso established a National Committee on the Fight against Drugs. As a member of this Committee, I was able to learn about the problem of drugs, their cultivation, manufacture, legal and illegal trade, the repression of illicit trafficking in narcotics and psychotropic substances, medical and social problems and drug addiction. I contributed to the organisation and implementation of the policy defined by the Burkinabe Government in this field. On these issues, I particularly ensured the internalisation of international Treaties to which Burkina Faso is a party.

As Ambassador, Permanent Representative to the AU, I actively participated in the preparation of the 2004 Ouagadougou Summit and the Ouagadougou + 10 Summit which led to the Declarations "on Employment, poverty eradication and inclusive development in Africa."

In 2012, I negotiated and co-signed, on behalf of the Government of Burkina Faso, an "AU Special Prize on Peace and Security" for the Pan African Film and Television Festival of Ouagadougou (FESPACO). This award aims to recognise, reward and honour the best African film productions that promote the culture of peace and non-violence on the Continent.

I was bestowed the honour of "Commander of National Order" in January 2020 and "Officer of National Order" of Burkina Faso in 2008.
