**DECISION ON THE HARMONIZATION OF THE REMUNERATION  
POLICY OF THE COMMISSION  
DOC. EX.CL/329 (XI)**

**The Executive Council:**

1. **TAKES NOTE** of the study on the Harmonization of the Remuneration Policy of the Commission;
2. **APPROVES and AUTHORIZES** the Commission to charge to arrears of contributions the financial implications of the proposed adjustments to the salary scale amounting to US\$1,892,592.00;
3. **REQUESTS** the Commission to undertake a complementary study on the proposal of the consultants to set the salary scale at 75% of that of the United Nations and, identify the problems and challenges that the Commission might face by adopting such alignment;
4. **AUTHORIZES** the Commission to extend the study on salaries to other organizations, including those outside the African continent and to provide up-dated data to the Member States;
5. **REQUESTS** the Commission to introduce, as soon as possible, a new Performance Appraisal System and link pay to performance;
6. **FURTHER REQUESTS** the Commission to complete the study on the harmonization of the remuneration policy by the end of 2008 and to resubmit the other recommendations contained in the report for further consideration by the PRC. The entire process should interface in the above recommendations with the outcome of the institutional audit, if need be.

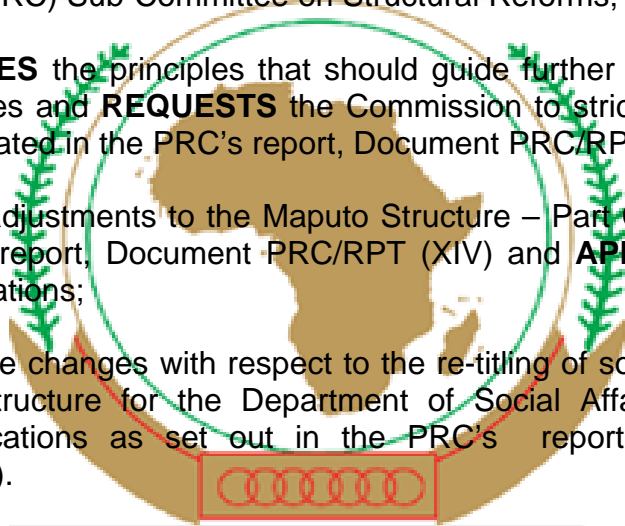
**The Executive Council:**

2. **RECOGNIZES** the urgent need to improve the conditions of service of staff of the Commission and **REITERATES** its earlier decision to achieve this goal;
3. **DECIDES** to defer the consideration of the report on the review of the Social Security System in order to enable the Member States to undertake further consultations on the matter in view of its technical nature and its complexity;
4. **REQUESTS** the Chairperson of the Commission to submit to the Permanent Representatives' Committee (PRC) concrete recommendations on the structure, mandate and financial implications of the proposed Fund;
5. **FURTHER REQUESTS** the PRC to re-examine the report and to submit recommendations thereon to the next Ordinary Session of Council scheduled for January 2008.

**DECISION ON THE ADJUSTMENTS TO THE MAPUTO STRUCTURE**  
**PART C – VOLUME II – DOC. EX.CL/331(XI)**

**The Executive Council:**

1. **TAKES NOTE** of the report of the Permanent Representatives' Committee's (PRC) Sub-Committee on Structural Reforms;
2. **ACKNOWLEDGES** the principles that should guide further adjustments to the Structures and **REQUESTS** the Commission to strictly abide by them as elaborated in the PRC's report, Document PRC/RPT (XIV);
3. **ADOPTS** the adjustments to the Maputo Structure – Part C as set out in the PRC's report, Document PRC/RPT (XIV) and **APPROVES** its financial implications;
4. **APPROVES** the changes with respect to the re-titling of some posts in the Maputo Structure for the Department of Social Affairs, without financial implications as set out in the PRC's report, Document PRC/RPT (XIV).

**The Executive Council:**

1. **TAKES NOTE** of the report on the Structure of the African Court on Human and People's Rights (AfCHPR);
2. **ACKNOWLEDGES** the principles that should guide further adjustments to the structure and **REQUESTS** the Court to strictly abide by them as elaborated in the Permanent Representatives' Committee (PRC) 's report, Document PRC/RPT(XIV);
3. **AUTHORIZES** the AfCHPR to put in place the following Structure:
  - i. Office of the President
  - ii. Office of the Registrar
  - The Registrar
  - Legal Matters
  - Linguistic Matters
  - Information, Communication and Technology
  - Protocol Services
  - Library and Documentation- Archives, Indexing and Distribution
  - Finance and Accounting
  - Human Resource Management
  - Typing and Reproduction
  - General Assistance
4. **APPROVES** a staff complement of forty six (46) as per the PRC's report Document PRC/RPT (XIV) and Council's decision EX.CL/331(XI). This staff complement does not include the eleven (11) Judges who are Elected Officials;
5. **REQUESTS** the AfCHPR, in collaboration with the Commission to start immediately the recruitment exercise, taking into consideration the AU recruitment criteria including quota, gender, regional representation and gradually fill the approved positions on the basis of clear programming;
6. **APPROVES** the Conditions of Service for Members of the AfCHPR as well as Staff of the Registry as per the PRC's report, Document PRC/RPT (XIV) as read together with the African Union legal instruments pertaining to statutory benefits granted to AU Staff on the regular establishment.



**DECISION ON THE REPORT ON THE STATUS OF THE OAU/AU TREATIES**  
**DOC. EX.CL/339(XI)**

**The Executive Council:**

1. **TAKES NOTE** of the Report on the Status of the OAU/AU Treaties;
2. **COMMENDS** the Chairperson of the Commission for the initiative and efforts aimed at encouraging Member States to become State Parties to the OAU/AU Treaties;
3. **APPEALS** to Member States to prioritize and accelerate the signing and ratification/accession to OAU/AU treaties; **REQUESTS** the Commission with the assistance of Member States, to harmonise the texts in the different official languages;
4. **REQUESTS** Member States to submit to the Commission their ratification/accession procedures to treaties to enable the Commission finalize implementation of the previous decision of the Executive Council on harmonization of ratification procedures within Member States;
5. **ALSO REQUESTS** the Commission to expedite the implementation of the previous decisions of Council, particularly on the review of OAU/AU Treaties including outdated treaties, especially those that date back as far as the 1960s which have not entered into force;
6. **FURTHER REQUESTS** the Commission to expedite resolving the inconsistency in various linguistic texts and to appoint an Arabic speaking legal expert to assist in this regard.

**DECISION ON THE SITUATION OF REFUGEES, RETURNEES  
AND DISPLACED PERSONS IN AFRICA – DOC. EX.CL/340 (XI)**

**The Executive Council:**

1. **TAKES NOTE** of the Report on the Situation of Refugees, Returnees and Internally Displaced Persons in Africa;
2. **EXPRESSES GRAVE CONCERN** over the persistent nature of forced population displacements on the Continent, and its negative impact on the lives of the persons affected; and **REAFFIRMS** the need for Member States to address the root causes as a durable solution to forced displacements;
3. **CALLS ON** the International community to increase its assistance to victims of forced displacements, in both host and home countries, particularly within the context of post-conflict reconstruction with a view to ensuring their long-term interaction;
4. **REQUESTS** the Commission to continue efforts to reactivate the coordination committee on Assistance and Protection to Refugees, Returnees and Internally Displaced Persons, to finalize the terms of reference for its working group; to submit same for validation to the office of the Legal Counsel and for approval at the next Session of Council;
5. **WELCOMES** the preparatory initiatives taken by the Task Force for the Special Summit of Heads of State and Government on forced displacements in Africa, scheduled to take place in 2008 and **CALLS UPON** the Task Force to continue the preparation for the successful outcome of the Special Summit;
6. **TAKES NOTE** of the concept paper on the African Union's policy on access to post-primary education for victims of forced displacements and **REQUESTS** the Commission to submit same for consideration by the Conference of Ministers of Education, scheduled in September 2007 in South Africa, prior to adoption by the Executive Council.

**DECISION ON THE IMPLEMENTATION OF THE AGENDA OF THE  
AFRICAN UNION ON FREE MOVEMENT IN AFRICA - DOC.EX.CL/341(XI)**

**The Executive Council:**

1. **TAKES NOTE** of the Report on the Implementation of the Agenda of the African Union on Free Movement in Africa;
2. **ALSO TAKES NOTE** of the symbolic launching of the African Union Diplomatic and Service Passports, as part of the implementation of Decision EX.CL/Dec.337 (X) adopted by the Executive Council in January 2007;
3. **UNDERScores** the need to de-link the issue of the African Union Diplomatic Passport from that of free movement in Africa;
4. **CALLS ON** the Commission to continue consultations with Member States on the African Union Diplomatic Passport;
5. **DECIDES** to convene a Forum bringing together African officials at national, regional and continental levels, and the PRC, with a view to holding such consultations and making recommendations on issues of common interest that would facilitate free movement in Africa.

**DECISION ON AFRICA-EUROPEAN UNION DIALOGUE - DOC. EX.CL/342 (XI)**

**The Executive Council:**

1. **TAKES NOTE** of the Report on Africa-European Union (EU) Dialogue;
2. **WELCOMES** the consultations undertaken with various stakeholders leading to the finalization of the outline for the Joint Africa-EU Strategy;
3. **ADOPTS** the Outline for the Joint Africa-EU Strategy as a basis for the elaboration of a fully-fledged Joint Strategy and Action Plan to be adopted at the December, 2007 Lisbon Africa-Europe Summit;
4. **URGES** the Africa-EU Ministerial Troika and the Experts to expedite the elaboration of the Joint Strategy and Action Plan as part of Lisbon Summit documentation;
5. **WELCOMES** progress made in preparations for the Africa-EU Summit to be held in Portugal, in December 2007, and **NOTES** that all African countries and the African Union (AU) Organs would be invited without conditions;
6. **URGES** all African Countries and the AU Organs to fully participate in the Summit;
7. **ENDORSES** the convening of a joint ministerial meeting to prepare adequately for the Lisbon Summit and **WELCOMES** in this regard the offer by the Arab Republic of Egypt to host the meeting in November 2007;
8. **REQUESTS** the Chairperson of the Commission to ensure that the Agenda of the Summit takes into account Africa's development needs including agriculture and food security;
9. **SUPPORTS** the forthcoming launching of the Africa-EU Partnership on Infrastructure and **REQUESTS** the Commission to take all necessary measures to ensure participation of African stakeholders at this important event.

**DECISION ON ASSESSING AFRICA'S PROGRESS TOWARDS THE  
MILLENNIUM DEVELOPMENT GOALS (MDGs) – DOC. EX.CL/332 (XI)**

**The Executive Council:**

1. **TAKES NOTE** of the report on Assessing Africa's Progress Towards the Millennium Development Goals (MDGs);
2. **CALLS UPON** the Commission, in collaboration with the Regional Economic Communities (RECs), the United Nations Economic Commission for Africa (ECA) and the African Development Bank (AfDB) to continue monitoring the implementation of the MDGs;
3. **FURTHER CALLS UPON** all Member States to continue their efforts towards the attainment of the MDGs by 2015;
4. **MANDATES** the Commission, the RECs, ECA and AfDB to strengthen the capacity of national statistical institutions, as well as other African statistics organizations in the development of statistics in Africa;
5. **REQUESTS** the Commission to report on the progress made on the assessment of the MDGs to the Assembly at least once a year, in collaboration with the RECs, ECA and AfDB.

**DECISION ON THE PROTOCOL ON RELATIONS BETWEEN THE AFRICAN UNION AND THE REGIONAL ECONOMIC COMMUNITIES (RECS)**  
**DOC. EX.CL/348 (XI)**

The Executive Council:

1. **TAKES NOTE** of the Report on the Protocol on Relations between the African Union and the Regional Economic Communities (RECs);
2. **ADOPTS** the Protocol and recommends its endorsement by the Assembly;
3. **RECOMMENDS** that the Assembly authorizes the Chairperson of the Commission to sign the Protocol on behalf of the Commission of the African Union.



**DECISION ON THE FIRST AFRICAN UNION CONFERENCE OF MINISTERS  
RESPONSIBLE FOR MARITIME TRANSPORT - DOC. EX.CL/349 (XI)**

1. **TAKES NOTE** of the report on the First African Union Conference of Ministers Responsible for Maritime Transport;
2. **ENDORSES** the Abuja Declaration and Plan of Action on Maritime Transport in Africa;
3. **REQUESTS** the Commission, in collaboration with the RECs, specialised institutions, Member States and other stakeholders to take all the necessary measures to ensure the implementation of the Action Plan for the development of the maritime transport sub-sector in the continent;
4. **URGES** the Commission to particularly expedite the development of a continental policy, and a legal and institutional framework for coordinating the development of the maritime transport industry;
5. **APPEALS** to the International Maritime Organisation (IMO), the United Nations Economic Commission for Africa (UNECA); the African Development Bank (AfDB), the European Union and other development partners to support the implementation of the Plan of Action of the African Union on maritime transport;
6. **REQUESTS** the Commission to submit periodic reports on the implementation of this Decision to the Executive Council.

**DECISION ON THE THIRD AFRICAN UNION CONFERENCE OF MINISTERS  
RESPONSIBLE FOR AIR TRANSPORT - DOC. EX.CL/350 (XI)**

**The Executive Council:**

1. **TAKES NOTE** of the report on the Third African Union Conference of Ministers Responsible for Air Transport;
2. **ENDORSES** the Resolution on entrusting the functions of the Executing Agency of the 1999 Yamoussoukro Decision to the African Civil Aviation Commission (AFCAC);
3. **ALSO ENDORSES** the Addis Ababa Declaration on Civil Aviation Security;
4. **FURTHER ENDORSES** the 2007 – 2010 Air Transport Plan of Action and **URGES** Member States to provide the necessary support to AFCAC including fulfilling all their financial obligations in order to enable it to accomplish its objectives;
5. **REQUESTS** the Commission to oversee the implementation of the Resolution on entrusting the functions of the Executing Agency to AFCAC as soon as possible as well as ensure harmonious implementation of the Libreville (2006) and Addis Ababa (2007) Plans of Action for the air transport sub-sector in Africa;
6. **ALSO REQUESTS** the Commission to complete, as a matter of urgency, the harmonisation of air transport competition rules, elaboration of a continental dispute settlement mechanism and conduct an evaluation of the implementation of the 1999 Yamoussoukro Decision;
7. **FURTHER REQUESTS** the Commission, in collaboration with the Regional Economic Communities (RECs), Member States and other stakeholders to finalise the preparation of a Common African Position on Negotiation of Air Service Agreements with the European Union countries and other Third Countries;
8. **APPEALS** to the International Civil Aviation Organisation (ICAO), the United Nations Economic Commission for Africa (UNECA), the African Development Bank (AfDB), the European Union and other development partners to support the implementation of the 2007 – 2010 Air Transport Plan of Action of the African Union;
9. **REQUESTS** the Commission to submit periodic reports on the implementation of this Decision to the Executive Council.



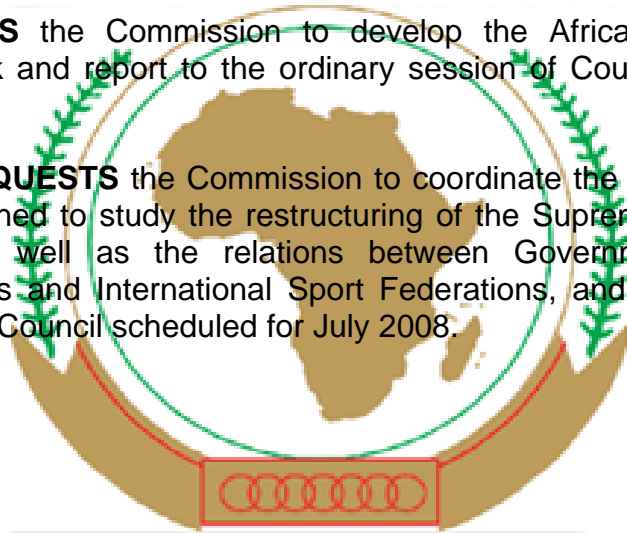
**DECISION ON THE FIRST SESSION OF THE AFRICAN UNION CONFERENCE  
OF MINISTERS OF SPORTS - DOC. EX.CL/353 (XI)**

**The Executive Council:**

1. **TAKES NOTE** of the Report on the First Session of the African Union Conference of Ministers of Sports;
2. **COMMENDS** the Ministers for providing leadership to development of sport as contained in the Strategic Plan of the Commission; in recognition of the role of sport as a vehicle for achieving the Millennium Development Goals; and in implementing the Declaration of the 8<sup>th</sup> Assembly of the Union on the International Year of African Football (IYoAF), 50<sup>th</sup> Anniversary of the Confederation of African Football and ushering in the 2010 World Cup as an African event;
3. **WELCOMES** the hosting by Algeria of the 9<sup>th</sup> All Africa Games to be followed by the Africa-Asia Games in Algiers, Algeria, in July 2008;
4. **RECOGNISES** the role that sport plays in the socio-economic development, and as a vehicle for peace building and regional integration;
5. **EXPRESSES** concern about the limited provisions for the inclusion of sport and physical education in educational curricula at all levels in educational institutions, including those for women and girls, persons with disabilities and for youths in conflict and post conflict situations, and refugees and displaced persons;
6. **URGES** Member States, the African Sport Federations and International Sport Federations to keep the development of sport on the Continent high on the agenda of their national development plans, in conformity with previous commitments at all levels; and **ALSO URGES** Member States to continue cooperating with the Commission in strategizing for the popularization of all sport in Africa;
7. **CALLS** for the institutionalization of the Conference of Ministers of Sport in line with the decision on the Specialized Technical Committees;
8. **MANDATES** the Bureau of the Conference of Ministers of Sport to oversee the implementation of the activities called for in the Addis Ababa Declaration of 8 June 2007;
9. **CALLS UPON** Member States to implement activities programmed to roll over to 2010, to popularize the International Year of African Football and the 2010 FIFA World Cup African Legacy Programme;

**10. REQUESTS** the Commission to develop the African Union Sport Policy Framework and report to the ordinary session of Council scheduled for July 2008;

**11. ALSO REQUESTS** the Commission to coordinate the work of the Committee commissioned to study the restructuring of the Supreme Council for Sport in Africa, as well as the relations between Governments, National Sport Federations and International Sport Federations, and report to the ordinary session of Council scheduled for July 2008.

2. **REAFFIRMS** the importance of health in the promotion of socio-economic development in Africa;
3. **ENDORSES** the Johannesburg Declaration of the Third Session of the AU Conference of Ministers of Health<sup>1</sup>;
4. **ALSO ENDORSES** the Africa Health Strategy as a framework within which Member States should address the health challenges facing the continent;
5. **FURTHER ENDORSES**
  - a) The Pharmaceutical Manufacturing Plan for Africa;
  - b) The Plan of Action on Violence Prevention in Africa;
  - c) The Monitoring and Reporting Mechanism for the Outcomes of the May 2006 Abuja Special Summit on HIV/AIDS, TB and Malaria.
6. **URGES** Member States, in collaboration with relevant stakeholders, to implement these commitments and report to the Commission;
7. **REQUESTS** the Commission in collaboration with Regional Economic Communities and other partners, to follow-up and coordinate the implementation of the recommendations contained in the report as well as all the documents adopted at the Conference;
8. **FURTHER REQUESTS** the Commission to submit a status report regularly on the implementation of the outcomes and recommendations of the Conference to Council.

**The Executive Council:**

1. **TAKES NOTE** of the Report of the 40<sup>th</sup> Session UN-ECA Conference of African Ministers of Finance, Planning and Economic Development;
2. **RECALLS** Decision Assembly/AU/Dec.73 (V) adopted by the Fifth Ordinary Session of the Assembly in Sirte, Libya in July 2005 to institutionalize the organization, on annual basis, of the Conference of African Ministers of Finance, Planning and Economic Development;
3. **FURTHER RECALLS** Decision Assembly /AU/DEC.140 (VII) adopted by the Assembly in Banjul, The Gambia, in July 2006 on the strengthening the Commission, Economic Commission for Africa (ECA) and the African Development Bank (AfDB) partnership;
4. **REITERATES** its support to the proposal by the AU Conference of African Ministers of Economy and Finance (CAMEF II) in Yaounde, Cameroon, in November 2006 (AU/CAMEF/Rpt (II) to organize a joint meeting of AU-ECA Annual Conference;
5. **SUPPORTS** the Ministerial Statement and the resolutions of the Conference of African Ministers of Finance, Planning, and Economic Development held in Addis Ababa, Ethiopia, on 3<sup>rd</sup> April 2007, in particular Resolution 853 (XL) to organize a Joint Annual AU/ECA Conference of African Ministers of Finance, Planning and Economic Development;
6. **MANDATES** the Commission and ECA to organize jointly, beginning in 2008, the Conference of the African Ministers of Finance, Planning and Economic Development and submit its report to the Council.

1. **TAKES NOTE** of the Report of the Chairperson of the Commission on Afro-Arab Cooperation;
2. **COMMENDS** the Commission and the General Secretariat of the League of Arab States for their timely initiative to transform the Afro-Arab Cultural Institute in Bamako, Mali, to an Afro-Arab Institute for Culture and Strategic Studies (AAICSS);
3. **WELCOMES** the role to be played by the AAICSS in addressing strategic issues and shaping the future direction of Afro-Arab Cooperation on the basis of research;
4. **URGES** the parties to expedite the transformation process of the Afro-Arab Cultural Institute to the AAICSS;
5. **CONGRATULATES** the Chairperson of the Commission and the Secretary General the League of Arab States for concluding the General Agreement on Cooperation between the African Union and the League of Arab States signed in 2007;
6. **ENDORSES** the Agreement, and **CALLS UPON** the Chairperson of the Commission and the Secretary General of the League of Arab States to take all necessary measures to ensure successful implementation of the provisions of the Agreement.

1. **TAKES NOTE** of the Report on World Trade Organization (WTO) negotiations;
2. **WELCOMES** the resumption of the negotiations and **CALLS** on the WTO members to display the political will and the flexibility in negotiating positions that are necessary to bring the negotiations to a successful conclusion with the development dimensions at the core as agreed in Doha;
3. **COMMENDS** the AU Ministers of Trade and the African Group in Geneva for their continued efforts in articulating the concerns and interests of Africa in the WTO negotiations;
4. **RECOGNISES** the relevance of the Hong Kong WTO decision on providing aid for trade to developing countries in order to enable them to benefit meaningfully from the trade liberalization agenda of the WTO;
5. **CALLS ON** AU Member States to adopt appropriate measures to take full advantage of the flexibilities and amendments in the Trade-Related Aspects of Intellectual Property Rights (TRIPS) Agreement, including the signing of the Protocol that will make these amendments effective in accordance with the WTO Agreement;
6. **URGES** AU Member States and the Regional Economic Communities (RECs) to establish appropriate mechanisms and structures for operationalizing and deriving maximum benefits from the Aid for Trade Initiative;
7. **FURTHER URGES** the EU and other development partners to take concrete steps for the early operationalisation of the Aid for Trade initiative;
8. **REQUESTS** United Nations Development Programme, the United Nations Conference on Trade and Development (UNCTAD), the United Nations Economic Commission for Africa (ECA) and the African Development Bank (AfDB), to provide adequate support to AU Member States and RECs for the effective design of their Aid for Trade programmes.

**DECISION ON THE SITUATION IN THE MIDDLE EAST AND PALESTINE**  
**DOC.EX.CL/360 (XI)**

**The Executive Council:**

1. **TAKES NOTE** of the Report on the Situation in the Middle East and Palestine;
2. **RECALLS** all relevant Resolutions and Decisions adopted by the OAU/AU on the situation in Palestine and the Middle East;
3. **REITERATES** its continued full support to and solidarity with the Palestinian people and the Authority of the Palestine Liberation Organization the sole representative in their just and legitimate struggle for the exercise of their inalienable national rights including their right to self-determination, return to their land, recovery of their properties and the establishment of an independent State on their national soil with Al-Quds as its capital in accordance with the principle of international law and all the UN resolutions and other pertinent resolutions of the OAU/AU;
4. **REAFFIRMS ITS SUPPORT** for the peaceful solution to the Israeli-Palestinian conflict in accordance with the principles of international law, all pertinent resolutions of the UN Security Council and General Assembly and the Arab Peace Initiative to end the Israeli occupation that began on 5 June 1967, with the achievement of the vision of two States, Israel and an independent, sovereign and territorially contiguous Palestine, living side by side, in peace and security;
5. **CALLS UPON** the United Nations to take concrete measures to protect the people of Palestine by providing international protection forces to the Occupied Palestinian Territories and to compel Israel to allow the UN fact-finding missions charged with investigating war crimes and atrocities perpetrated against Palestinian Peoples to discharge its duties within the Occupied Territories;
6. **EXPRESSES GRAVE CONCERN** over the deterioration of the economic, social and health conditions resulting from continued Israeli occupation, siege, restriction of movement of goods and persons;
7. **STRONGLY CONDEMNS** the Israeli repressive measures, aggressions and all acts perpetrated by Israel against harmless innocent people; the policies of assassinations; ongoing invasions in the cities; villages and Palestinian camps; as well as the heinous crimes and massacres, especially the latest atrocious assault committed by the Israeli forces on 17 May over different public institutions in the Gaza strip; and **URGES** the Israeli Government to put an end to all these indiscriminate measures and retaliatory actions that violate International Law and the Fourth Geneva Convention of 1949;



8. **STRONGLY CONDEMNNS** the continued Israeli policy of arresting and detaining the Palestinians, especially the kidnapping and detention without trial of Ministers, Members of the Legislative Council and the Municipal Council, which constitute a grave violation of International Humanitarian Law;
9. **STRONGLY CONDEMNNS** the construction by Israel of the Separation Wall and the expansion of the Colonial Settlements in the Occupied Palestinian Territories, around Al-Quds town, especially the recent Israeli decision to build 20000 housing units which violate International Humanitarian Law, in particular the Fourth Geneva Convention of 1949, and **URGES** Israel to comply with the advisory opinion of the International Court of Justice and General Assembly Decision ES-10/15;
10. **CALLS UPON** the International Community and the Members of the Quartet Committee to spare no efforts to reinvigorate the negotiations and to salvage the peace process, and **EXPRESSES** the AU support for the organization of an International Peace Conference on the Middle East conflict;
11. **CONSIDERS** the establishment of the government of Palestinian National Unity as a symbol of the unity of the Palestinian people in face of Israeli occupation; and **EXPRESSES ITS GRAVE CONCERN** over the deteriorating situation between the two main components of the Government of National Unity, namely, Fatah and Hamas, resulting in the dissolution of the Government;
12. **AFFIRMS** that such a situation is detrimental to the cause of the Palestinian people, and **REMINDS** the Palestinian factions that their unity is the only guarantee to preserve their gains and move towards their national objectives;
13. **SUPPORTS** the decision related to the Arab Peace Initiative adopted in Beirut in 2002 and reaffirmed at the last Arab Summit in Riyadh and regard it as an important and appropriate framework to put an end to the conflict in the Middle East and as the way to a just, comprehensive and durable solution on all the fronts;
14. **URGES** the Government of Israel to accept the Arab Peace Initiative as an Arab effort towards putting an end to the conflict in the Middle East, and also providing a chance for mutual recognition between Israel and Arab countries;
15. **CALLS UPON** the International Community to lift the siege, boycott and blockade against the Government so as to ease the difficult living conditions of Palestinian People which stirs up tension and violence;
16. **EXPRESSES GRAVE CONCERN** regarding the tension and violence in Lebanon, and **CALLS UPON** all Lebanese parties to resolve their differences through negotiations;



**17. URGES** the Government of Israel to put an end to its occupation of the Syrian Golan Heights and all Arab Territories occupied during the June 1967 war in accordance with the relevant UN Security Council resolutions, including Resolutions No. 242 and 338.



**DECISION ON THE AFRICAN COMMITTEE OF EXPERTS  
ON THE RIGHTS AND WELFARE OF THE CHILD - DOC. EX.CL/338 (XI)**

**The Executive Council:**

1. **TAKES NOTE** of the Report of the 8<sup>th</sup> and 9<sup>th</sup> Sessions of the African Committee of Experts on the Rights and Welfare of the Child;
2. **COMMENDS** the Committee for its achievement in setting up a strong basis for its effective operation by adopting the required procedural and framework documents and **REQUESTS** that the Committee start considering the reports already received from State Parties;
3. **EXPRESSES** concern on the deteriorating situation of children on the continent and **REITERATES** the need to make Africa a place fit for children to develop and prosper;

4. **ALSO DECIDES** to rely on the outcomes of the consultations at the level of the African Civil Aviation Council (AFCAC) regarding the candidatures of the Republic of Senegal and the Republic of Ghana (West Africa) for Group III at the Executive Board of the International Civil Aviation Organization for elections due to take place in Montreal, Canada, in September 2007;
5. **CALLS FOR** strict compliance with the relevant provisions of:
- i) Rule 14(3) which stipulates that “Decisions of the Executive Council, approved by the Assembly of Heads of State and Government of the Union, on the recommendations of the Committee on a particular candidature shall be binding on all Member States”;
  - ii) Rule 14(4) which also provides that “Member States that fail to comply with the Decisions of the Executive Council on candidatures, may be subjected to sanctions in accordance with Article 23 of the Constitutive Act of the African Union”;
6. **ALSO CALLS FOR** compliance with the relevant provisions of the Rules of Procedure of the Committee and with previous Decisions regarding the deadline for submission of candidatures for consideration by the Committee.

**DECISION ON CONTRIBUTIONS**  
**DOC.EX.CL/337 (XI)**

**The Executive Council:**

1. **TAKES NOTE** of the report of the Permanent Representatives' Committee's (PRC) Sub-Committee on Contributions by Member States;
2. **AUTHORIZES** that the sanctions imposed on Burundi and Sierra Leone remain temporarily lifted since they have respected their payment schedules;
3. **TAKES NOTE** of the fact that Guinea, Guinea Bissau and Central Africa Republic have cleared their arrears up to the year 2004 and have partially paid for the year 2005, thus taking them out of sanctions;
4. **DECIDES** that the following Member States shall remain under sanction since they are in arrears of contributions for more than two (2) years:
  - i) Cape Verde
  - ii) Democratic Republic of Congo
  - iii) Eritrea
  - iv) Sao Tome and Principe
  - v) Seychelles
5. **URGES** Cape Verde to present its repayment schedule to the Sub-Committee on Contributions for consideration and **REQUESTS** the PRC to make appropriate recommendations to the next ordinary session of Council scheduled for January 2008;
6. **REQUESTS** the Commission to expedite the elaboration of proposals on the treatment of countries emerging from conflicts with regard to the payment of their arrears and assessed contributions.



**DECLARATION ON THE SITUATION IN CÔTE D'IVOIRE**

**The Executive Council,**

1. **STRONGLY CONDEMNS** the attempted assassination perpetrated at Bouake on 29 June 2007 against Mr. Guillaume Soro, the Prime Minister of Cote d'Ivoire, and which resulted in several casualties,
2. **ALSO STRONGLY CONDEMNS** any attempt aimed at jeopardizing the progress recorded in the peace process in Côte d'Ivoire;
3. **STRESSES** the need to identify the perpetrators of this criminal act as soon as possible and to bring them to justice;
4. **REITERATES** the full support of the African Union for the Ouagadougou Political Agreement signed on 4 March 2007 under the facilitation of President Blaise Compaore of Burkina Faso, Chairperson of the Economic Community of West African States (ECOWAS), and for the efforts being made by the Ivorian parties towards the implementation of the said Agreement;
5. **ENCOURAGES** the Ivorian parties to pursue and intensify their efforts within the context of the Ouagadougou Political Agreement and to continue lending the Facilitator the necessary support towards the successful conclusion of the peace and reconciliation process in Côte d'Ivoire.
