RECOMMENDATION FOR APPOINTMENT OF MEMBERS OF  
BOARD OF EXTERNAL AUDITORS BY NAME BASED ON  
EXPERIENCE AND ABILITY

The Board of External Auditors was established in accordance with the decision of the Assembly of Heads of State and Government at its 2nd Ordinary Session in Accra in 1965. At that time the Board comprised representatives from Ghana, Algeria, Cameroon, Ethiopia and Central African Republic. A representative of Libya was added in 1969.

The Secretariat believes that for the work of auditing to be efficiently done, the countries which supply auditors, should send the same representatives each year. The Secretariat has observed that, unfortunately, this is not the case. The Secretariat thinks that some countries, for no compelling reasons, change their representatives when they like.

The purpose of this recommendation is to get the authority of the Council that members of the Board of External Auditors be appointed by name for a fixed period, say, 5 years. They will be appointed in their capacities as technicians in addition to their being representatives of their respective countries. This will ensure that the same people do the auditing every year and if for any strong reason a member is unable to carry out his duties, his country can nominate another person to serve for the rest of the period of the mandate of his compatriot. The Secretariat suggests that the auditors who have come this year be so appointed. They are:
