#### Item 17: <u>Report of the Administrative Secretary-General on</u> OAU activities in the Economic, Social, Transport and Communications fields:-

Since the Specialized Commission could not meet as scheduled from 13 to 18 July 1970 for lack of quorum, the Secretariat will present to the Council of Ministers the overall activities of OAU in the economic, social, transport and communications fields, which have been treated in a general Report. In view of the fact, that the Specialized Commission has not met since 1965, the General Secretariat deemed it useful to devote the present report to the role that the Commission. and for that matter, OAU should play in the fields of economic, social, transport and communications development and co-operation in Africa. In defining this new role, the changes in the structure and working methods of the United Nations Economic Commission for Africa (ECA) will also be taken into consideration. In the light of the foregoing, the Council will be requested to recommend new directives in respect of the specific work of OAU in the economic, social, transport and communications fields. Nine special reports will enable the Council to consider each of the sub-items on the Agenda related to inter-African Co-operation in the economic, social, transport and communications fields.

#### Item 18: Report of the Administrative Secretary-General on OAU activities in the Educational, Scientific, Cultural, Health and related fields:

A general report will be presented on the OAU activities in the field of education, science, culture, health and related areas. Separate reports will be given concerning the programme on Centres of Excellence, regional food reserves, the Inter-African Cereals Crops Conference, and the meeting of the Scientific Council for Africa indicating the activities in each case.



EXPLANATORY NOTE TO ITEM 25 ON THE PROVISIONAL AGENDA OF THE FIFTEENTH ORDINARY SESSION OF THE COUNCIL OF MINISTERS

OAU contribution to the celebrations of the 25th Anniversary of the signing of the U.N. Charter and the 10th Anniversary of the voting of the Declaration on the Granting of Independence to peoples and countries under foreign domination.

The international community is preparing for the celebration of the UN 25th Anniversary and the 10th Anniversary of the Declaration on the Granting of Independence to colonial territories and peoples, in the course of the 25th Session of the General Assembly. The U.N. has realized the significant role played by the regional organizations in the international relations, for consolidating the principles of the U.N. Charter. The U.N., therefore, invited the participation of the regional organizations to these celebrations. The recommendations made by the preparatory Committee for the celebration of the 10th Anniversary of the Declaration of Decolonization included the invitation of the regional organizations particulary in the regions still suffering under the yoke of colonialism - to enhance their programmes of action aimed at liquidating imperialism and moreasing their co-operation with the UN for this purpose. The recommendations of the preparatory committee for the celebration of the UN 25th Anniversary considers these celebrations an apportunity for the strengthening and consolidation of the UN, for rendering it more effective and reasserting the belief of all Governments and peoples in the principles and the purposes of the UN Charter,

The faith of Africa in the UN as an instrument for safeguarding world peace and security and for the development of friendly relations, peaceful and active co-operation among the members of the international community as well as her faith in the principles of the UN Charter, are embodied in the preamble to the OAU Charter and the first provision thereof, The desire of Africa to see peace provail in her territorics, and the wish of African peoples to live in security and peace, bind us to the duty of strengthening and consolidating UN.

As the Declaration to be issued by UN on the occasion of the celebrations is due to include all what the UN has since its inception achieved in the various fields of activity, and will tackle the remaining international problems and the possibilities of solving them, it is the duty of OAU, wherein the African peoples have placed their confidence and hopes and which is entitled to speak in their name, to declare to the world - on the occasion of these celebrations - her position as regards the problems facing the African peoples, to inform the international community of the real motives which hinder the solutions of these problems, and the means for solving them.

The OAU must also call upon the international community represented by the UN to rise up to the level of the responsibilities laid on it, to consolidate peace and secure prosperity to mankind. The UAR therefore requests the inclusion of an item on the Agenda of the Council of Ministers on the participation of OAU in the celebration of the 25th Anniversary and 10th Anniversary of the Declaration on the granting of independence to the Colonial territories and peoples, so that the Council may consider the ways and means in which OAU can contribute to the various aspects of the said celebrations, and adopt the necessary recommendations to be submitted to the Assembly of Heads of State and Government during its Seventh Ordinary Session, so that the aims of the Organization of African Unity be fulfilled on the level of the United Nations.
