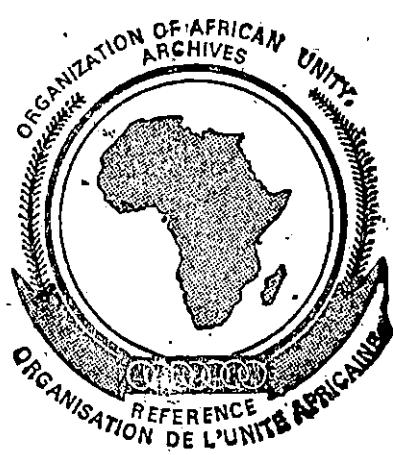

FINANCIAL REPORT COVERING THE PERIOD

1st JUNE 1970 TO 31st MAY 1971

The General Secretariat has pleasure in submitting to the members of the Board of External Auditors the Report covering its financial activities and those of the Regional and Sub-Regional Offices from 1st June, 1970 to 31st May, 1971.

2. As in the past, the entire staff who are involved in the financial administration of the Organization are readily available for any clarifications that the Board may require in the course of its auditing.

3. Throughout the financial year 1970/71, the Administration Department has been guided by a policy of maximum austerity and strict observance of Staff Rules and Regulations in handling O.A.U. funds; and the results have been good.

4. In compliance with section 4, sub-section 5, of Part IX of the Financial Rules and Regulations, all unforeseen expenditure was referred to the Resident Members of the Advisory Committee on Budgetary and Financial Matters for approval before incurring it. The General Secretariat is happy to report that it obtained approval for all its virements of funds and those of its Regional and Sub-Regional Offices. This approval was obtained at a meeting of the Resident Members of the Advisory Committee on Budgetary and Financial Matters held in Addis Ababa on 13th April, 1971 (Document FBM/SC/58(XV) refers).

5. The following sums totalling U.S. \$ 114,842.48 represent the unforeseen expenditure approved to be spent from the anticipated savings of the 1970/71 budget, but the total expenditure does not exceed the total approved budget for the financial year 1970/71:

6. Savings on the 1970/71 budget

The appropriations for the 1970/71 budget amounted to U.S. \$ 2,726,746.50, whilst the total expenditure and outstanding obligations including the unforeseen expenditure approved to be spent from the anticipated savings of the 1970/71 budget as of 31st May, 1971 amounted to U.S. \$ 2,628,420.35, thus leaving a theoretical saving of U.S. \$ 98,326.15. The actual contributions of Member States paid into the 1970/71 budget were U.S. \$ 1,410,024.09 as of 31st May, 1971. However, at the time of writing this report (October 1971), a further sum of U.S. \$ 666,621.81 had been paid into the 1970/71 budget between June and October 1971, thus leaving an outstanding contribution of U.S. \$ 650,100.60 representing 23.8 % of the total appropriations for the 1970/71 financial year. The Organization was able to meet its obligations during the financial year because of the previous year cash balances, payment received in respect of outstanding contributions and miscellaneous income.

7. Revenues

The total contributions received from Member States during the financial year 1970/71 amounted to U.S. \$ 2,080,970.44, made up as follows:
