**REPORT ON ELECTION AND APPOINTMENT OF SIX (6) MEMBERS  
OF THE AFRICAN COMMITTEE OF EXPERTS ON THE RIGHTS AND  
WELFARE OF THE CHILD**

## **REPORT ON ELECTION AND APPOINTMENT OF FOUR (6) MEMBERS OF THE AFRICAN COMMITTEE OF EXPERTS ON THE RIGHTS AND WELFARE OF THE CHILD**

1. The election of Members of the African Committee of Experts on the Rights and Welfare of the Child (ACERWC) is governed by the provisions of the African Charter on the Rights and Welfare of the Child (the Charter) and the Rules of Procedure of the Executive Council.

2. The ACERWC is established by Article 33 (1) of the Charter. Article 33 (1) of the Charter provides that the ACERWC shall consist of eleven (11) Members of high moral standing, integrity, impartiality and competence in matters of the rights and welfare of the child. Members of the ACERWC serve in their personal capacity.

3. Further, Article 33 (3) of the Charter provides that the ACERWC shall not include more than one (1) national from the same State.

4. The Members of the ACERWC serve for a term of five (5) years which may be renewed only once in accordance with Decision Assembly/AU/Dec. 548 (XXIV) adopted during the Twenty Fourth Ordinary Session of the Assembly, held in Addis Ababa, Ethiopia in January 2015.

5. The Commission has the honour to inform Member States that the terms of office of the following members of ACERWC who were elected in July 2015 for a term of five (5) years, pursuant to the provisions of Article 37 of the Charter, shall expire in July 2020:

1. Mrs. Dikere Marie-Christine Bocoum (Cote d'Ivoire);
2. Ms. Aver Gavar (Nigeria);
3. Ms. Maria Mapani-Kawimbe (Zambia);
4. Mr. Clement Machamba (Tanzania);
5. Mr. Benyam Dawit Mezimur (Ethiopia);
6. Ms. Goitseone Nanikie Nkwe (Botswana).

6. Outgoing members 1, 2, 3, and 6 are eligible for re-election

### **Modalities for Election**

7. The Commission would like to draw the attention of all Member States to Decision EX.CL/907 (XXVIII) on the Modalities on Implementation of Criteria for Equitable Geographical and Gender Representation in the African Union Organs, adopted by the Executive Council in January 2016. Paragraph 2 of the said Decision provides as follows:

- i) The regional representation, where applicable, shall be East (2), Central (2), North (2), South (2) and West (2), except in cases in which a region which has been duly informed has not presented candidates;

- ii) Where applicable, one (1) seat shall be a floating seat and will rotate among the five (5) regions;
- iii) At least one (1) member from each region should be a woman;
- iv) The modalities shall become effective immediately.

8. In light of the above, the Commission would like to inform Member States that the regional and gender representation at the ACERWC after the end of the terms of office the six (6) members, will be as follows:

9. In this regard, during these elections, in accordance with the Modalities on Implementation of Criteria for Equitable Geographical and Gender Representation in the African Union Organs, the Members shall be elected as follows:

- a) **Eastern Region:** two(2) candidates : one (1) female and one (1) male candidates,
- b) **Southern Region:** two (2) candidates : one (1) female and one (1) male candidates, and
- c) **Western Region:** two (2) candidates: one (1) female and one (1) male candidates.

10. It will be recalled that the Commission, through its Note Verbale referenced BC/OLC/24.9/4032.20 dated 02 April 2020, invited Member States, to submit candidates on or before the deadline of 30 April 2020. Further, the Commission, through Note Verbale reference number BC/OLC/24.9/4069.20 dated 06 May 2020, extended the deadline to 30 May 2020.

11. The Commission would like to inform the Executive Council that the candidatures received from the States Parties to the Charter are as follows:

**12.** It will be recalled that the Assembly vide decision Assembly/AU/Dec.760(XXXIII) adopted in February 2020 in Addis Ababa, Ethiopia delegated its authority of appointment of members of AU Organs and institutions, including the ACERWC, to the Executive Council.

**13.** In this regard the elected members shall automatically and simultaneously be appointed by the Council.
