**I. Introduction**

1. A delegation of the African Union Commission (AUC) composed of a senior technical expert from the Department of Trade and Industry and a representative of the Office of the Legal Counsel, embarked on a mission to re-evaluate AU Member States that had previously expressed interest in hosting the secretariat of the African Minerals Development Centre (AMDC), namely, Sudan, Zambia, Kenya and Guinea. The mission was undertaken to Khartoum, Sudan from 26 to 29 December 2017; Lusaka, Zambia from 3 to 5 January 2018; Nairobi, Kenya from 8 to 9 January 2018; and Conakry, Guinea from 11 to 12 January 2018.

2. In each of the above listed Member States, the Commission made a brief presentation on the AMDC, the reasons for conducting this second round of evaluation and the applicable criteria for hosting AU Organs and institutions. The Commission explained that the core aim of the re-evaluation missions was to ascertain the continued readiness of these Member States to host the AMDC given that a considerable amount of time has passed since the initial evaluation and to score their respective offers against the primary criteria set out in the 2005 *Criteria for Hosting AU Organs*, as well as the introduction of three (3) additional criteria that are peculiar to the AMDC as follows:

- a) **Ratification of the AMDC Statute** – at the time of reassessment, the status of the Statute of the AMDC stands at four (4) signatures and zero (0) ratifications. In promoting the instrument, the Commission considered that the country wanting to host the AMDC shall have ratified its Statute as a demonstration of commitment to the vision and objectives of the AMDC contained therein.

**Direct Financial and Additional Support to the AMDC** – The AMDC has been operating as a project for the past four years. Having been launched in Maputo, Mozambique in December 2013, the AMDC project was wholly funded by Development partners, specifically Canada who provided \$15 million and Australia that provided \$5 million and hosted by United Nations Economic Commission for Africa (UNECA). However, the AMDC as a project has come to an end with no funds left to allow the operations of the AMDC to continue under the UNECA. Subsequently, UNECA wrote to AUC on 20<sup>th</sup> December 2017 and proposed that AMDC should to move from UNECA to AU by 30<sup>th</sup> April 2018. On 20<sup>th</sup> December 2017, AUC/DTI and

UNECA met and agreed that the AMDC should move seamlessly to the host country in order not to lose the momentum given the importance and the success of the AMDC project. In this regard, an additional non-substantive but very important criteria was added to the list. A minimum budget of at most US\$2 million and at least US\$1.2million per year for an interim period of not more than two (2) years to support an interim staff and minimal operations should be provided by the host country.

- b) **Provision of a Residence for the Head of the Secretariat** – Similarly as explained above, to facilitate the AMDC to move to the host country by 30<sup>th</sup> April 2018, the Country wishing to host the Institution should provide the accommodation of the Head of the Secretariat.

## II. Scoring

3. In addition to the above, the AUC delegation recalled to each State that the initial evaluation mission conducted in 2016 had omitted to score the respective States against these criteria, thus the AU Commission was directed by the meeting of the Permanent Representatives Committee (PRC) to reassess and score the offers.

4. The Score Sheet used in the assessment is divided into two (2) sections: (i) Section A - Primary Requirements consisting of ten (10) checklist items extracted from the 2005 Criteria for Hosting AU Organs; and (ii) Section B - Additional Requirements consisting of the three (3) items set out above. Each checklist item carries a maximum of (ten) 10 points except the ratification and residence criteria under Section B which carry a maximum of five (5) points each. In this regard, the maximum point attainable from the Score Sheet is one hundred and twenty (120) points

## III. Republic of The Sudan

5. The AUC delegation made its presentation to the representatives of the Government, who on its part reiterated its strong interest to host the Centre and it fully concurs with the Vision of the Centre - to add value to Continent's Mineral resources and to provide technical assistance to AU Member States in implementing the African Mining Vision. The Government has also shown its readiness to consider the additional requirements laid out by the AUC.

6. The Team visited the permanent premises offered by the Government to host the Centre. The Building used to be Office for the Ministry for Petroleum, Gas and Mining located a few metres from the Nile River Street. The structure holds standard office spaces, guest-holding rooms, lavatories and kitchen and functioning lifts. It also contains spacious meeting rooms, conference hall with 150 seats and a rooms built for

a library. The premises is found along the same street where the United Nations Development Program Sudan Country Office and several Government Ministries are also located.

7. With regard to the budget for interim period, the Government informed the AU Delegation that efforts will be made to negotiate with the Ministry of Finance for funds given that the Budget for 2018 had already been approved.

#### IV. Republic of Zambia

8. The AUC delegation met with a number of Zambian Ministries including the Ministry of Mines, Tourism, Works, Infrastructure and Housing and Foreign Affairs. Following the AUC's presentation, the representatives of the Government at the respective ministries reaffirmed Zambia's commitment to host the secretariat of the AMDC, emphasising its merits in the field of mining and readiness to meet the additional criteria.

9. The delegation assessed three (3) locations designated by the Government of Zambia as the possible premises of the AMDC as follows:

- a) **Option 1** – located within the newly built complex of the Zambian Ministry of Housing and Infrastructure Development opposite the former USA Embassy. The Government earmarked the entire first floor of the building for the AMDC. The property comprises four (4) spacious open-plan office spaces to be equipped with work stations and a separate secluded office for the Head of the AMDC. There are separate toilets designated for men and women, kitchen area, functional lifts, stairways, air conditioning. The premises is secured within a gated compound with 24/7 security.
- b) **Option 2** – located on the 5<sup>th</sup> floor of the building complex of the Zambian Ministry of Finance known as National Statistics House. The floor will be shared with staff of the Central Statistics Office , although the Government representatives expressed that some reassignments could be made so that the AMDC alone occupies the 5<sup>th</sup> floor.
- c) **Option 3** - located within the Mukuba Pension House building complex, the Government representatives emphasised the symbolic significance of this building which formerly housed the Zambian Copper Conglomerate. The premises is neighboured by the Zambian Ministry of Mines and is fully secured with CCTV surveillance cameras, comprises of executive offices that can be easily converted into open plan offices, conference facilities, designated male and female toilets.

- d) The Government also informed the AUC that a plot of land has been earmarked to build a permanent structure for the AMDC if Zambia is chosen to host.

**10.** In addition to the office premises, the Government of Zambia also offered two (2) options as residential properties designated to accommodate the Head of the AMDC as follows. The residential premises are located in the Kabulonga Area of Lusaka. Both a four (4) bedroom bungalow and duplex respectively, with bathrooms, a living room, dining area, kitchen, laundry room, pantry and a large surrounding garden with sufficient water and electricity supply.

**11.** In relation to the requirement for ratification of the AMDC – at the time of this evaluation, Zambia had signed the instrument and is currently in the process of concluding its internal processes for ratification.

**12.** With regard to a budget for interim period, the Government informed the evaluation Team that efforts will be made to negotiate with the Ministry of Finance for funds given that the Budget for 2018 had already been approved.

## **V. Republic of Kenya**

**13.** The AUC delegation met with the Cabinet Secretary of the Kenyan Ministry of Mining who made the case for why Kenya should host the AMDC. He referenced Kenya's Pan-Africanism and its vision to help the AMDC attain its utmost potential. He further assured the AUC of Kenya's willingness and readiness to fund the AMDC, evidenced in the Government's inclusion of an approved budget line for this purpose since the initial evaluation mission in 2016 as well as a readiness to increase the budget to accommodate additional requirements.

**14.** The AU delegation did not view any physical premises for the AMDC, however, the Government of Kenya assured of the availability of funds to rent the interim offices premises as well as residence of the head of the AMDC if Kenya is chosen. Additionally, Kenya is ready to build a permanent structure for the AMDC.

**15.** With regards to the ratification requirement, at the time of this evaluation, Kenya has yet to sign or ratify the AMDC Statute, however, the Government assured of its best efforts to fast-track completion of the process.

**16.** With regard to the budget to support the interim period, Kenya has since 2016 an approved budget for AMDC and currently an approved budget of Ksh30 million (US\$ 300,000) is readily available for the AMDC. In addition, the Ministry of Mines has included in its budget cycle a budget line for the AMDC for additional funds as and wherever required.

## VI. Republic of Guinea

17. The AUC delegation met with the Guinea Prime Minister, Ministers of State in the President's Office, Foreign Affairs Minister, as well as the Deputy Minister of Mines on behalf of the Government. They presented various reasons why Guinea should be chosen to host the AMDC including the fact that Guinea is a mineral rich country with a lot of ambition in the sector and is currently developing a Regional Centre of Excellence for Mining. Additional emphasis was also placed on the fact that Guinea does not currently host any AU Organs or institution though being one of the founder members of the OAU/AU. The Government maintained and reaffirmed the commitment of Guinea to host the AMDC with an assurance to look into internal means of meeting the additional requirement for financial support.

18. The delegation assessed two (2) locations designated by the Government of Guinea as the possible premises of the AMDC or the as follows:

- a) **Option 1** – located in the Union of State City, this property comprises of several rooms on three floors, built as a residence but could be converted into an office premises. This property requires renovation, which the Government assures will be commenced if Guinea is chosen to host the AMDC.
- b) **Option 2** – Located in the Cammayene area of Conakry, the office premises is situated on the 4<sup>th</sup> floor of the Ghassn Building complex with three large offices spaces, with a capacity of twelve (12) per room with open plan work stations, a separate office for the Head, 2 toilets, lifts and stairway, air conditioned, fibre optic internet and 24/7 security. It is 10 minutes from the Ministry of Mines and close to two major hospitals in the city. There is a further proposal to house the Head of AMDC within the same building complex if desired.
- c) The AUC delegation also viewed a plot of land located in Kouriah about 60 km outside Conakry, which has been designated for building the AMDC permanent premises.

19. In relation to the requirement of ratification, at the time of evaluation, Guinea had neither signed nor ratified the AMDC Statute officially, however, the Government of Guinea asserted that the internal processes for ratification have been completed and provided the Commission with a copy of the instruments of ratification, and the original copy to be deposited with the Office of the Legal Counsel of Commission by the Permanent Representative of Guinea to the AU. In this regard, on 16<sup>th</sup> January, Guinea

deposited the Instruments of ratification of the AMDC with the Office of the Legal Counsel and as such completed the ratification Process.

**20.** In relation to the budget for the interim period, the AU Delegation was informed that the Government is ready to provide funding of not more than \$2 million per year for an interim period of (2) or more years.

## VII. Conclusion

21. During both the initial evaluation and the re-evaluation, all countries displayed a high level of commitment to host the African Minerals Development centre. All countries are mining countries and are adhering to the principles of the Africa mining Vision. They all have displayed high level of Pan African ideals and values and all understand the importance as well as the transformative role of the mineral resources. They all

understand the AMDC as an AU institution should be owned and principally funded by the African Countries to ensure that the mineral resources contribute to the inclusive growth and sustainable development through social and economic structural transformation not only of the hosting country but of the continent as envisioned by the Agenda 2063. They all agree that the core budget of the institution should be met by member States with any development partners funding leveraging and contributing to only the programmatic budget.

**22.** As indicated by the score sheets of the countries, the following are the results:
