INTRODUCTION

1. The Decision of the Assembly (AU/Dec.318(XV)) on the Implementation of the Previous Decisions of the Executive Council and the Assembly, adopted by the 15th Ordinary Session of the Assembly held in Kampala, Uganda in July 2010, requested the Commission, in collaboration with the Permanent Representatives' Committee (PRC), to improve the format for reporting implementation of previous Decisions.
2. Following the adoption of a new format for reporting the implementation of the various Decisions, Declarations and Resolutions of the Executive Council and the Assembly, at the recently held third Joint Retreat between the Permanent Representatives Committee (PRC) and the African Union Commission (AUC) which took place in Nazareth, Ethiopia from 31 March to 2nd April 2011, the Commission subsequently articulated the key Decisions that arose from the past two immediate Summits held in Kampala, Uganda and Addis Ababa, Ethiopia, in July 2010 and January 2011, respectively.
3. The Decisions taken by the Policy Organs, namely; the Executive Council and the Assembly of the Union during their Ordinary, Extraordinary and Special Sessions, constitute the legal basis upon which the Commission and the other Organs of the Union as well as other stakeholders and partners such as the RECs derive the authority and mandate to carry out activities aimed at fostering continental integration process and global networking.
4. The compiled report summarizes progress made on the implementation of Decisions of the Executive Council and the Assembly of the Union for the period under review and provides information on actions taken to promote and facilitate co-operation among Member States, especially in the areas relating to peace and security, administration, finance, socio – economic, scientific, cultural and political matters in which the Commission was required to take action. Overall, a considerable amount of progress has been made since the July 2010 Kampala Summit to date.
5. It is worth mentioning that the majority of Decisions are expected to be implemented by the Member States themselves. In this regard, the Commission has endeavoured to identify those pertinent provisions of the Decisions which are to be implemented by the Member States for the last two Summits (Kampala, July 2010 and Addis Ababa, January 2011). The Commission has forwarded these Decisions to Member States and has requested them to submit relevant information on the status of their implementation in respective countries by 1 September 2011. Upon receipt of this information, the Commission will analyse, classify and compile them in a summarized form for subsequent submission to the 18th Summit in Addis Ababa in January 2012.

6. During the period under review, a number of initiatives aimed at advancing the development within the changing dynamics of the African continent were undertaken. Such initiatives include:

- Actions adopted by the Assembly on Maternal, New born and Child Health and Development in Africa;
- Renewed commitment for attainment of the Millennium Development Goals (MDGs);
- Concerns for child welfare and gender issues;
- Commitment to combat corruption;
- Prevention and resolution of conflicts;
- Technological advancement and the integration of existing initiatives on infrastructures;
- Food security and climate change;
- Search for alternative sources of financing the Union;
- The need for involvement of the youth in the polity of the continent, leading to the choice of “Accelerating Youth Empowerment for Sustainable Development” as Theme for the June/July 2011 Summit, in Malabo, Equatorial Guinea.

7. In the course of carrying out the implementation of the Decisions, a number of technical, human, material and financial challenges were encountered, hence the reason for the deferment of implementation of some key Decisions to a later date when the conditions that constituted constraints have been alleviated.

8. The Commission, in collaboration with the Permanent Representatives’ Committee, would continue to work towards ensuring that only informative, concise and reader friendly reports on implementation of previous Decisions are rendered while striving to limit the number of Decisions taken by the Policy Organs in view of the evident budget constraints and scarce resources required for the execution of the Decisions.
