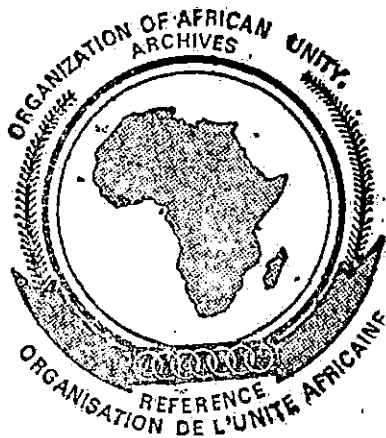

SUBJECT: REQUEST FOR SUBVENTION

Dear Sir,

We have the honour to inform you that the Panafriean Youth Movement will be engaging in numerous activities at both Continental and International level in the course of 1976.

Among these activities, which are as numerous as they are important, we may quote the following:

- 1) Meeting of the Executive Committee of the Panafriean Youth Movement in Casablanca (Morocco).
- 2) Preparation and holding, in collaboration with the European Council of Youth Organizations, of a Seminar on the struggle in Southern Africa, in Bonn (FRG).
- 3) Conference on the African Student and his participation in the general struggle of the African peoples, in Dar-es-Salaam.
- 4) Holding of a World Assembly of Youth on the New International Economic Order, in Algiers.
- 5) Implementation of the action programme drawn up by the Liberation Movements Committee of the PAYM.
- 6) Meeting of the Statutory Working Committees of the PAYM.
- 7) Functioning of the General Secretariat, whose relations with International Institutions and the International Youth Movement results in the organization of a multiplicity of initiatives for the Movement, and these activities are added to those for the annual 1976 programme.

These activities, among so many others, call for very substantial expenditure by our Movement.

In order to enable us to cope with these initiatives with the maximum of success, we are requesting the OAU Council of Ministers, at its Twenty-Sixth Ordinary Session, to grant our Movement a subvention of US.\$190,000 (One hundred and Ninety Thousand US Dollars).

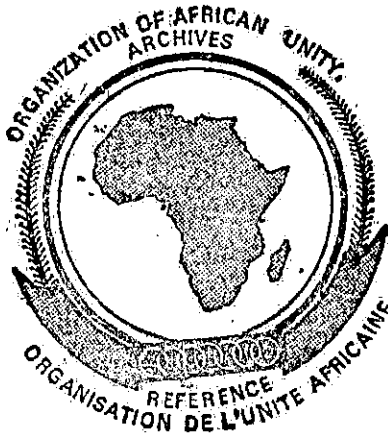
We are convinced, Mr. Secretary-General, that you will devote the closest attention to our request.

We avail ourselves of this opportunity to inform you that the Panafrican Youth Movement organized a number of activities during 1975 and is now having to deal with the operational costs of the General Secretariat, which involved expenditure amounting to AD.235,000 (Two Hundred and Thirty-Five Thousand Algerian Dinars), equivalent to US.\$60,000.--. We are sending you the invoices connected with this expenditure, in accordance with the OAU's Financial regulations and in justification of the use of the subvention of 60,000 US Dollars which the Twenty-Fourth Ordinary Session of the OAU Council of Ministers accorded our Movement.

Wishing you every success in your great and noble mission for the welfare of our Continent, please accept, Mr. Secretary-General, the expression of our highest consideration and esteem.
