DECISION ON THE REPORTS OF THE PERMANENT REPRESENTATIVES' COMMITTEE (PRC) SUB-COMMITTEES

- 1. TAKES NOTE of the PRC recommendations on the Reports of its Sub-Committees
 - I. THE JOINT SITTING OF THE SUB-COMMITTEE ON STRUCTURAL REFORMS AND THE SUB-COMMITTEE ON GENERAL SUPERVISION AND COORDINATION ON BUDGETARY, FINANCIAL AND ADMINISTRATIVE MATTERS ON THE TRANSITION PLAN AND FINANCING STRATEGY FOR THE NEW DEPARTMENTAL STRUCTURE OF THE AFRICAN UNION (AU)
- 2. RECALLS EX.CL/Dec.1073(XXXVI) which recommended the new departmental structure of the AU Commission which also decided that:
 - The Commission and Member States shall finalize the Transition Plan and Financing Strategy by June 2020 for consideration by the 37th Ordinary Session of the Executive Council:
 - The implementation of the new departmental structure shall be financed within existing resources and should come at no additional cost to Member States;
 - The Commission shall complete the implementation of the new structure within three years from the date of adoption of the Transition Plan and Financing Strategy;
 - iv A staff skills and competency audit shall be undertaken and shall be applied to regular and non-regular staff to determine whether they meet the requirements of the new structure;
 - The Commission with the oversight of the ten Recruitment Experts (R10) shall develop the job profiles and competency requirements for the new departmental structure of the Commission by June 2020; and undertake a staff skills audit and competency assessment. The Commission and R10 shall be assisted, if required, by an independent firm; and
 - vi The Commission shall provide all technical, administrative, financial and logistic support to facilitate this process;
 - vii The Commission should address the irregularities in the application of the existing AU Staff Regulations and Rules regarding the renewal of non-

regular staff contract beyond the permissible number of renewals, within the context of the Transition Plan and that the Chairperson of the Commission should report to the next Ordinary session of the Executive Council on progress on this matter.

- 3. FURTHER RECALLS Ext/EX.CL/Dec.1(XX) paragraph 36 and REITERATES that the current quota system applied to AUC regular staff should take into account the gender and youth quotas and be extended to short term, fixed term and special service staff and to all staff of the Organs, excluding general service staff and DIRECTS the AUC for its immediate implementation;
- **4. REQUESTS** the Commission to ensure that all staff costs funded by Partners shall remain under the Program Budgets of the Union;
- 5. **DECIDES** to adopt Phase one (1) of the Transition Plan and financing strategy including Scenario one (1) of the separation scenarios. Further **DECIDES** to lift the moratorium on the recruitment of Director level posts within the AU Commission to enable the implementation of phase 1 of the transitional plan:
- **DECIDES** that Phase two (2) and three (3) of the Transition Plan and Financing Strategy shall be considered at a later stage;
- 7. REQUESTS the Commission not to utilize any arrears to finance the new structure and REITERATES that the implementation of the new departmental structure shall be financed within existing resources and should come at no additional cost to Member States:
- 8. REQUESTS the PRC and the Commission and STC Justice and Legal Affairs to expedite the review of the Financial Rules and Regulations (FRR) and the Staff Regulations and Rules (SRR) for consideration and adoption by the relevant Policy Organs by December 2020 in order to enable the implementation of Phase 1 of the transition plan with a new legal framework in place;
- **9. DECIDES** that the Staff Skills Audit and Competency Assessment shall be applied to all current AUC staff subject to Phase one (1);
- 10. DIRECTS the Commission, in collaboration with the R10, to develop the terms of reference for the skills audits and competency assessment that shall be implemented by an independent human resource HR firm in order to ensure credibility and transparency;
- **11. APPROVES** the supplementary budget request of \$450,000 to be funded from African private sector funds for the implementation of the skills audit and competency assessment;

12. DECIDES that the proposed voluntary departure scheme shall be limited to staff with a regular contract;

- **13. DECIDES** that competition for vacant posts shall be open to internal, and external applicants.
 - II. THE JOINT SITTING OF THE SUB-COMMITTEE ON GENERAL SUPERVISION AND COORDINATION ON BUDGETARY, FINANCIAL AND ADMINISTRATIVE MATTERS, SUB-COMMITTEE ON PROGRAMS AND CONFERENCES AND THE TECHNICAL EXPERTS OF F15 Doc: EX.CL/1229(XXXVII)

A. ON STAFF RETIREMENT STATUS AT THE AU COMMISSION

- 14. **EXPRESSES** concern on the proposal to extend staff contracts beyond the retirement age as stipulated in the AU Staff Regulations and Rules;
- 15. INSTRUCTS the Commission to strictly apply the Staff Regulations and Rules as the provisions are clear and adequate;
- 16. CALLS UPON the Commission to extend employment contracts on case-bycase basis, in accordance with SRR;
 - B. ON THE AU 2019 BUDGET EXECUTION REPORT
- 17. EXPRESSES concern regarding the low execution rate of the AU 2019 Budget, especially the execution rate of programs and NOTES WITH CONCERN the inaccuracy of the justifications provided by the AUC that the low execution rate incurred due to the drastic reduction of the AU 2019 budget, the non-availability of resources and the moratorium imposed on the recruitment of Directors and short-term Staff;

C. ON THE 2019 BUDGET TECHNICAL PERFORMANCE REPORT

- 18. **DECIDES** to impose sanctions on Departments that have not submitted their 2019 execution reports and **REQUESTS** the AUC Chairperson to report on the implementation of this decision at the 38th Ordinary Session of the Executive Council;
- **19. URGES** the Commission to sign performance contracts with staff so that staff are appraised against their performance; and **REITERATES** the need to put in place effective staff performance mechanisms to ensure that staff perform to high standards;
- **20. CALLS UPON** the Commission to provide both technical and financial execution rate in one report for improved decision making;

21. EMPHASIZES the need to take into consideration the human resource capacity of each department when allocating resources during budget consideration.

D. ON THE INTERNAL AUDIT REPORT OF THE 2019 BUDGET PERFORMANCE

- **22. REQUESTS** the Office of Internal Audit to also present budget performance audit reports of other AU Organs along with the audit report on AUC:
- 23. ALSO REQUESTS the Commission, through the SPPMERM directorate:
 - i) to engage partners to fund AU priorities as set by the AU policy organs;
 - ii) to conduct research to establish the main reasons as to why some partners are not remitting the funds to AUC as pledged and report back to the PRC;
- 24. REITERATES that no activity shall be included in the approved budget without secured funding;
- 25. CALLS FOR accountability for any financial loss of \$283,841.89 incurred in judgment ref no. AUAT/2019/001 dated 10 September 2019, as ruled by the Administrative Tribunal and the liable persons to be held responsible for the loss and DIRECTS the AUC Chairperson to prepare a detailed report on the outcomes of the Administrative Tribunal on the judgment ref no. AUAT/2019/001 and other cases and report back to the Executive Council at its 38th Ordinary session through the relevant organs of the AU;
- **REQUESTS** the AHRMD to continuously advise the AUC Chairperson on matters of appointment, which clearly spells out the implication for any appointment decision taken; and **ALSO REQUESTS** the Office of Legal Counsel to always provide legal advice in line with AU Staff Regulations and Rules on any appointment decision made on exceptional basis by the Chairperson of AUC or any competent authority of any other AU Organs.
- **27. URGES** the Commission to include in the Staff Regulations and Rules provisions to allow for the prerogative of the Chairperson in the appointment of staff;
- **28. DIRECTS** the Commission to obtain written commitment from Partners regarding funding of programs, prior to consideration and approval of annual budgets by the relevant AU Policy Organs;

E. ON SHORT TERM STAFF FUNDED BY PARTNERS

29. DIRECTS the Commission to use the resources provided by Partners prudently, strictly in accordance with partners agreements to avoid using Member States funds to pay salaries for staff funded by partners;

30. REQUESTS the Commission, through the Legal Counsel, to develop a template for staff contracts under Partners' funding, which should incorporate a clause to avoid legal challenges when funds are not available or upon phasing out of the project;

31. **ENCOURAGES** the AU Commission to engage partners with long term funding on technical assistance arrangement instead of requesting for direct funding to lessen stress on the AU Organs;

F. ON THE R10 PROGRESS REPORT

- 32. NOTES WITH CONCERN the challenges encountered by the R10 and in this regard DIRECTS the Commission to render the requisite support to the R10 so that the committee is able to effectively execute its mandate within the set time frame.;
- REQUESTS the R10, to present a detailed report at the 38th Ordinary Session of the Executive Council, that includes a matrix of activities, both achieved and pending, indicating the responsible Organ at each phase with a clear timeline including the exit strategy.
- 34. RECALLS Executive Council Decision EX.CL/Dec. 1073 (XXXVI) which "APPROVES the extension of the R10 mandate from March to September 2020, including to provide recommendations aimed at addressing the imbalance in the representation of Member States, in accordance with the quota system" and DECIDES to extend the period of assignment of the R10 experts up to February 2021.
- 35. RECALLS Decision Assembly/AU/Dec.388 (XVII), and Decision Assembly/AU/Dec.794(XXXIII) and; DIRECTS the Commission to implement these decisions, on the incorporation of the use of the Spanish language among other AU working languages in the new recruitment system.

G. ON RECRUITMENTS FOR 2019 AND 2020

- **36. DIRECTS** the R10 to evaluate the 2019 and 2020 appointments made and submit a report to the PRC by February 2021 through its relevant Sub-Committees;
- **37. EXPRESSES** concern over the roster system which hinders new skills and competencies in the organization and **DECIDES** to abolish the roster system;
- 38. REQUESTS the Commission in consultation with the R10 to review the quota system and present a proposal to the Executive Council by February 2021 and DECIDES that the quota system shall be applied to both regular and non-regular

staff and across the Union; African Union Youth Volunteer Program, Africa CDC Youth Fellows and scholarships of the Pan-African University students.

- 39. **RECALLS** Executive Council Decision EX.CL/Dec.1073 (XXXVI) paragraph 34 that "URGES the Commission to work with the support of the R10, to correct, as a matter of priority, the glaring imbalance in the representation of Member States, in accordance with the quota system and the principle of equitable geographical representation within the African Union, and report regularly to the PRC on progress made"; and **DIRECTS** that the quota system issue shall be a permanent agenda of the PRC and its relevant Sub-Committees;
- **40. REQUESTS** the Commission to organize training sessions for the focal points in the permanent missions on the requirements of AU recruitment;

H. DECISION ON THE 2021 AFRICAN UNION BUDGET

- 41. TAKES NOTE of the Reports of the PRC and Joint Sitting its Sub-Committee on General Supervision and Coordination on Budgetary, Financial and Administrative Matters, Sub-Committee of Programs and Conferences and the F15's Committee of Experts;
- **DECIDES** that the 2021 budget shall be an austerity budget and that a midterm review mechanism be instituted in September of each year to address emerging issues;
- 43. URGES the Commission to rationalize all activities requiring consultancies and prioritize the recourse to consultancies on a need by need basis and as per the AU priorities;
- 44. RECALLS paragraph 42 of its decision EX.CL/Dec.1073 (XXXVI) and DECIDES to channel all capacity building activities of the AU to the ACBF, with the exception of the AU-IBAR, AFREC, Infrastructure and Energy and AUDA-NEPAD
- **45. DIRECTS** the AUC and all AU Organs to make use of virtual meetings instead of physical meetings, with a view to make savings on travel costs.
- 46. APPROVES a total budget of US\$636,075,986 for the AU for the year 2021 of which US\$203,500,000 is to be assessed on Member States (32%), US\$8,500,000 from the Administrative Cost (1%); US\$418,434,167 from Partners (66%), and US\$5,641,820 from the Maintenance Fund (1%). This is further broken down as follows:
 - a. Regular budget of **US\$371,337,325** broken down as follows:
 - i. Operating budget of **US\$172,089,820** to be funded as follows:
 - US\$161,000,000 (93%) assessed on Member States;

- US\$8,500,000 (5%) from Administrative Cost and
- US\$2,589,820 (2%) from the Maintenance Fund;
- ii. Programme Budget of **US\$199,247,506** to be financed as follows:
 - US\$42,500,000 (21%) assessed on Member States;
 - US\$3,052,000 (2%) from the Maintenance Fund; and
 - **US\$153,695,506 (77%)** to be solicited from international partners;
- b. Peace Support Operations with a total budget of **US\$264,738,661** to be fully solicited from international partners;



 the Commission, to undertake regional consultations on the matter of assessing
 the Peace Fund and report back to the Executive Council in Niamey, Niger, in
 June 2019.
- 2. **FURTHER RECALLS** the July 2019 Progress Report of the AU High Representative for Financing the Union and the Peace Fund on the Outcome of the Regional Consultations on the Matter of Assessing the AU Peace Fund.
- 3. RECALLS Executive Council Decision EX.CL/Dec.1089 (XXXVI) requesting the AU High Representative to conclude the regional consultations and report back to the Executive Council in July 2020.
- 4. DECISION ON THE REPORT OF THE JOINT SITTING OF THE MINISTERIAL COMMITTEE ON SCALE OF ASSESSMENT AND CONTRIBUTIONS AND COMMITTEE OF FIFTEEN MINISTERS OF FINANCE (F15) Doc.EX.CL/1239 (XXXVII)

- TAKES NOTE of the Report of the Joint Sitting of the Ministerial Committee on Scale of Assessment and Contributions and the Committee of Fifteen Ministers of Finance (F15);
- 2. COMMENDS Member States for contributing 59% of the funds assessed to them in 2020 towards the Union regular budget and 32% towards the Peace Fund endowment despite challenges they are faced with as a result of COVID-19 pandemic;
- 3. ALSO COMMENDS Member States that are up-to-date in the payment of their contributions, including those that have made advance payments towards the 2021 budget, and URGES Member States that have not yet done so to pay their assessed contributions in fulfilment of their financial obligations to the Union;
- 4. RECALLS Decision Assembly/AU/Dec.752(XXXIII) of February 2020 in Addis Ababa, in which the Assembly DECIDED to impose sanctions on Member States, in line with paragraph 3(c) of the November 2018 Assembly Decision Ext/Assembly/AU/Dec.3(XI);
- **5. DECIDES** to lift the sanctions previously imposed on the Republic of South Sudan as well as the Republic of Liberia
- **6. FURTHER DECIDES** to impose sanctions as follows:
 - a) Cautionary sanction on Nigeria, Equatorial Guinea, Mozambique, Benin, Mauritania, Central African Republic, Djibouti, Gambia, Comoros, Tunisia, Cape Verde, Cameroon, Niger and Senegal
 - b) Intermediate sanction on Tanzania and Eswatini.
 - c) Comprehensive sanction on Guinea Bissau and Sao Tome & Principe.
- 7. **RECALLING** Decision **EX.CL/Dec.1071(XXXV)** of the Thirty-Fifth Session held in Niamey in 2019 in which the Executive Council decided to, taking into account the security and political situation, withhold the imposition of sanctions on Somalia and Libya, and in this regard, requested the Commission to consult with the two countries to agree on a repayment plan to clear the arrears as soon possible, within four (4) years from the adoption of the Decision; **REQUESTS** the Commission to expeditiously finalize consultations with Somalia, and Libya report back to the Executive Council in February 2021;

Candidates will contest with others from various regions of the world.




D. ON DELEGATION OF AUTHORITY IN BETWEEN THE SESSIONS OF THE COUNCIL

- 1. **NOTES** with sadness the demise of Hon. Dr Azza Al Ashmawy from the Arab Republic of Egypt, who served as the Member of the African Committee of Experts on the Rights and Welfare of the Child and pays tribute to the work conducted by the late member.
- 2. RECALLS that Article 39 of the Charter of the African Committee of Experts on the Rights and Welfare of the Child stipulates that the State which nominated the incumbent member shall appoint another member from amongst its Nationals to serve for the remainder of the term;
- 3. TAKES NOTE of the Report of the Commission on the Approval of Appointment of One (1) Female Member of the African Committee of Experts on the Rights and Welfare of the Child in which the Arab Republic of Egypt submitted a candidate.



- 2. **TAKES NOTE** of the Commission's Report on the Response to COVID-19 Pandemic in Africa prepared by the Africa Centres for Disease Control and Prevention (Africa CDC) and the recommendations therein;
- 3. **EXPRESSES DEEP APPRECIATION** to the Chairperson of the African Union H.E. Mr Matamela Cyril Ramaphosa, President of the Republic of South Africa, and the members of the Bureau of the Assembly of the African Union: H.E. Félix Tshisekedi of the Democratic Republic of Congo, H.E. Abdel Fattah el-Sisi of the Arab Republic of Egypt, H.E. Uhuru Kenyatta of the Republic of Kenya, and H.E. President Ibrahim Boubacar Keïta of the Republic of Mali, for providing exemplary, timely, focused and effective leadership to Africa's response to COVID-19;
- 4. COMMENDS the Chairperson of the AU Commission, Members of the AU Commission and Staff of the African Union for the support they have provided to the Bureau of the Assembly and for implementing the decisions of the AU Policy Organs on Africa's response to the COVID-19 pandemic;
- 5. **WELCOMES** the efforts of Member States on fighting COVID-19, including the efforts of H.E. Dr. Abiy Ahmed, Prime Minister of the Federal Democratic Republic of Ethiopia with the Jack Ma Foundation, which led to a major boost in the prevention and control of the outbreak of COVID-19 in the continent;
- 6. **ALSO COMMENDS** the Africa CDC for its contribution in responding to COVID-19 pandemic and congratulates Dr. John Nkengasong, Director of Africa CDC, for receiving "Global Goalkeeper 2020 Award" by the Bill and Melinda Gates foundation;
- 7. **ACKNOWLEDGES** the efforts of the Ministers responsible for health, finance and transport, and all other stakeholders in their roles to respond to the COVID-19 pandemic;
- 8. **ALSO ACKNOWLEDGES** the Communiqué submitted by African Women Ministers of Foreign Affairs on "Enhancing Women Leadership in COVID-19 Responses", and requests the African Union Commission to develop and implement AU Guidelines on Gender-Responsive responses as a framework to integrate gender equality and Women's participation in decision making

- 14. **EXPRESSES** gratitude to all AU Member States⁷ who have pledged contributions a total of USD 20.7 million to support the AU COVID-19 Response Fund as annexed and **ENCOURAGES** Member States that have not yet done so, to consider making voluntary contributions to the AU COVID-19 Response Fund and Africa CDC in an effort to pull together continental resources to support the African Union fight against the pandemic on the continent;
- 15. **ALSO EXPRESSES GRATITUDE** to Member States of the African Union that have implemented measure at the national level to protect their citizens from the COVID-19 pandemic and **ALSO APPRECIATES** those members that have initiated bilateral efforts to assist other AU Members by providing in-kind assistance to support the fight against the pandemic;



16. **NOTING** the role of the Africa CDC, within its existing mandate, to a timely and effective health emergency preparedness and response;

- 17. **ALSO TAKING NOTE** of invaluable efforts to deal with the COVID-19 pandemic in Africa, including the:
 - a. implementation of the Africa Joint Continental Strategy for COVID-19, through the Africa Taskforce on Coronavirus (AFTCOR);
 - b. initiatives such as the Partnership to Accelerate COVID-19 Testing (PACT) and the "Saving Lives and Saving Economies" Campaign to protect borders, economies, and schools from COVID-19 to secure the continent
 - Africa COVID-19 Vaccines Development and Access Strategy;
 - d. establishment and operationalization of the African Union COVID-19 Response Fund;
 - e. / mobilization of financial support as well as human and material resources;
- 18. STRESSES that the vaccine strategy should aim to ensure a secure timely access to COVID-19 vaccines when available;
- 19. **EMPHASISES** the role of the African Medicine Agency (AMA) with the main objective of enhancing Member States and Regional Economic Communities' capacity when finalized to improve access to quality, safe and efficacious medical products on the continents **AND URGES** all Member States that are yet to do so, to sign and ratify the Treaty establishing AMA to enable it to enter into force:
- 20. APPEALS to the scientific community to accelerate the search for a vaccine against COVID-19 in order to slow the spread of the disease, protect vulnerable populations and ultimately return our society and economies back to normal and towards Africa's broader global development agenda;
- 21. **REQUESTS** the Commission to prepare a report, including a road map and Framework of Operations, outlining the financial, legal and structural implications to fully operationalize the Africa CDC in line with its Statute, for submission to the 38th Ordinary Session of the Executive Council through AU Policy Organs
- 22. **REASSERTS** that the budget of Africa CDC shall be that of the Union, however, given the nature of the institution and its mission of supporting Member States, **REQUESTS** that the Africa CDC budget be carried over to the subsequent calendar year;
- 23. **DECIDES** to remain seized of the matter and **REQUESTS FURTHER** the Commission to report on progress and the implementation of this decision to the 38th Ordinary Session of the Executive Council.
