My vision is to leapfrog Africa's development, lead and manage a productive Department.

- (1) Leapfrogging Africa's development would be achieved by designing strategies that eliminate our underdevelopment and middle-income trap and replace it with high and sustained levels of green growth. This would be achieved by doing the following:
- (2) Eliminating illicit financial flows through improved governance and effective tax administration; in turn improve domestic resource mobilization. Achieving this would attract pension funds, other financial institutions and individuals with financial holdings abroad to remit them back and invest across the continent;

4.2 Invest in Research and Development to facilitate original-design-manufacturing and later, original-brand-manufacturing, vital to avoiding intellectual property rights restrictions associated with original-equipment-manufacturing in the process of industrialization. Emerging innovations will move Africa up in the global value chains as well as create her capacity to develop regional value and supply chains critical to facilitating increased intra-African trade in value-added products; and, resilience from crises.

(6) Collaborating with Member-States, African Continental Free Trade Area(AfCFTA), AU Development Agency-NEPAD and Regional Economic Communities(RECs) to:

5.1 Develop and implement a framework of collaboration among the African Union Commission, the AfFTA, AUDA-NEPAD and RECs aimed at:

- (a) Building transparency, mutual trust and synergies in their daily operations;
- (b) Overcoming overlaps and duplication, thereby removing resource wastage, critical to generating high impact results; and,
- (c) Laying foundations for the African Customs Union and ultimately the African Economic Community. This will include defragmenting Africa by creating a single market of 1.27 billion people, making it the third biggest market after India and China, in the process, unleashing large economies of scale and scope that are vital to attracting and retaining investments and increasing Africa's share in global trade. A single market will also create conditions for coming up with a self-financing mechanism critical to increasing funding to the AU system. - (10) Convinced my cousins in the village where I was born to pool their holdings and register a primary cooperative to enable them move up in the farming value chain.



Africa and the Commission in this role

My vision as a Commissioner is to be a key driver for the realisation of Agenda 2063 with its aspirations of the Africa we want anchored on the Constitutive Act. In my role, I shall be guided by the AU vision and Africa Union Commission (AUC) mission, values and principles. Agenda 2063 is a comprehensive framework that encapsulates a range of key strategic aspirations covering among others, sectors of Economic Development, Trade, Industry and Mining.

The first point of reference is the initial implementation tool namely, The First Ten Year Implementation Plan (2013- 2023), which specifies the goals, priorities and outcomes to be attained by 2023. In addition, I will use the quantitative and qualitative findings contained in the First Report on the Implementation of Agenda 2063. These are key instruments that will shed light on areas of emphasis particularly where performance needs improvement and sustaining and further strengthening where performance is good.

The seven overarching aspirations in Agenda 2063 requires a multisectoral approach and multiagency participation premised on the principle of subsidiarity and complementarity. The First Ten-Year Implementation Plan sets 2023 as the target timeframe for attainment of the specified goals, priorities and targets including the identified flagship projects.

My approach to the realisation of the aspirations and goals of Agenda 2063 will also put into context the impact of COVID 19 pandemic on Africa's economic growth and sustainable development in the medium to long-term perspective. It is evident that Africa's economies have been negatively affected by the pandemic with some sectors being hit hard thus a drastic decline in GDP growth, loss of jobs, income erosion and shut down of some key sectors will negate the aspirations and slow the pace for the attainment of some aspirations and goals. It is therefore pertinent to design mitigating measures and recovery plans to trigger a rebound of the socio-economic status.



According to the First Report on Implementation of Agenda 2063, the initial cycle performance shows a below average rating against 2019 targets for most of the aspirations and goals. These findings will form the basis upon which I will together with my colleagues, design action plans that will place the continent on a trajectory towards attainment of these goals and aspirations. Specifically, my priority focus will be the following:

1. The Africa Continental Free Trade Area (AfCFTA) goal has been the most successful goal with the highest score in the report of implementation of Agenda 2063. The AfCFTA is expected to enhance intra-Africa trade by threefold and enhance investment and value addition on our agricultural and mineral products. To sustain this trajectory and have a functional Free Trade Area, I intend to prioritize trade by the following;
 - a) Finalisation of all pending issues on the Protocols on Trade in Goods and Trade in Services to facilitate smooth implementation of the AfCFTA.
 - b) Fast tracking the Phase II negotiations on Competition, Investment and Intellectual Property Rights.
 - c) Recalibrate and galvanise African common voice and interests in multilateral and bilateral trade arrangements including Post-AGOA, Post-Cotonou, WTO and UK-Africa trade arrangements.
 - d) Work closely with the AfCFTA Secretariat to develop policies and strategies that will enhance trade facilitation across borders and bolster intra-Africa trade.
 - e) Develop and review for implementation action programmes for inclusive economic growth and sustainable development to uplift women, youth and informal sector.
2. Implement and evaluate the Action Plan for Accelerated Industrial Development for Africa (AIDA) initiative partnering with UNIDO, RECs and Member States agencies.
3. Pursue the domestication of Agenda 2063 in concert with my colleagues at AUC.
4. Drive the establishment and operationalization of Continental Financial and Monetary Institutions by firstly engaging Members States to get the requisite signatures for the



- establishment of the Africa Investment Bank, Africa Central Bank, Africa Monetary Fund and Africa Stock Exchange. Will seek full ownership of Ministers of Finance as drivers of this initiative. Collaboration with International Financial Institutions will be pursued.
5. Tourism before COVID 19 was contributing about 8% of the continents GDP and hence one of the most promising and fastest growing sectors in Africa. My focus will be work with AUDA-NEPAD to concretize the Tourism Plan of Action, harness the regional initiatives on tourism and engage the Ministers responsible for Tourism as a priority component under Agenda 2063. To revitalize the tourism sector which has been hit hard by COVID 19 pandemic, I will lead the development of a harmonized recovery plan drawing from the RECs and Member States' strategies.
 6. Generation of timely, reliable and harmonised statistics for Africa is encapsulated in the Strategy for the Harmonisation of Statistics in Africa (SHaSA) and is an underlying component for attainment of the Agenda 2063 aspirations and goals. Coordination and implementation of the strategy will be prioritised including mobilisation of resources for statistics programmes. The work will entail engagement of REC's Statistical programmes and build linkage to National Strategies for Development of Statistics. My goal is to periodically produce timely and quality statistics depicting realistic trade and socio-economic status of Africa.
 7. I will direct my effort to enhance partnerships with the Private Sector as engines of Africa's Economic growth and development. I will engage and provide support to galvanize an African Business platform and establish a two-way working relationship to enhance dialogue, policy input and fair business practices on the continent.
 8. Drive the implementation of the Africa Mining Vision (AMV) so that Member States adopt policies and strategies that harness and prudently utilise the extractive resources for the development of their economies. There has been a slow pace in the implementation the AMV. I intend to collaborate with respective continental bodies, Member States and private sector groups to push for domestication and



implementation of the vision.

9. In collaboration with AUDA-NEPAD, ECA and AfDB, I intend to put in motion the realisation of the recommendations in the Eminent Persons Report on Illicit Financial Flows and commence mechanisms to activate the directives of the Assembly on diplomatic advocacy for repatriation of illicit resources taken from Africa.

I have 35 years work experience of which 20 years have been at senior management level in key national and regional integration institutions. With the United Nations Conference on Trade and Development (UNCTAD) predicting a significant exacerbation in the level of FDI flows to Africa of up to 40% and World Bank expecting a recession in growth forecasts for the continent in 2020, this paints a bleak picture of the state of affairs for African nations. With the COVID-19 pandemic impacting on the way business is being conducted at all levels, individuals, institutions, governments and industries are reviewing their priorities and reassessing their strategies to mitigate the repercussions in the long run. 

It's incumbent on the Commission to factor this into the Commission's planning process and operations. The Commission needs to harness opportunities brought about by the digital economy and identify innovative ways to bring about the necessary management change as Africa engages with the global economy through trade and proceeds from the industrialization drive, and utilization for Africa's benefit, of its natural resources; including further enhancement of the Commission's negotiation capacity. Financing is always a challenge; traditional sources are no longer adequate to realize aspirations of the Africa We Want. Innovative ways of mobilizing development finance must be vigorously pursued; including domestic resource mobilization (DRM) as espoused in the 2015 Addis Ababa Plan of Action. There is need also to revisit the various initiatives with a view to determine what works and what not and chart the way forward. These include: The Second Decade



of Education for Africa (SDEA), Comprehensive Africa Agriculture Development Programme (CAADP), Program for Infrastructure Development in Africa (PIDA), Accelerated Industrial Development for Africa (AIDA), Boosting Intra-African Trade (BIAT), and Continental Free Trade Area (CFTA) initiative. A programmatic approach is important. For the other pressing challenges, a similar approach needs to be adopted on a selective manner, case by case manner. To accomplish these requires strategic leadership and effective engagement with key stakeholders, including Member States, the private sector and other non-state actors, development partners and development finance institutions.

To realise the Aspirations requires taking, among others, the following measures:

- i. Create common understanding of Agenda 2063 aspirations and its goals among all stakeholders,
- ii. In a consultative manner, revisit the guiding vision and priorities so as to spell out necessary institutional reforms to bring about vigour in operations of the ETIM portfolio,
- iii. Examine each aspiration and associated goals to identify and sift out those to be championed through ETIM portfolio,

Effective partnerships were built with development partners, coming from different countries and with different viewpoints, to ensure convergence and aid effectiveness as they provided financing through general budget support among other modalities. In the process development partners have built confidence in systems of government in managing resources and accounting for them.

I dealt with communities while heading Tanzania Social Action Fund (TASAF), who were of various levels of sophistication. This required demonstration of authority and clarity in communication, transparency in operations, and building the necessary networks, alliances and trust.

Change leadership

Organizations strive when there is dynamism in operations. This requires motivated and measured institutional and staff capacity with high level of exposure. I have always championed the importance of investing in knowledge capital given advances in technology and the influence of digital economy. This way organizational capability is enhanced, new ways of delivery identified, tested and the organizational structure re-shaped to reflect current and future challenges.


