REPORT OF THE ADMINISTRATIVE SECRETARY-GENERALON THE ASSOCIATION OF AFRICAN TRADE
PROMOTION ORGANIZATIONS

Established during its inaugural meeting held at Addis Ababa from 14 to 18 January 1974, in compliance with the recommendations of the seventh OAU/ECA Joint meeting on Trade and Development, the Resolution 247 (XI) adopted by the Conference of ECA Ministers in February 1973 and the Resolution CM/Res. 310 (XXI) adopted by the OAU Council of Ministers in May 1973, which supported the principle of its creation, the Association of African Trade Promotion Organizations held its first General Assembly from 31 March to 4 April 1975 at Tangiers (Morocco).

Among decisions taken, the General Assembly had:

- designated Tangiers as the seat of the Association;
- adopted the rules of procedure of the Association;
- adopted the work programme and priorities (1975 - 1977);
- adopted the composition of the Secretariat of the Association;
- adopted the Budget of the Association fixed at US.\$439,510.00 for the period of 1 October 1975 to 31 December 1976.

It was decided as well to convene an extraordinary General Assembly at Tangiers before the end of 1975, with a view to nominate the Secretary-General of the Association, who is supposed to take up his duties and carry on the execution of the work programme, after recruiting the other staff members of the Association, and take over from the interim Secretary-General appointed by the host Country, according to a recommendation of the General Assembly.

Since the first meeting of the General Assembly, the ECA/OAU Joint interim secretariat had taken the following actions:

- Communication to the member States of the consolidated report of this General Assembly.

- Invitation of the member States to submit candidates for the post of Secretary-General and for the other vacancies with the secretariat of the Association.
- Communication to the member States of their share of contribution to the budget of the Association.

In spite of reminder Notes Verbales and cables sent out, only three member States out of the 26 contributing have so far paid their contributions, namely: Morocco, Ghana, and Sudan.

Only four countries, namely Egypt, Tunisia, Sudan and Somalia have submitted candidates for the post of Secretary-General and only three applications (one from Tunisia and two from Morocco) have been received by the interim secretariat for the 10 other vacancies at the professional level and one vacancy at senior general service level.

In view of the foregoing, the extraordinary General Assembly initially scheduled from 2 to 4 December 1975, has been postponed to the early last quarter of 1976.

In order to enable the Association start an effective and constructive task, it is strongly recommended that the Heads of State and Government recommend to their respective authorities:

- to take necessary action to sign and deposit the instruments of ratification to the Constitution of the Association of African Trade Promotion Organizations as soon as possible,
- to pay their contributions before the end of August 1976.

PREAMBLE

The Governments on whose behalf this constitution is signed:

Having regard to the advantage for the region to be derived from the effective and continuous exchange of information and co-ordination of activities in the field of trade promotion especially as regards intra-African trade;

Being aware of the significant role that African trade promotion organizations have to play in the economic development of the region;

Recognizing that the creation of an Association of African Trade Promotion Organizations for the study, discussion and promotion of African trade matters would best serve these purpose;

Have agreed as follows :

ARTICLE I

Establishment of the Association

1. The Association of African Trade Promotion Organizations (AATPO) (hereinafter referred to as "the Association") is hereby established and shall operate and be governed according to the provisions of this constitution.
2. The Association shall operate under the aegis of the Organization of African Unity and the United Nations Economic Commission for Africa.

ARTICLE II

Objectives and Functions

1. The main objectives of the Association shall be to foster contact and the regular flow of information and communication between African countries in trade matters and to assist in the harmonization of the commercial policies of African countries in order to promote intra-African trade.
2. The Association shall serve as a practical instrument for the promotion of trade and investment particularly within Africa.

3. For the purposes set out in paragraphs 1 and 2 of this Article the Association shall:

- (a) provide for meetings of the Association and its organs;
- (b) assist member States to establish national trade promotion organizations or associations;
- (c) assist member States in the strengthening of their existing trade promotion organizations or associations;
- (d) promote the exchange of ideas and experience in trade promotion generally and intra-African trade in particular;
- (e) Assist African Governments in the formulation of trade policies conducive to trade exchanges and increased intra-African trade;
- (f) make recommendations to member States on various aspects of African trade;
- (g) formulate a code of commercial conduct to be observed by member States;
- (h) assist in organizing sub-regional trade information centres for the dissemination of trade information among member States;
- (i) arrange contacts and organize meetings for African businessmen concerned with intra-African trade and its various aspects; and
- (j) do all such other things as would enable the Association to achieve its objectives.

ARTICLE III

Membership

1. Membership of the Association shall be open to all African States which are members of the Organization of African Unity and the United Nations Economic Commission for Africa.

2. For the purposes of this Constitution, a member State shall designate from within its territory the organizations concerned with trade promotion from which it shall be represented. In designating such organizations, a member State shall take into account the desirability of designating as many organizations as possible so as to ensure the representation of the various organizations that are committed to the development of intra-African trade.

3. Membership of the Association shall be acquired in accordance with the provisions of Article XV of this Constitution.

ARTICLE IV

Obligations of member States

1. Member States shall co-operate in every way so as to assist the Association in achieving its objectives. They shall in particular:

- (a) facilitate the collection, exchange and dissemination of information;
- (b) submit all necessary reports and information to the competent organs of the Association;
- (c) make available training and research facilities on such terms and conditions as may from time to time be agreed with the appropriate organ of the Association;
- (d) make available personnel on such conditions as may be agreed with the appropriate organ of the Association; and
- (e) pay their annual contributions as assessed by the General Assembly and such special contributions as may be determined by the General Assembly.

ARTICLE V

Status, structure and organization of the Association

1. To enable it to achieve its purposes and to perform its functions, the Association shall in accordance with the laws of the country where its headquarters is established, seek and acquire legal capacity to acquire, hold, manage and dispose of land and other

property, enter into contracts, accept and make loans, grants, gifts and contributions, and to sue and be sued.

2. The organs of the Association shall be:
 - (a) the General Assembly and its Bureau;
 - (b) the Sub-regional Conferences;
 - (c) the Secretariat;
 - (d) the National Associations; and
 - (e) such other bodies as are established by the General Assembly and the Sub-regional Conferences.

ARTICLE VI

The General Assembly

1. The General Assembly shall consist of the representatives of all member States; provided however that each member State shall have only one vote at the meetings of the General Assembly.
2. The General Assembly shall meet once in two years in regular session and emergency sessions may be convened in accordance with rules made by the General Assembly.
3. The General Assembly shall elect from amongst its members, its President, two Vice-Presidents and a Rapporteur who shall also together from the Bureau of the General Assembly.
4. The General Assembly shall:
 - (a) determine the general policies of the Association;
 - (b) determine the contributions of member States in respect of the expenditure involved in the running of the affairs of the Association and its subsidiary bodies;
 - (c) consider and approve the annual reports on the activities of the Association and the accounts of the Association;
 - (d) consider and approve the draft programme of work and the draft budget of the Association;

- (e) determine the conditions of admission of associate members and observers of the Association; and
 - (f) consider and adopt rules and general directions governing the activities of the Association and its subsidiary bodies.
5. The General Assembly may establish such subsidiary organs that it deems necessary and may delegate any of its functions to an organ of the Association.
6. Subject to the provisions of this Constitution, the General Assembly shall prescribe its own rules of procedure including those for convening its meetings, the conduct of such meetings, and the quorum and voting thereat and for the dissemination of the report of its meetings.
7. The Bureau of the General Assembly shall under the direction of the President:
- (a) consider the annual reports on the activities of the Association and the accounts of the Association and submit them to the General Assembly for approval;
 - (b) consider the draft programme of work and the draft budget of the Association and submit them to the General Assembly for approval;
 - (c) consult with the Secretariat on actions that may be undertaken by the Association or its organs in furtherance of the objectives of the Association; and
 - (d) within the limits of the programme of work and the budget of the Association, review, direct and co-ordinate the activities of the organs of the Association.

ARTICLE VII

Sub-regional Conferences

1. A sub-regional Conference shall consist of the representatives of the member States within a sub-region of Africa as defined by the United Nations Economic Commission for Africa.

2. A sub-regional conference shall among other things :
- (a) oversee the implementation of the decisions and policies of the General Assembly concerning its sub-region;
 - (b) be responsible for the obtaining and dissemination of commercial intelligence concerning the trade of the member States of its sub-region;
 - (c) take decisions on matters concerning its sub-region and members States of its sub-region which are not inconsistent with the decisions and policies of the General Assembly;
 - (d) establish such subsidiary bodies as it deems necessary for the carrying out of its functions; and
 - (e) have such other functions and responsibilities as may be determined or delegated to it by the General Assembly.
3. A sub-regional conference shall elect its officers and prescribe its own rules of procedure; provided however that each member State of a Sub-regional Conference shall have only one vote at a meeting of a Sub-regional Conference.

ARTICLE VIII

The Secretariat

1. The General Assembly may establish a Secretariat of the Association and prescribe its functions. Until such a Secretariat is established, the Africa Trade Centre of the United Nations Economic Commission for Africa and the Secretariat of the Organization of African Unity shall jointly constitute the Secretariat of the Association.
2. The Secretariat of the Association, when established, shall have such other functions and responsibilities as the Bureau of the General Assembly may determine.

ARTICLE IX

National associations

1. A national association shall be organized on a broad basis in each member State and shall be the organ of the Association through

which the services and other activities of the Association relating to the member State shall be considered, channelled and co-ordinated.

2. A national association shall also act as the centre for information about the activities of the Association in a member State and shall have such other functions as the General Assembly may determine.

ARTICLE X

Amendments

1. This Constitution may be amended by a two-thirds majority at a meeting of the General Assembly. Member States who are not represented at such a meeting may signify their votes in writing or by proxy; provided however that this Constitution may not be amended unless a written notice of a proposed amendment shall have first been given to all the member States at least three months before the meeting of the General Assembly at which such a proposed amendment is to be considered.

ARTICLE XI

Deposit and Signature

1. This Constitution of which both the English and French texts are equally authentic shall be deposited in two original copies one with the Administrative Secretary-General of the Organization of African Unity and one with the Executive Secretary of the United Nations Economic Commission for Africa.

2. The original copies of this Constitution in both the English and French texts shall remain open until 31 August 1973 for signature on behalf of the Governments of the African States referred to in Article III of this Constitution.

3. The Depositaries shall jointly transmit certified copies of this Constitution to all member States.

ARTICLE XII

Suspension, withdrawal, and cessation of membership

1. Any member State which persistently fails to fulfil any of its obligations under this Constitution may be suspended from membership of the Association by the General Assembly on such terms as the General Assembly may determine.

2. Any member State may withdraw from the Association after the expiration of one year from the date on which it acquired membership of the Association by giving a written notice of its withdrawal to the President of the General Assembly who shall forthwith inform all members of the Association and the Secretariat of the receipt of such notice of withdrawal and shall transmit the originals of such notice of withdrawal to the Depositaries.

3. Withdrawal from the Association shall become effective one year from the date of receipt by the President of the General Assembly of a notice of withdrawal. Provided that during the period of such one year a member State withdrawing from the Association shall nevertheless remain liable for the discharge of its obligations incurred under the provisions of this Constitution.

4. Any member State which fails to fulfil its obligations incurred under the provisions of Article IV of this Constitution within two years from the time when such obligations should have been fulfilled, shall ipso facto cease to be a member State at the end of such two years.

ARTICLE XIII

Dissolution of the Association

1. The Association may be dissolved by a resolution to that effect carried by a two-thirds majority at a meeting of the General Assembly.
2. The General Assembly shall appoint a Committee for the purpose of liquidating the assets of the Association.

ARTICLE XIV

Arbitration

1. Any dispute arising between member States concerning the provisions of this Constitution shall be settled in accordance with this Article.

2. Any trade dispute arising between persons one of whom has his registered place of business in the territory of any of the member States may by agreement between such persons be settled in accordance with this Article. Provided that such a dispute must first have been referred to the Association by the National Association of the member State in which a party to the dispute has his registered place of business.

3. Where any matter is submitted for settlement under the provisions of paragraphs 1 and 2 of this Article each party to a dispute shall nominate one person to serve on a Board of Arbitration and the two so nominated shall nominate a third person to act as Chairman of the Board of Arbitration and in the case of disagreement on the nomination of such third person, he shall be selected by the President of the General Assembly from a Panel of Arbitration established by the General Assembly.

ARTICLE XV

Final provisions

1. This Constitution shall enter into force upon twelve of the signature on behalf of Governments of African States referred to in Article III of this Constitution.

2. After entry into force of this Constitution any of the African States referred to in Article III of this Constitution may accede to this Constitution upon conditions that shall be determined by the General Assembly.

RESOLUTION
ON THE ASSOCIATION OF AFRICAN TRADE
PROMOTION ORGANIZATIONS

The Council of Ministers of the Organization of African Unity meeting in its Twenty-Fifth Ordinary Session in Kampala, Uganda, from 18 to 25 July 1975,

Recalling:

- a) Resolution "CM/Res.310(XXI)" of the Council of Ministers of the OAU adopted at its Twenty-First Session, which endorsed the principle of establishing the Association of African Trade Promotion Organizations, and which urged member States to adopt and sign the Constitution of the Association;
- b) Resolution on the Association of African Trade Promotion Organizations, adopted by the Conference of Ministers of the ECA, meeting in Accra (19 - 23 February 1973),

Noting with satisfaction the progress achieved regarding the establishment of the Association on African Trade Promotion Organizations,

Convinced of the important role that the Association can play in the promotion and harmonization of international African trade and intra-African trade,

Noting that only seventeen member States have signed the Constitution of the Association, of whom two only have deposited their instruments of ratification,

Congratulate the Association of African Trade Promotion Organizations for its establishment, and endorses its decisions adopted during its first meeting held in Tangier (Morocco) from 31 March to 4 April 1975,

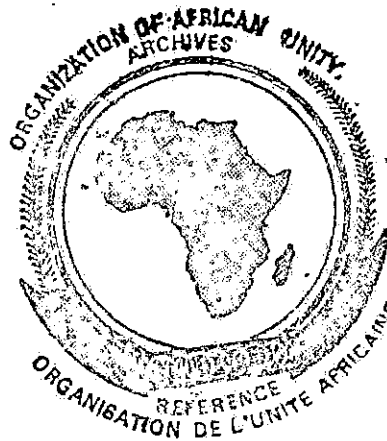
