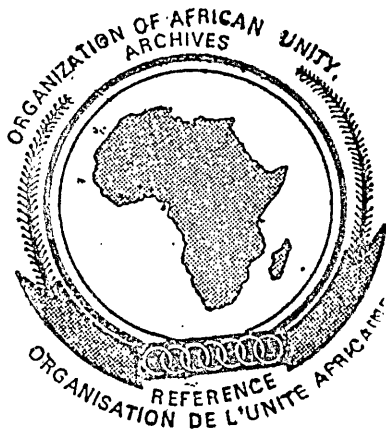

ON CANDIDATURES TO INTERNATIONAL ORGANIZATIONS

As customary, every year, at the beginning of January 1977, the OAU Executive Secretariat distributed to Members of the African Group a document on the position of the African States in the various UN bodies during 1976/1977 and a list of the vacancies due to occur during the year 1977 in the UN Organs.

On February 9, 1977, the OAU Executive Secretariat received from the African Member States the following candidatures attached herewith.

According to its programme of work, the Committee on Candidatures of the African Group set the date of 31 March 1977 as last opportunity for the nomination of candidatures. In April 1977, the Committee on Candidatures will meet to study the candidatures received and will make its recommendations to the African Group. Once, these are accepted they would be submitted to the Council of Ministers for final decision.

It is to be recalled that the Committee on Candidatures had its mandate renewed for two years from 1st. of January 1977 and included the following countries:
