The need for literacy, specialized staff training as well as that of training educated citizens of the independent States, has made many a people to believe in adult education.

The idea of establishing an association emerged from a conference on adult education held in Tanzania in 1964.

The first objective was to establish an association for education of adults in East Africa and Central Africa. The Adult Education Association for Central and East Africa was quickly established to publish a magazine and organize conferences and workshops. Very soon, foreigners in this geographical region started being interested in these activities. Educationists from seven countries therefore participated in the Conference held in Uganda in 1968. The Association thereby grew beyond its initial boarders by extending membership to States from other geographical regions. The African Adult Education Association was thus formed.

The Association which originated from anglophone Africa is now trying to make a great number of non-anglophone countries interested in its activities. Its membership includes representatives from Zaire, Cameroon, Ivory-Coast and Madagascar. It is seeking a closer cooperation with Mozambique, Angola, Guinea-Bissau and Arab speaking Africa.

CRITERIA FOR GRANTING OBSERVER STATUS WITH THE CAU

At its 14th Session, the Assembly of Heads of State and Government approved the following criteria for granting observer Status with the OAU:

- a) Any organization applying for Observer Status with the OAU will show its genuiness; its credibility; its pan-Africanism; the impossibility of its being influenced by forces external and inimical to Africa. If it is a professional Organization, it should include all various disciplines of wider profession. For instance an Association of Engineers should include all Organizations of various disciplines of engineering, civil and mechanical, for the whole Africa. Any organization seeking Observer Status with the OAU should therefore:
 - Have its objectives and activities conform with the fundamental principles and objectives set forth 'n the Charter of the OAU;
 - 2. Be an African Organization, registered in Africa with its headquarters in Africa, Membership would be African, excluding South Africa, Rhodesia and South West Africa, while minoroty Racist Governments are still in power in these places. Membership external to Africa should not have voting rights;
 - 3. Have sound financial basis. Sources of finance should be African. Donors external to Africa are to be clearly disclosed.
 - 4. To the above end, the Organization should be required to submit:
 - a) a written application and the following documents to the General Secretariat indicating its intention, at least

six months before, it can be considered by the Council of Ministers, in order to allow for sufficient time for processing the application;

- b) Its Constitution or Charter, its list of up-to-date membership, sources of its finance, including copies of its most
 recent balance sheet, and Memorandum of activities, all
 in the main languages of the AU in sufficient quantity to
 facilitate circulation to Member States;
 - c) if a non-governmental organization, the particulars of at least five Member States of the OAU, who have intimate knowledge of the Organization, and who are prepared to sponsor it. One of those States should be that where the Organization has its registered headquarters.
- 3. No application for Observer Status shall be submitted for consideration of the Council of Ministers, unless it has been fully processed by the General Secretariat.
- 4. The Memorandum of Activities should contain the past and present activities of the Organization, its connections, including any connections external to Africa, and any other information, which will assist in determining the identity of the Organization, especially its scope of activities (Ref. CM/784 (XXVIII).
- 5. The Assembly also stipulated that:

The granting of Observer Status to an organization entails no obligation on the Organization of African Unity to grant subsidy to that organization. The granting of subsidy to any organization can be envisaged only in certain cases, in exceptional and urgent circumstances, when such subsidy represents a temporary and vital addition to the budget of the organization enjoying observer status.

PART II. OBSERVER PART CIPATION IN THE PROCEEDINGS OF THE OAU

- 6. a) All observers may be invited to be present in the public galleries for the inaugural and closing meetings of all OAU Conferences:
 - b) An observer at a meeting of OAU institution may participate in the proceedings of that institution only in accordance with the conditions laid down in Part II under.
- 7. Observer may have access to AOU documents provided that they are:
 - a) Not of a confidential nature;

b) Once not dealing with matters of interest to the observers concerned.

Distribution of CAU documents shall be against payment in those cases where there is no reciprocity.

- 8. Observers may be expressly invited to attend private meetings during discussion of a subject in which they are concerned.
- 9. With the express authorization of the Chairman, observers may participate in the proceedings of meetings to which they are invited. Although they may participate in the proceedings, observers shall not have the right to vote.
- 10. Observers may be authorized by the Chairman of the Conference to make a statement on a mtter on which they are concerned, subject to the text of the statement being communicated before hand to the Conference Chairman, through the medium of the Secretary-General.
- 11. The Conference Chairman may give the floor to observers .
 in order to enable them to reply to questions which might be addressed to them by Member States.

PART III. SPECIAL PROVISIONS DEALING WITH PARTICIPATION OF OBSERVERS IN THE WORK OF QAU SPECIALIZED COMMISSIONS

- 12. Observer Status shall be granted under the following categories:
 - A. Category A shall include:
 - i. Governments in exile and the liberation movements of African territories under colonial domination recognized by the OAU;
 - ii. African inter-governmental organizations which have important interest in most of the activities of OAU Member States and which comprises a large number of OAU Member States.
 - B. Category A Observers may:
 - i) Attend all public sessions;
 - ii) Request the inclusion of certain items falling within their exclusive competence in the draft agenda.
 - iii) Make a written or oral statement on a matter of special interest to them in the provisional agenda;
- 13. A. Category B shall cover African inter-governmental organizations having a specialized competence, and having an interest in substantial activities of the OAU.

B. Category B. observers may:

- i) Attend all public sessions;
- ii) Make a written or an oral statement to the Specialized Commission on a matter of special interest to them, subject to the approval of the Chairman of the session;
 - iii) Reply to questions which the Commission, or Member States, might address to them.

14. A. Category C shall include:

- i) Inter-African non-governmental organizations, associateons or unions;
- ii) Inter-African non-governmental institutions;

B. Category C Observers May:

- i) Attend the public sessions of the OAU Specialized
 Commissions during discussion of a matter concerning them;
- ii) Communicate a written declatation to the Commission through the medium of the Administrative Secretary-General, and after approval by the Chairman of the session.

PART IV: FINAL PROVISIONS

- 15. The provisions of the General Convention on Privileges and immunities, and those relating to the Headquarters Agreement of the OAU, shall not be applicable to observers, save for those regarding facilities provided for the granting of visas.
 - 16. Observers shall themselves be responsible for expenses incurred as a result of their travel to and from, and their stay at the venue of the Conference.
 - 17. These Rules may cease to apply to any institution enjoying the advantages of observer status should the Council of Ministers consider that this institution has ceased to satisfy the requirements laid down in these criteria.

ARTICLE I - NAME

The name of the Association shall be the African Adult Education Association - hereinafter referred to as the Association.

ARTICLE II - AIMS AND OBJECTIVES

The objects for which the Association is established are:

- a) The promotion of Adult Education in all forms in Africa and particularly by encouraging the formation of national adult education associations in member countries;
- b) To arrange objective study of and research into the problems of adult education in contemporary Africa by all appropriate means including conferences, seminars, study-groups and exhibition;
- c) To act as a clearing-house for information on all forms of adult education relating to Africa;
- d) To publish reports of the educational activities and special studies of the Association and similar bodies;
- e) To publish and encourage the publication or production of books, journals, pamphlets, visual and other material contributing to the purposes of the Association;

- The harman and the f) To institute, confer and award fellowships, scholarships, bursaries, medals and prizes y and other distinctions and awards;
 - g) To encourage affiliated national associations to arrange conferences, study-courses, lectures, Testudy-groups, seminars, classes and exhibitions on subjects affecting the citizen; The second of the second of
- h) To co-operate with any society, association or body, as well private as public, in any matters which will be conductive to the attainment of the Association's objects.
- i). National adult education associations, who may
 - ii) Institutions concerned with adult education in Africa, as well as societies and bodies of national, international and regional character, who may become institutional members;
 - education,
 - Any member who shall fail in observance of the rules HOLD TALL STATE of the Association may be excluded by a resolution of the Executive Committee with a majority of at least three-fourths of the members present and voting. Any member so excluded shall have the right of appeal to the General Meeting, voting in accordance with Article V, Section 8;

Any member wishing to terminate his membership shall do so in writing to the Secretary. Any member who allows his subscription to lapse by 6 months from the renewal date shall be deemed to have terminated his membership.

ARTICLE IV - FINANCE AND AUDIT

- a) The fiscal year of the Association shall be from January 1st to December 31st;
- b) Subscriptions shall be paid in accordance with the rates to be determined by the General Meeting of the Association from time to time. Auditors shall be appointed by the General Meeting to make an annual examination of the accounts and report to the following General Meeting, or, if none, to the Executive Committee who shall circulate a balance sheet to members;
- d) The officers of the Association shall, acting as a Committee, if necessary working by circulation of papers, be empowered to seek funds from African and other sources for the fulfilment of the purposes of the Association;
- e) The income and property of the Association shall be applied solely towards the promotion of the objects of the Association, provided that nothing herein shall prevent the payment, in good faith, of reasonable and proper remuneration to any officer or servant of the Association nor the gratuitous distribution among, or sale at a discount to, subscribers to the funds of the Association of any books or other publications, whether published by the Association or otherwise, relating to all or any of its objects as above set forth.

ARTICLE V - OFFICERS AND ORGANIZATION

SECTION 1 - PATRONS

The Association may, through its Executive Committee, honour itself and confer honour on certain persons by inviting them to become its patrons or by showing them such other marks of acknowledgment as may be deemed appropriate.

SECTION 2 - OFFICERS

The officers of the Association shall be a Chairman, a Deputy Chairman, a Secretary, a Treasurer, who shall have the power to appoint a Conference Secretary, if they so wish. Mid-term vacancies may be filled by the Executive.

SECTION 3 - EXECUTIVE COMMITTEE

- a) There shall be an Executive Committee, consisting of the officers, with the Journal Editor and the conference officers ex-officio and not less than three nor more than six additional members, together with the Chairman of all committees.

 The Executive Committee may co-opt up to six people;
- b) Between meetings of the Association, the Executive Committee shall exercise the powers of the Association, except that it may not amend the Constitution;
- c) The Executive Committee shall appoint a Journal Editor, who shall hold office during the Executive Committee's pleasure;
- d) The Executive Committee may appoint, remunerate, suspend and dismiss employees of the Association;

THE RESERVE OF THE PARTY OF THE

- e) One-third of the members shall constitute a quorum.
 - f) The Chairman, or his deputy or any pro tempore presiding officer, shall have a casting vote in the event of an equality of votes;
- g) The Executive Committee may make, alter or revoke rules and regulations for the Association, subject . to ratification by the General Meeting.

SECTION 4 - NATIONAL ASSOCIATIONS

- 100 mg 2 mg a) The Association's General Meeting shall ratify approval given by the Executive to the affiliation of National Associations. Nothing in this section shall preclude the recognition for affiliation of appropriate existing societies or groups as national associations.
 - b) Each affiliated national association shall elect its own officers and committee or committees and adopt, subject to approval by the Association Executive Committee, its own constitution and regulations. .

SECTION 5 - ASSOCIATION REPRESENTATIVES

Representatives may be appointed by the Association Executive where no national association exists.

SECTION 6 - ELECTIONS

A B Table 1

a) All officers and Committee members, except the Journal Editor, shall be elected; and the election of officers and Committee members shall be performed at the General Meetings of the Association by secret ballot and simple majority.

b) Officers shall take office at the end of the General Meeting at which their successors are elected.

Officers shall be eligible for re-election, save that the Chairmanship may not be held for two consecutive terms of office.

SECTION 7 - MEETINGS

- a) The Association shall hold a General Meeting at least once in every two consecutive calendar years.
- b) Extraordinary meetings may be convened by the Executive Committee in its discretion, but shall be called on the requisition of at least three national associations.
- c) At least sixty days' notice, in writing shall be given in advance of the meeting.
- d) If the Committee does not proceed to cause a meeting to be held within sixty days from the date of the requisition, the requisitioners, or a majority of them, may themselves convene a meeting.
- e) A quorum shall be note less than forty members coming from not less than five different African countries, provided that not more than fifteen members from any one country count towards the quorum.
- f) Voting in Association General Meeting on all matters shall be on the basis of one vote for each individual member present, three votes for each institutional member represented and five votes for each affiliated association represented.

An institutional member may authorise such person or persons as it thinks fit to act as its representative(s) at any meeting of the Association; and the person or persons so authorised shall be entitled to exercise the same powers as individual members, save that they shall vote in accordance with the provisions of sub-section(f) of this Section.

ARTICLE VI -- COMMITTEES

- a) Dissolution may be decided at a General Meeting subject to similar provisions as for amendments (Article VIII).
- b) Where no General Meeting is held for three consecutive years, the Association shall be deemed dissolved and the Treasurer or his personal representative shall pass any outstanding funds to trustees appointed under section (c) of this Article.
- If upon dissolution of the Association there remains, c) after the satisfaction of all debts and liabilities. any property whatsoever, the same shall not be given or transferred to or distributed amongst the members of the Association, but shall be given or transferred to some other Institution having similar objects and which also prohibits the distribution of its assets among its members. The appropriate regional UNESCO officers may be asked to act as Trustees or to invite not less than three University Vice-Chancellors of Universities which are or have been (but not excluded in accordance with Article III (b) members of the Association, to act as Trustees in this matter. In the event of this provision being deemed impossible or impracticable, then the outstanding property shall be developed upon some charitable object of an educational or social nature within Africa.

ARTICLE VII - AMENDMENTS

The Constitution may be amended by any General Meeting of the Association, subject only to the following:

- a) Sixty days' clear notice of such intention was given in writing to all members;
- b) A quorum is present;
- c) A two-thirds majority of those voting is obtained.

ARTICLE VIII - INTERPRETATION

In the event of a dispute on the interpretation, the General Meeting's ruling is final, the vote being taken in accordance with Article V.

ARTICLE IX - REVOCATION

All former constitutions are hereby revoked.

THE AFRICAN ADULT EDUCATION ASSOCIATION

Adult education has long been recognized as important on this continent. In modern times, the demand for literacy, the need for training skilled men and women and the need also to fashion educated citizens of independent states have strengthened many people's belief in adult education.

The Association starts from this belief and exists to foster adult education and to act as a channel of communication between all interested in the subject.

Before an African-wide body came into existence, there were pioneer local and national organizations interested in adult education (one early national body was the People's Educational Association in Ghana, another was the Swaziland Sebenta). There were also occasional conferences bringing adult educators together (e.g. in Ghana in 1954); but the idea of an association came from a conference on residential adult education held at Kivukoni College, Tanzania in 1964.

The original proposal was for an adult education association of East and Central Africa and this came into existence at a meeting on adult education and the mass media, held at the Evelyn Home College of Further Education in Zambia in 1965. The Adult Education Association of East and Central Africa quickly established itself, issuing a newsletter and holding further conferences and workshops. Very soon, interest in its activities began to be expressed by persons outside its geographical area and at its 1968 conference held in Makerere University College, Kampala, Uganda, there were adult educators present from seven different African countries, including the Sudan and Ghana.

As a result, it was decided, after serious discussions and some hesitation, to cast the net wider and change the Organization's name to its present one - African Adult Education Association.

Permanent Secretariat

In September 1973, during the Association's 4th biannual conference, members voted to found a permanent home for
the Association in Nairobi, Kenya. On January 2nd 1977, our
first full-time officer started working for the Association. A
second officer is expected to arrive in Nairobi any time now.
It is hoped that the permanent secretariat will also act as
the regional bureau for the International Council for Adult
Education (ICAE),

The Association new boasts of support from seven national associations, at least 30 national institutions, and some 300 individual members, found mainly in Africa, but also in many other parts of the world. It also has received constant support from many international organizations and agencies. It holds category C status at UNESCO, is an affiliated and founder member of the International Council for Adult Education (ICAE), and has consultative status with many other organizations concerned with adult education throughout the world. We have good working relations with UN/ECA.

Although the origins of the Association are in the English-speaking Africa, efforts to encourage French-speaking Africa to enroll as members still continue. At present we have as members representatives from Zaire, Cameroon, Ivory Coast and Madagascar. We are also seeking close co-operation with the Arab-speaking Africa and also with our brothers in Mozambique, Angola and Guinea-Bissau. We have also applied for observer-status at the OAU.

In order to keep members in touch, the Association issues an occasional Newsletter. Distribution is free to members and other interested parties. From now on, copies will be available in both English and French.

The Journal of African Adult Education, which had temporarily ceased publication, will soon reappear.

on adult education in Africa and has exerted a lot of effort towards giving greater publicity to adult education activities.

Apart from being represented at many important meetings of international nature, the Association has issued and distributed press releases on important issues of adult education to some 70 journals and newspapers.

It has kept in touch with adult education activities in other parts of the world through UNESCO, ICAE and through the Asian and South Pacific Bureau of Adult Education (ASPBAE) and the Latin American Adult Education Federation (FIDEA).

Future Plans

Harty Years - or a fail a mail

The Association intends to continue with its existing role but hopes to strengthen its work in several ways. For a long time the activities of the Association have been financed by members and little outside funding has been sought. However, some funds are now available to run the permanent secretariat for the first two years. The Association will endeavour to secure more funds from within and outside Africa and all members are urged to help in this effort by making sure that their contributions are regular and also by urging their institutions and governments to make regular donations to AAEA. It is expected that institutions will continue to help their staff attend various AAEA meetings and conferences, as they have so generously done in the past.

Occasional publications, including a book of readings on African Adult Education, will be forthcoming. Small workshop-conferences for adult education in a group of neighbouring countries and exchange programmes and study visits, as well as our regular bi-annual conferences, will continue to be arranged. Reports on all these will be issued in both English and French.

AAEA will encourage translation of these into Portuguese and Arabic. In the past AAEA has co-sponsored (with UNESCO) an international seminar on Competative Structures of Adult Education (Nairobi, February 1975) and Adult Education for Manpower Development (with UN/ECA) in Addis Ababa (September 1973). It is hoped that in November 1977, AAEA will be co-sperating with ICAE, WHO and International Development Research Centre in sponsoring a regional seminar on Health Education at Lusaka, Zambia.

AAEA believes that its major contribution to adult education in Africa is its encouragement of the formation of national adult education associations in various member states. At present such associations exist in Tanzania, Zambia, Kenya, Nigeria, Ghana, Sudan and Zaire. Special efforts will continue to be made to have similar associations in French-speaking Africa, Portuguese-speaking Africa, Arab-speaking Africa and of course in the rest of Anglophone Africa. AAEA can grow only if strong national associations, with mass support of its people, exist.

As mentioned elsewhere, application for "observer status" at the OAU has been made. It is the hope of the Association that this link will be of value not only as an appropriate channel for contacting African governments but also as a means of getting in touch with other sister organizations supported by OAU.

The Association is an important and essentially modern organization. It could not exist without the aeroplane, the telephone and the transistor radio. But the value of working together in education was known in tradificant times. One of AAEA guidelines could be an old African Proverb:

"Wisdom is like a baobab tree; one man's arms can never go round it."
