**REPORT OF THE COMMISSION ON THE IMPLEMENTATION OF THE JULY
2008 ASSEMBLY DECLARATION ASSEMBLY/AU/DECL. 1 (XI) ON THE
SHARM EL SHEIKH COMMITMENTS FOR ACCELERATING THE
ACHIEVEMENT OF WATER AND SANITATION GOALS
IN AFRICA**

Report of the Commission on the Implementation of the July 2008 Assembly Declaration Assembly/AU/Decl. 1 (xi) on the Sharm El Sheikh Commitments for Accelerating the Achievement of Water and Sanitation Goals in Africa

1. Introduction

- 1.1. The Decision of the African Union (AU) Assembly in Sharm El Sheik in July 2008 [Assembly/AU/ Decl.1 (XI)] reaffirmed Africa's commitment to the achievement of the water and sanitation goals enshrined in, among others, the Africa Water Vision 2025; the 2004 Sirte Declaration on integrated development of Agriculture and Water in Africa [Ex/Assembly/AU/Decl. 1(II)]; and the Millennium Development Goals. The African Ministers' Council on Water (AMCOW) was also delegated to annually report to the AU Assembly on the progress made in the implementation of the commitments of the Heads of State and Government on water and sanitation.
- 1.2. The African Union Commission (AUC), in collaboration with AMCOW, has been engaged for the last two years, in mobilizing the key stakeholders and development partners to strengthen the partnership with AU Member States and the Regional Economic Communities (RECs) for establishing a mechanism for regular monitoring, evaluation and reporting on progress in implementing the commitments on water and sanitation, to the African Union Assembly.
- 1.3. This report is the product of those efforts. It has been prepared through extensive consultations with Member States, as well as capacity building to designated focal points from the Member States. In addition, the report preparation process has focused on promoting national ownership of the reporting mechanism.
- 1.4. AMCOW Member States have then adopted a Reporting Format for use to prepare the water and sanitation report on progress made in implementing the Sharm El Sheikh Commitments for accelerating water and sanitation goals in Africa. The Reporting Format is framed under the 7 themes defined for the water and sanitation sector development in Africa, that include:

Theme 1- Water Infrastructure for Economic Growth;
Theme 2- Managing and Protecting Water Resources;
Theme 3- Achieving Water supply and Sanitation MDGs;
Theme 4- Global Changes and Risks Management in Africa;
Theme 5- Water Governance and Management;
Theme 6- Financing Water and Sanitation Sector;
Theme 7- Education, Knowledge, Capacity Development and Water Information.
- 1.5. In the Report performance categories have been defined for the 7 themes to evaluate country performance in achieving water sector goals in Africa.

2. The 2011 Report preparation Process

- 2.1. Focal persons from all Member States have been trained on the use of the reporting format (except Cape Verde, Comoros, Eritrea, Mauritius, Saharawi Arab Democratic Republic, Seychelles, Somalia and Swaziland which did not avail focal persons on time). They agreed on a continental roadmap and activities to be implemented at national level with a deadline set for September 15, 2012 to avail the country report. This deadline has been extended several times with the latest at June 30th, 2013 to allow more country reports submission.
- 2.2. Forty-two (42) Member States were able to carry out self-assessments and provide their respective Progress Reports. They include: Algeria, Angola, Benin, Botswana, Burkina Faso, Burundi, Cameroon, Central African Republic, Chad, Congo, Côte d'Ivoire, Democratic Republic of Congo, Egypt, Equatorial Guinea, Ethiopia, Gabon, Gambia, Ghana, Guinea, Kenya, Lesotho, Liberia, Libya, Madagascar, Malawi, Mali, Mauritania, Mozambique, Niger, Nigeria, Rwanda, São Tomé and Príncipe, Senegal, Sierra Leone, South Africa, South Sudan, Sudan, Swaziland, Tanzania, Togo, Tunisia, and Uganda.
- 2.3. Countries have submitted on average 62% of the information required in the reporting Format. A key challenge for most of the countries that provided information is the lack of baseline data which in turn made it difficult to estimate the progress achieved by the countries vis-à-vis the agreed targets.
- 2.4. Whereas the information gathered is not exhaustive as regards the status of progress in implementing the Sharm El Sheikh Commitments on water and sanitation, the report preparation process has provided a wealth of vital information on the capacity challenges to be addressed as part of process to establish a functional African Water and Sanitation Monitoring, Evaluation and Reporting System.

3. Main findings of the Report

- 3.1. Member States are investing a great deal of effort into the achievement of the water and sanitation goals for Africa as espoused by the Africa Water Vision 2025, the Sharm el-Sheikh Declaration and the Millennium Development Goals (MDGs).
- 3.2. The rate of progress, though commendable for most Member States, may not be sufficient to achieve the targets set. As example, Africa has progressed from 56% of water supply coverage in 1990, to 61% in 2011, and has therefore reduced the percentage of population without access to water supply by 11%, while the target is set at 50% for the MDGs by 2015.
- 3.3. Using benchmarking methods, performance benchmarks for attaining the relevant targets for achieving water sector goals for Africa, have been set for each theme. The outcomes of each theme are the following:

- **For Theme 1: *Water Infrastructure for Economic Growth in Africa***
 The 2011 benchmark have been set at 7.3 out of 10.
 Algeria (10); Kenya (7.5); Madagascar (7.7), Mali (7.4); and Senegal (7.5) **are on track**.
- **For Theme 2: *Managing and Protecting Water Resources in Africa***
 The 2011 benchmark have been set at 5.2 out of 10.
 Kenya (10); Sudan (7.0); and Tunisia (5.9) **are on track**.
- **For Theme 3: *Achieving Water supply and Sanitation MDGs for Africa***
 The 2011 benchmark have been set at 8.4 out of 10.
 Algeria (10); Gabon (10); Libya (10); Rwanda (10); South Africa (10); Swaziland (9.5); and Tunisia (10) **are on track**.
- **For Theme 4: *Global Changes and Risks Management in Africa***
 The 2011 benchmark have been set at 6.0 out of 10.
 Algeria (10); Angola (9.5); Benin(8.5); Cameroon (9.0); Egypt (9.0); Gabon (10);
 Gambia(7.0); Ghana (10); Kenya (10); Liberia (10)Madagascar (8.0); Mali (6.0);
 Mauritania (10); Mozambique (7.0); Niger (7.5); Nigeria (10); Senegal (8.5); South
 Africa (9.0); Sudan (7.0), Swaziland (10); Togo (8.5); and Tunisia (10) **are on track**.
- **For Theme 5: *Water Governance and Management in Africa***
 The 2011 benchmark have been set at 6.0 out of 10.
 Angola (10); Benin (10); Burkina Faso (10); Burundi (6.8); Cameroon (6.0);
 Central African Republic (7.6); Chad (8.4); Congo (9.2); Côte d'Ivoire (7.6); Egypt
 (10); Gambia (6.0); Ghana (10); Kenya (10); Lesotho (8.4); Liberia (10);
 Madagascar (10); Malawi (10); Mali (10); Mauritania (8.4); Mozambique (6.0);
 Niger (6.8); Nigeria (10); Senegal (6.0); South Africa (10); South Sudan (10);
 Swaziland (10); Tanzania (10); Togo (10); Tunisia (10); and Uganda (10) **are on track**.
- **For Theme 6: *Financing Water and Sanitation Sector in Africa***
 The 2011 benchmark have been set at 8.7 out of 10.
 Kenya (10); Lesotho (10) Libya (10); and South Africa (10) **are on track**.
- **For Theme 7: *Education, Knowledge, Capacity Development and Water Information in Africa.***
 The 2011 benchmark have been set at 4.0 out of 10.
 Algeria (10); Angola (4.0); Benin (4.0); Burkina Faso (4.0); Burundi (4.0);
 Cameroon (4.0); DR Congo (4.0); Egypt (4.0); Kenya (10); Libya (10);
 Madagascar (10); Mauritania (4.0) Mozambique (10); Niger (4.0); Nigeria (10);
 Senegal (4.0); South Africa (4.0); South Sudan (10); Tanzania (10); Tunisia (6);
 and Uganda (10) **are on track**.
- **For the overall benchmark of 6.51 for 2011, for achieving Sharm El Sheikh Commitments for accelerating water and sanitation goals in Africa,**

Kenya (9.29); Algeria (8.17); Tunisia (7.88); South Africa (7.28); Madagascar (7.73) and Uganda (6.51) are the only Member States that are on track.

- 3.4. National Water Policies are a fundamental requirement for the creation of an enabling environment for the implementation of the necessary national level interventions to achieve the commitments. In response to commitment (d)¹ of the Sharm El Sheikh declaration, it has been observed that some of the Member States are yet to develop and operationalize national water policies.
- 3.5. Investment in the sector has also been crucial to implement necessary actions to improve performance. With regards to the national budget allocation to water, sanitation and hygiene, information received indicates that public investment in these sectors remains low for most countries. Overall, implementation of both the 2008 eThekweni ministerial declaration of allocating 0.5% of GDP to sanitation and hygiene; and the 2003 PANAFCON ministerial declaration to allocate 5% of national budgets to water and sanitation, is yet to be universally initiated. So far only Algeria, Cote d'Ivoire, Kenya, Lesotho, Libya, Mali, Mozambique, Niger Sierra Leone, South Africa, Swaziland, and Tanzania have implemented the 2008 eThekweni declaration, and only Kenya, Lesotho, Libya, and South Africa have implemented the 2003 PANAFCON declaration.
- 3.6. Efforts to improve basic sanitation in Africa are so far inadequate. Poor sanitary conditions remain a major hazard to the health and productivity of the African population. Among the countries that provided information, only Algeria, Gabon, Kenya, Libya, Rwanda, South Africa, Swaziland, and Tunisia are getting ahead in raising the profile of sanitation in accordance with commitment (b)² of the Sharm El Sheikh declaration. The other countries have indicated facing considerable challenges to get on track to achieve the MDGs on sanitation targets which are even lower than the Africa Water Vision target on sanitation. In this report, Rwanda has already reduced by 77% and Tunisia by 80% the proportion of population without improved sanitation facility in 1990, and are the only countries that have met the Africa Water Vision target of reducing by 70%.
- 3.7. An analysis of the information provided indicates that whereas Member States have put in place various instruments and mechanisms to finance activities in the Water and Sanitation sector, public and private investment, particularly to water resources management; and improving hygiene and sanitation, are insufficient to fully unleash the productivity of such sectors as agriculture, industry and fisheries and – therefore – release Africa's development potential.
- 3.8. Most Member States could not provide information on progress made on rainwater harvesting and utilization due to a universally reported lack of the necessary

information systems to monitor rainwater use. The development of infrastructure for rainwater harvesting and use is necessary to augment supply and improve overall sector demand satisfaction, as well as contributing to flood control measures. The issue is still not getting enough attention on the continent.

- 3.9. Challenges of inadequate capacity to provide information on all the performance categories defined for the water sector in Africa; and on all indicators defined for the Sharm El Sheikh Commitments were clearly evident in this reporting cycle.

4. Conclusion and key recommendations

First). In order to provide the AU Assembly with the full picture of progress in the implementation of the Sharm El-Sheikh commitments, it is recommended that the Member States listed below fully participate in the next rounds of the reporting exercise, these are: Cape Verde, Comoros, Djibouti, Eritrea, Guinea-Bissau, Mauritius, Namibia, Republic Arab Saharawi Democratic, Seychelles, Somalia, Zambia and Zimbabwe.

Second). Intensive advocacy activities are required to push for enough budgetary allocations and promote increased public investment in water, sanitation and hygiene in response to pressing African needs. The opportunity cost and impact on the productivity of the peoples of Africa as a consequence of very low access to safe water, and poor sanitation and hygiene in Africa is profound and poses a major threat to the Africa Water Vision 2025 of *“Equitable and Sustainable Use of Water for Socio-economic Development”* Specifically, there is a strong need to raise the profile of sanitation on the continent.

The Commission of the African Union working with AMCOW and in collaboration with other relevant partners is therefore requested to take further actions, to assist Member States in promoting large scale infrastructures development for sustainable sanitation in Africa, in order to improve living conditions of hundreds of millions of Africans.

Third). Sector institutions and development partners are requested to enhance, but more importantly, to streamline collaboration in the continent to avoid duplication of actions and focus more actions on the ground for the effective development of the African Water Sector. It is thus recommended to fast-track implementation of commitment (p)³ of the Sharm El-Sheikh declaration on accelerating achievement of water and sanitation to establish and strengthen AMCOW presence at the Regional Economic Communities levels, as well as cooperation with sector institutions and development partners for joint and aligned actions in achieving African Water sector goals.

- Fourth). Efforts should be made to resolve all bottlenecks hindering an accelerated use of available funds for the sector at the African Development Bank, and to strengthen the funding base of the African Water Facility to support member states especially fragile and poor performing countries in filling the gap for improving their water sector performance.
- Fifth). It is recommended that the year 2015 to be declared a “**Blank Year of Water and Sanitation Events in Africa**” where the planned budgets for water sector events in the continent should be collected from all partners to fund direct action interventions at community level for water development, utilization and management, as well as improvement of hygiene and sanitation conditions. Construction needs will be identified and assessed with partners by mid-2014. The target of **a minimum of 50 million euros should be set for collection** from countries and development partners, in lieu of Water and Sanitation Events in Africa, to support grassroots activities. Focus for this intervention should be placed on the ten (10) countries in which the least progress has been reported in water and sanitation development. The aim will be to reach at least an additional five (5) million people as beneficiaries of water supply and sanitation services in 2015.
- Sixth). It is suggested to submit to the Heads of States and Government, the **designation of his Excellency Paul Kagame, President of Rwanda to lead implementation of required actions** of the Blank Year of Water and Sanitation Events in collaboration with President Sirleaf Johnson, the Goodwill Ambassador on water and sanitation in Africa. He will present the 2015 African Water and Sanitation Report to the AU Assembly.

Strengthening of the African Water and Sanitation Monitoring and Evaluation Process

- Seventh). It is compelling to intensify efforts to facilitate peer-to-peer experimental learning and networks development among the water and sanitation M & E Focal persons at national level, particularly to share lessons from the experiences of the top performing Member States while at the same time appreciating the challenges faced by those Member States facing difficulties in either implementing the commitments and or monitoring their progress.
The process should lead to a broader participation of Member States in the preparation of the Africa-wide report to the Assembly thereby giving a complete picture of the progress made.
- Eighth). In parallel, Member States are called upon to mobilize adequate technical and human resources for a comprehensive capacity needs assessments particularly at national level. This exercise should take center stage in 2014 and its outcomes utilized to inform a programme to strengthen national level M&E systems as well as institutionalizing the vertical (continental-regional-national) and horizontal (between Member States or regional institutions) linkages required to strengthen and fully operationalize the Pan-African Water and Sanitation M&E System.

The above recommendations are submitted for the PRC's consideration and endorsement to form the basis for proposals for related AU Assembly decisions.

The pursuit of the Africa Water Vision 2025 is not an option, especially given the need to unleash Africa's development potential. The African Union commission reaffirms its commitment to providing political guidance to make this happen.
