

Retreat of the Group of African Ambassadors in Brussels on Africa at the Durban Conference on Climate Change: Positions and Strategy

A. Background

In the second revised edition of the Africa-EU Joint Strategy adopted by the third Africa-EU Summit held in Tripoli (Libya) in November 2010, the African Union (AU) Commission committed itself to strengthen the coordination mechanisms to ensure an efficient implementation of the Joint Strategy. Henceforth, the AU Permanent Mission in Brussels is expected to play a key role in the process, mainly through the greater involvement of the Group of African Ambassadors in Brussels in the implementation of the Joint Strategy and by ensuring that there is complementarity between the Joint Strategy and other existing cooperation instruments linking the European Union to Africa. Fully aware of this requirement, the Mission engaged in a thinking process and initiated a number of actions to reach this objective. One of such actions is, among others, the organisation last September of the Conference on the Financing of the Joint Strategy and the support provided for the elaboration of a strategy to foster a greater involvement of the Group of African Ambassadors in Brussels in the follow-up of Africa-EU cooperation. Following up on this momentum, the Mission strives to further explore and popularise the Joint Strategy in view of a better articulation of its objectives with the international cooperation agenda. Hence, having referred to the Partnership on Climate Change and the Environment, it thought it advisable to organise a retreat of the Group of African Ambassadors in Brussels on the theme of Climate Change, in the run-up to the next Conference of Parties to the United Nations Framework Convention on Climate Change (COP 17), to be held from 28 November to 9 December 2011 in Durban, South Africa.

The choice of this theme on climate change is not fortuitous given that for many experts, the Durban Conference could be a major turning point in the negotiations on the climate, particularly as regards the issue of the implementation of binding commitments to reach the objective of a global warming limit of 2°C. Furthermore, the extension or not of the Kyoto Protocol signed in 1997 with an initial time frame

ending in 2012 will be one of the main stakes in Durban. The success or failure of the Durban Conference will undoubtedly depend on the outcome of the negotiations on these major issues. The Retreat will be a real opportunity for the Group of African Ambassadors in Brussels to have further insight into the common positions that Africa will have to defend under the aegis of the AU.

The opportunity will also be seized to examine and adopt the conclusions of the Working Group on "a Greater Involvement of the Group of African Ambassadors in Brussels in the Follow-up of Africa-EU Cooperation". There will also be a brainstorming and an in-depth exchange of views on the cooperation between Africa and the EU, with a view to underlining the challenges, constraints and prospects.

B. Objectives of the Retreat

The objective of the Retreat is twofold:

- 1. Have a better grasp of the multiple stakes of the Durban Conference on Climate Change and offer the Group of African Ambassadors in Brussels an opportunity to be kept abreast of Africa's common position.
- 2. Take stock of actions undertaken by the Mission and the Group of African Ambassadors in Brussels and identify orientations to be used as guidelines for the implementation and follow-up of Africa-EU cooperation in general and of the Joint Africa-EU Strategy, in particular.

C. Organisation of the Retreat

The deliberations will last over two days according to the hereto annexed programme. On the first day participants will examine the report of the Working Group on the involvement of the Group of African Ambassadors in Brussels in the follow-up of the cooperation between Africa and the EU. To enrich the debate, the participants will exchange views on the challenges facing the African Union in general and the Africa-EU cooperation in particular (issues relating to peace and security in Africa, the European debt crisis, the EPAs, etc.).

On the second day the debate will focus on climate change and more specifically on the stakes of the Durban Conference (COP 17). It will be used as an opportunity to inform participants of the African position on the climate and of Africa's strategy to speak in one voice, to advocate for a fair and equitable agreement to cater for its concerns. This session will also be devoted to an exchange of information and views on the Pan African initiatives on climate change.

D. Expected Results

Aside from a more in-depth insight into Africa's position in the framework of the climate change negotiations, the Retreat will facilitate the adoption of a framework to

enhance the coordination of the Group of African Ambassadors in Brussels and will, in the same vein, contribute to give a new impetus to its involvement in the follow-up of Africa-EU cooperation.

E. Date and venue of the Retreat

The Retreat will take place in Liege from Thursday 10 to Friday 11 November 2011 at the following address:

F. Participants

Around seventy participants will be attending the Retreat. They will mainly include the members of the Group of African Ambassadors in Brussels, resource persons from the African Union Commission, African negotiators on climate change, representatives of the European Commission, of ECDPM, of the Regional Economic Communities and of the ACP Secretariat.

G. Languages

The working languages of the Retreat will be French and English and simultaneous interpretation will be provided.
