## THE REPORT ON THE ACTIVITIES OF THE ADMINISTRATIVE SECRETARY GENERAL OF THE ORGANIZATION OF AFRICAN UNITY

In keeping with the instructions of Heads of State and Government on the one had and that of the Council of Ministers on the other, the Administrative Secretary-General has executed the following Resolutions:

ON POLITICAL MATTERS

## I. <u>Apartheid and Racial Discrimination in South Africa</u> CM/Res.31(III) - AHG/Res.5(I) - AHG/Res.6(I) - CM/Res.48(IV)

In conformity with the above mentioned Resolutions, a Bureau of Sanctions was established with a view to co-operate more closely with the Special Committee of the United Nations in charge of the question of Apartheid, and with other anti-Apartheid Organizations with which it often has relations.

At present the Bureau of Sanctions is studying what necessary steps it should adopt with regards to foreign powers who are still sending arms to South Africa despite United Nation's Resolutions on this question.

The Bureau of Sanctions has equally sent circulars and a list of questions to all Member States of the Organization of African Unity asking them to communicate to it, the steps they had already taken to implement these Resolutions of the Organization.

#### II. Countries that are still under Portuguese Colonial Domination

The Administrative Secretary-General of the Organization of African Unity has closely followed the continual evolution of these territories still under Portuguese colonial domination.

The Ministers of Foreign Affairs of Liberia, Madagascar, Sierra-Leone and Tunisia have also been asked to co-operate with the African Group at the U.N.O. in studying what action should be proposed to the Security Council on this question.

#### III. Southern Rhodesia

CM/Res.38(III) - AHG/Res.8(I) - CM/Res.50(IV)

The Administrative Secretary-General has attentively followed the evolution of the explosive situation in Southern Rhodesia and has at the last Extraordinary Session of the Council of Ministers held in Lagos in June 1965, submitted the most recent informations on this issue.

In keeping with the Lagos Resolution - CM/Res.9 of 13th June 1965, Six East African countries met in Nairobi from 20th - 21st July to study in minute details the situation in Southern Rhodesia and the possibility of reconciling the two Nationalist Novements ZAPU and ZANU to form a common front in their struggle. A committee made up of Kenua, Tanzania and Zambia was formed to continue to look into the possibility of reconciliation and to submit a report at the next Session of the Council of Ministers.

On its own part, the Liberation Committee has male attempts at achieving the unity of the Rhodesian National Movement.

#### IV, The African Liberation Committee

AHC/Res.18(I) - CM/Res.5(IV)

The Military Commission of inquiry composed of Cameroon, Mauritania and Sierra-Leone which was given a mandate to find out which of the liberation movements was participating more efficiently in the fight for liberating Protuguese Guinea, went to Guinea and Senegal. Its report has been submitted to the Council.

The Committee of Three composed of United Arab Republic, Ghana and Congo (Brazzaville) and whose mission was to reconcile GRAE and MPLA into forming a common front in their struggle, should be meeting before this Session of the Council of Ministers.

#### V. The Refugees question

CM/Res.36(III) and CM/Res.52(IV)

In enforcing these resolutions, the Administrative Secretary-General summoned to Leopoldville, on 7th July, the Committee of Experts appointed by the Member States of the Special Commission for Refugee problems.

The Committee studied the first draft convention, noting the comments and observations of Member States and elaborated on the Second draft convention. On this occasion, United Nation's High Commissioner responsible for Refugee problems, was invited to take part in the meeting of the Committee of Legal Experts.

#### VII. The Algerian-Moroccan frontier dispute

CM/Res.1(I) - CM/Res.53(IV)

The last Session of the Special Commission for the solving of the frontier conflict between Algeria and Morocco, was at the request of Algeria postponed to a date after the Conference of Heads of State and Government.

#### The African Group at the United Nations

CM/Res.8(I) - CM/Res.54(IV)

In accordance with Resolution CM/54(IV), the African Group at the United Nations should have met to draw up a plan on its internal regulations. Uptill now, no copy of this plan has been sent to the Secretariat.

#### VIII. African Representation at the United Nations

CM/Res.41(III) - AHG/Res.13(I) - CM/Res.55(IV)

On the 10th of July 1965, the Administrative Secretary-General sent letters to the Government of Burundi, Congo (Leopoldivlle) and Somalia through their Embassies in Addis Ababa, and telegrams directly to the Governments of Congo (Brazzaville), and Dahomey asking them to ratify the amendments of the Charter of the United Nations. Thirty African countries have already deposited their instruments of ratification and amendment of the Charter.

## The Admission of Gambia into the Organization of African Unity \*CM/Res.57(IV)

The Administrative Secretary-General of the Organization of African Unity, had notified the Government of Gambia that it had become the 36th rightful Member of the Organization of African Unity.

## X. Financing the Law-suit against South-Africa on the question of the territory of South-West Africa

CM/Res.58(IV)

The Fourth Ordinary Session of the Council of Ministers having decided that the whole cost of the proceeding against South-Africa on the question of the territory of South-West Africa should be shared equally among all African countries. The Administrative Secretary-General of the Organisation of African Unity sent to each Member State, a bill on the amount to be paid as contribution towards the financing of the proceedings; and also informed them to send this amount to the Executive Secretariat of the African Group at the United Nations.

XI. The Administrative Secretary-General has been unable to submit the draft Statute of Administrative Tribunal to the present Session, for reasons which are clearly explained in the report on that subject.

### XII. The Payment of Contributions of Member States

CM/Ros.61(IV)

For the efficient working of its administration the General Secretariat of the Organisation of African Unity has sent to each Member State, the bill on their contributions to the ordinary budget and the special funds, which should be settled at the latest, six months after the date scheduled for payment. Up till now, less than 17 States have paid in their contributions to the ordinary budget. A Resolution asking each Member State to settle its contributions before the end of August, was adopted during the Fifth Extraordinary Session of the Council of Ministers held in Lagos last June.

REPORT OF ADMINISTRATIVE SECRETARY GENERAL ON THE HOLDING
OF THE FIFTH SESSION OF THE COUNCIL OF MINISTERS
AND THE SECOND SESSION OF THE CONFERENCE



1. On 15 July 1965, President Kwame Nkrumah of Ghana sent a letter requesting the Administrative Secretary-General of the OAU to circulate to all Heads of State and Government of OAU Member States a proposal stating "... with reference to the decision of the Heads of State and Government contained in Resolution AHG/Res.22 (1) adopted on 21 July, 1964, in Cairo regarding the holding of a Summit Conference in Acera this year, I very much regret to inform you that in spite of all exceptional efforts and diligence to arrange the Conference for the 1st of September, 1965, the new Conference Hall, accommodation for Heads of State and other a illary buildings now in the course of construction specially for the Conference will be completed by the 30th September this year.

After due consideration of all the factors aimed at making the Summit Conference a very successful one, I would like to propose that the Conference of the second regular session of the Assembly of Heads of State and Government will start on 21 October 1965, preceded by the meeting of the Council of Ministers on the 12th October 1965."

- 2. In response to the above request by the President of Ghama, the Administrative Secretary-General despatched the following cable message to all Heads of State and Government of Member States:
  - "... HONOUR INFORM THAT PRESIDENT GHANA AS HOST BY LETTER PROPOSES POSTPONEMENT SUMMIT CONFERENCE TO TWENTYFIRST OCTOBER PRECEEDED BY COUNCIL OF MINISTERS MEETING ON TWELVETH OCTOBER BECAUSE QUOTE DESPITE EXCEPTIONAL EFFORTS AND DILIGENCE OF GHANA'S PART THE CONFERENCE BUILDING ONLY BE COMPLETED BY THIRTYTH SEPTEMBER THIS YEAR UNQUOTE COPY OF LETTER FOLLOWS STOP GRATEFUL REPLY URGENTLY HIGHEST AND DEFERENTIAL CONSIDERATION."

The original copy of the letter of the President of Ghana was immediately transmitted by registered airmail and sent to all Member States.

- 3. In reply to the request of the President of the Republic of Ghana, numerous messages (telegrams and letters) have been received by the General Secretariat and some of them have been the subject of exchange of letters. The most important and most significant of these integral copies of messages are attached as annex to the present report for the information of Heads of State and Government and the Council of Ministers.
- 4. Following the reserved acceptances and initial refusals transformed into acceptances and the clarifications on certain messages the General. Secretariat has on 8th of October recorded 30 positive replies in principle for the postponement of the African Summit. Among these 25 were in favour of the dates suggested by Ghana. By the same date three States had not yet replied to the initial message from the Administrative Secretary-General while two others gave varying replies without formal opposition to the entire proposal of Ghana, like one State which declared that it adhers to the decision of the majority of Member States.

In consequence to the above and in conformity with its mandate, the Administrative Secretary-General informed all African Heads of State and Government of this situation and its consequence which means the acceptance of Ghana's proposal by two-third majority of Member States. The result being the following message on the holding of the Conference of Heads of State and Government on Twenty-first October. This would be preceded on the twelvth by the Fifth Ordinary Session of the Council of Ministers.

"Honour inform two-third majority on Ghana proposal obtained stop. Consequently Council and Assembly start meetings Accra twelve and twenty-first October Stop Defrential consideration".

#### GHANA

The President of the Republic of Ghana sent to the Secretary-General a message informing him that the Ghana Government had accomplished all its obligations resulting from the Lagos Resolution and has expelled all refugees whose presence in Ghana was considered as unlesimable for some Heads of State and Government. This message is being immediately circulated to all Heads of State and Government.


