Messers René Kouassi and Klaus Rudischhauser, respectively, Director of the Economic Affairs Department of the Commission of the African Union and Director of Relations with the African, Caribbean and Pacific (ACP) States of the European Commission will make presentations on the aspects relating to the financing of the Joint Strategy.

The Mission would like to request Their Excellencies the Ambassadors and the Minister Counsellors or First Secretaries to kindly grace this important Conference through their personal presence.



Conference on the role of the European external action service (EEAS) In the implementation of the joint EU-Africa Strategy (JAES) and its action plan

<u>Tuesday 19 April 2011</u> <u>Hotel Métropole</u>, Brussels

I. Background

The Lisbon Treaty was signed by 27 EU member states on 13 December 2007 and entered into force on 1 December 2009. It created the European external action service (EEAS), with the view to make the EU's external action more coherent and efficient, thereby increasing the European Union's influence in the world.

On 19 November 2009, Baroness Catherine Margaret Ashton was appointed the EU's first High Representative of the Union for Foreign Affairs and Security Policy. She is also the Vice-President of the European Commission in addition to heading the EEAS. Article 27, paragraph 3, of the Lisbon Treaty constitutes the legal basis for the organization and the functioning of the EEAS ¹.

The EEAS has become operational since the end of 2010, after adoption by the Council of all the legal instruments required for its organization and functioning². According to Baroness Ashton, the EU will be at the forefront in the area of development cooperation, through the EEAS. Although the development policy and its financial instruments will remain the responsibility of the Commission, any proposal or change in the EU development policy (European development funds and other development cooperation instruments), will be jointly done by the EEAS and the Commission. This joint programming seeks to foster harmonization between foreign policy, security and development policy. While it means that the EEAS plays a significant role in international cooperation and development policies, it still raises three fundamental questions over its role in the implementation of the JAES:

- 1. How can the EEAS goals on development cooperation be reached, given the fact that its means of action in this particular area seem limited?
- 2. What will be the place of the JAES in the action of the EEAS?

3. Who will be the main interlocutor of the AU Commission in the political dialogue between Africa and Europe, considering the fact that the partnership between the EU and Africa is broad and includes various areas of development cooperation?

II. Objectives

The AU permanent mission in Brussels is organizing a Conference on the role of the EEAS in the implementation of JAES in order to answer the aforementioned questions. With the recent adoption of a new Action Plan for 2011-2013 under the JAES, and the launch of the EU Green Paper on development policy, the question of the role of the EEAS in the implementation of JAES Strategy cannot be overemphasized. It should also be recalled that during the Conference on the Lisbon Treaty and its implications for the cooperation between EU and Africa organized by the Mission in April 2010, the participants had expressed the wish to further discuss the Lisbon Treaty, particularly the role of the EEAS. Therefore, this activity is a follow up to the Conference on the Lisbon Treaty and its overall objective is to deepen and broaden the debate on the EU-Africa partnership.

The specific objectives of the Conference are to exchange views on:

- The role and added value of the EEAS in development cooperation, particularly in the implementation of the JAES;
- The existing and/or possible collaboration modalities between the EEAS and African stakeholders (AU Commission, African Group of Ambassadors in Brussels, etc.), in the implementation of the JAES.

III. Expected results

- A clear understanding of the roles, responsibilities and areas of intervention of the EEAS in the implementation of the JAES;
- 2) Identification of practical modalities that will enable the EEAS, the AU Commission and the African Group of Ambassadors in Brussels, to work in close collaboration for the implementation and follow up of the JAES.

IV. Participants
