REPORT OF THE COMMISSION ON THE IMPLEMENTATION OF PREVIOUS DECISIONS OF THE EXECUTIVE COUNCIL AND THE ASSEMBLY

JANUARY AND JULY 2019

INTRODUCTION

- 1. RULE 4 1(b) of the Rules of Procedure of the Assembly states: "The Assembly shall monitor the implementation of Policies and Decisions of the Union as well as ensure compliance by all Member States through appropriate mechanisms". In a similar provision, RULE 5 1(d) of the Rules of Procedure of the Executive Council states: "The Executive Council shall monitor the implementation of the Policies Decisions and Agreements adopted by the Assembly". Reporting on the implementation of previous decisions of the Assembly and the Executive Council has therefore become a mandatory feature on the agenda of the PRC and Executive Council during their Ordinary Sessions as this constitutes an effective mechanism in ensuring that there is a follow up on decisions taken.
- 2. In light of the foregoing, this Report is a synopsis of measures taken by all the organs of the Union and Member States to implement the various Decisions and Declarations adopted by the Policy Organs of the Union during the February and July 2019 sessions, during the period under review, that is, **January to December 2019**. It gives an account of actions taken towards implementation of decisions, challenges encountered and proposed solutions/way forward. The total number of Decisions being reported on by the Organs of the Union and Member States are ninety six (96) of which forty three (43) are Executive Council, forty eight (48) are Assembly, four (4) Extraordinary Session of the Assembly and one (1) Mid-Coordination Meeting Decisions.
- 3. The activities carried out during the period under review cover diverse subjects and a number of vital issues of interest to Member States and that have a direct impact on the welfare of African citizens. They range from legal, structural, administrative, financial, and political and peace and security, gender and youth issues to socio-economic, political as well as AU reform matters. Some of the activities form part of the reports currently being considered under the Agenda of the Executive Council and/or that of the Assembly.
- 4. It is important to note that the Report covers only decisions for which actions are expected from AU Organs and Member States. In this regard, a matrix was sent to Member States for inputs on decisions to be implemented by Member States. However, none Member States reported. About 65% of the decisions taken by the Policy organs are to be implemented by Member States and therefore it is of paramount importance that they report on these decisions.
- 5. Brief analysis of number of Decisions taken by the Policy Organs over the past ten (10) years :

- 6. Statistics show that the total number of decisions taken at each Summit are increasing despite the call by the 2015 Johannesburg Summit to rationalize the number of decisions. Decisions at the Assembly level continue to increase, whereas those taken at the Executive council have decreased. In addition, Executive Council Decision EX.CL/Dec.898(XXVIII) Rev.1 states that "Decisions proposed by the Commission do not exceed three (3) per Department and also ensure full implementation within the reporting period before another decision is taken on the same subject matter." However, this decision is not fully complied with when the Policy Organs are submitting decisions hence the continued increase of decisions without the corresponding increase in rate of implementation of the same.

9. Following the analysis of the annexed report, the common challenges faced by Departments in implementation of decisions include insufficient time to implement and

- report on decisions, budgetary, human and technical constraints, duplication of reports and reporting fatigue.
- 10. It is worth noting that implementation of decisions has improved. However, more efforts should be deployed to ensure full implementation and compliance with the Union's obligations.

Recommendations

- 11. There is need to address the issue of duplication in reports and reporting fatigue through the introduction of a single centralized reporting system that encompasses all reports required of the Commission;
- 12. It is of paramount importance to rationalize the number of decisions taken per Summit in accordance Executive Council Decision **EX.CL/Dec.898(XXVIII)** Rev.1 Numerous decisions are still taken without due consideration to the financial, legal and structural implications of the decisions being proposed for adoption by the Executive Council and Assembly. This in turn results into poor rate of implementation of decisions.
- 13. Departments and AU Organs must ensure compliance with the guidelines on preparation and adoption of decisions, for instance, the observance of the requirement for submission of not more than three Decisions per Summit as per Executive Council Decision **EX.CL/Dec.898(XXVIII) Rev.1.**
- 14. Institutionalize an award for Member States with high rate of implementation of AU decisions with a view to recognizing them and increasing the rate of implementation of decisions of the Policy Organs by the Member States.
- 15. The Commission and Member States should avoid writing long and repetitive reports/decisions without indicating what is required of the Council and Assembly. Also, new decisions that contradict already adopted decisions should be avoided.
