OF THE EXECUTIVE COUNCIL AND THE ASSEMBLY**

INTRODUCTION

This Report is a synopsis of implementation of the various Decisions, Declarations and other measures of the policy organs of the Union, by the Departments, Directorates and Units of the Commission during the period under review that is January 2009 to June 2009, with a focus on Decisions taken at the 12th Ordinary Session of the Assembly in February 2009.

During their various Ordinary, Extraordinary and Special Sessions, the Executive Council and the Assembly of the Union, indeed, adopted quite a number measures at the conclusion of their deliberations. Such measures constitute the legal authority, which commits the Commission and other organs of the Union to pursue activities in furtherance of the integration process in the Continent. Many of the activities were carried out in collaboration with Member States, the other AU Organs as well as other stakeholders and partners such as RECs in the form of consultation and coordination meetings designed to harmonize viewpoints and actions, and were quite often geared to adoption of common positions and harmonized policy decisions.

The activities carried out during the period under review cover diverse subjects and a number of vital issues of interest to Member States. They range from legal, administrative, financial, political and peace and security issues to economic, social, scientific and cultural matters. Some of the activities form part of the reports currently being considered under the Agenda of the Executive Council and/or that of the Assembly.

However, in view of budget and human resource constraints during the period under review, some of the decisions with high degree of financial implications were not implemented; while others, for technical reasons and/or time constraints, were deferred to a later date pending improved or conducive conditions or when the constraints would have eased.

As the past experience has shown, many decisions were taken at various sessions with very little degree of implementation which impacts on credibility. It is most important that decisions are taken on the basis of a thorough assessment of their financial implications, human resource and institutional capacity requirements, both at the AUC and other concerned Organs' levels as well as at the level of Member States involved in the process of implementation.
