REPORT ON ELECTION OF ONE (1) MEMBER OF THE AFRICAN UNION ADVISORY BOARD ON CORRUPTION

1. The election of the Members of the African Union Advisory Board on Corruption are based on the provisions of the African Union Convention on Preventing and Combating Corruption (the Convention) adopted in July 2003 as well as the Rules of Procedure of the Executive Council.

2. The Advisory Board on Corruption was established under Article 22(1) of the Convention. Article 22(2) of the Convention provides that the Advisory Board on Corruption shall be composed of eleven (11) members elected by the Executive Council from among a list of experts of the highest integrity, impartiality, and recognized competence in matters relating to preventing and combating corruption and related offences, proposed by the State Parties.

3. In addition, Articles 22(3) - (4) of the Convention provide that the members shall serve in their personal capacity and that they shall be appointed for a term of two (2) years renewable once.

4. The Commission would like to inform the Executive Council that the term of office of the following member of AUABC who was elected in January 2018 for a term of two (2) years will expire in January 2020:

a) Ms. Amal Mahmoud Ammar (Egypt)

5. The outgoing member is eligible for re-election.

6. Accordingly, the Commission, through its Note Verbal reference number BC/OLC/24.12.1/22.30.19 dated 03 October 2019 invited States Parties to the Convention to submit candidatures on or before the deadline of 30 November 2019.

7. The Commission would like to inform the Executive Council that the candidature received from a State Party to the African Convention on Preventing and Combating Corruption is as follows:
