PROGRESS REPORT ON THE

IMPLEMENTATION OF PANAFRICAN TELECOMMUNICATIONS

NETWORK

- 1. The Pan African Telecommunications Network is now on the threshold of realization. The Co-ordinating Committee established by OAU resolution CM/309(XXI) and composed of OAU, ECA, ITU and ADB has exerted continuous efforts, so that its latest report shows that almost 80% of the finance needed to excute the project is now available and thus the greater part of the network is assured of financing.
 - 2. The last meeting of the Coordinating Cornittee held at the Head-quarters of the OAU from 12 to 13 December 1974, under the chairmanship of the Administrative Secretary-General, examined the progress so far achieved. Through bilateral contacts made on behalf of the Committee and from reports received from individual African countries the situation of the Project is as follows:
 - 80% of the financing is practically assured
 - 8 countries (Guinea, Mali, Dahomey, Togo, Upper Volta, Sudan, Senegal, Mauritania) have already issued invitations to tender
 - Some countries have requested financing and the results are being awaited
 - Some countries are yet to request financing.
- The table attached to this report as annex I gives the situation on the availability of finance for the major portion of the Network. The table attached as annex II indicates the routes for which finance is not yet obtained.

- 4. The Coordinating Committee is making a special effort to help secure finance for these sectors that are at the moment not very attractive to financiers, and it is hoped that this would find solution soon. The cooperation of the countries concerned is at the same time essential to ensure the acquisation of finance.
- 5. The Coordinating Committee at the conclusion of its meeting drew up its latest report and recommendations and wishes it to be forewarded to the Assembly of Heads of State and Government. This report is attached herewith as Annex III. The Council might wish to review the situation and refere it to the Assembly for its consideration.
- 6. It would be noted in the report that a meeting of Telecommunications administrations is envisaged to be convened during 1975. The meeting is expected to take place during the latter part of the year. An important question that the meeting is expected to deliberate upon beside the implementation of the Pan-African Telecommunications Network is the establishment of an African Telecommunications Union.
- 7. In this connections it is to be recalled that the Summit Conference of the East and Central African States meeting in Khartoum in 1970 adopted a resolution calling for the establishment of an African Telecommunications Union. It requested the OAU to draft a constitution for such a Union, in cooperation and consultation with ECA and ITU.
- 8. Accordingly, the OAU in cooperation with ECA and in consultation with ITU drafted a constitution and presented it to the Summit Conference of East and Central African States in September 1974 in Brazzabille. The draft was distributed to all Member States of the OAU. The Brazzaville Summit noted the draft and urged the countries in the sub-region to participate in the constitutive Conference when it is convened. The draft Constitution is attached herewith as annex IV for information of the Council.

9. The establishment of an African Telecommunications Union is an important factor in the orderly development of Telecommunications in Africa. Furthermore it would provide a vital machinery for collective action in the implementation and management of the Pan African Telecommunications

Network. Now that the preliminary task is accomplished, the Council might consider giving the green light for the establishment of an African Telecommunications Union and urge all Member States to participate fully in the envisaged conference of 1975.

REPORT OF THE COORDINATING COMMITTEE ON THE IMPLEMENTATION OF THE PAN-AFRICAN TELECOMMUNICATIONS NETWORK

- 1. The Coordinating Committee of the Pan-African Telecommunication.

 Network meeting at the OAU Headquarters in Addis Ababa on 12 and 13

 December 1974 reviewed the progress made so far towards the implementation of PANAFTEL and submits the following observations and recommendations to the Assembly of Heads of State and Government of the OAU.
- 2. Early in 1968, at a meeting held in Addis Ababa, the Secretary-General of ITU and the Executive Secretary of ECA decided to submit a. request to the UNDP for funds to finance the preliminary work of collecting the information required to define the scope and extent of the assistance to be sought from the UNDP for the entire project. preliminary survey was carried out by a armup of ITU Experts with UNDP. financing during the period 1968-1970. During that study the experts examined all possible transmission media, i.e. openwire lines, co-axial cables, sub-marine cables, radio relay systems as well as a regional sattellite system, and concluded that the most appropriate system for the immediate needs of Africa is a combination of co-axial cables and radio relay systems. This conclusion was justified by the fact that PANAFTEL should not only serve to provide connection between the major national centers. Accordingly the detailed survey that is just completed by specialized consultant firms has studied PANAFTEL using the above selected transmission media.
- 3. The major field work of PANAFTEL having been completed in 1972, a Coordinating Committee, composed of OAU, ECA, ADB and ITU for ensuring the realization of the Pan-African Telecommunication Network was created by Resolution CM/Res. 309(XXI) of the 10th OAU Assembly of Heads of State

and Government, Addis Ababa in May 1973. Since its establishment, the Committee has not only held several meetings of its own but also convened a number of consultative meetings with representatives of multilateral and bilateral sources of finance.

- 4. As a result of these meetings, bilateral and multilateral financing institutions have:
 - a. undertaken to provide most of the necessary finance for the PANAFTEL Project, and
 - b. accepted the role of technical and financial coordination, by the Coordinating Committee through its technical and financial Sub-committee constituted by the ITU and ADB, respectively.
- 5. It is the view of the Committee that the priority given to the Pan-African Telecommunication Network by African countries has encouraged several sources of financing to give generous assistance to individual and groups of countries in the implementation of several sectors of the Network. Through the continued action of the countries themselves and of the Coordinating Committee, it has been possible to arrange the financing of almost all of the Network.
- 6. Since it is essential that all sectors of PANAFTEL should be implemented and that the African Administrations need to obtain the required finance from abroad at reasonable cost, the Committee requested ADB to continue its search for additional development funds, in particular from the various Arab financial sources, including Arab Bank for Economic Development in Africa and Technical Assistance Fund for African States with the view to providing credit to all of the countries that are in need of such assistance.
- 7. As resolved at the Meeting on the Implementation of the Pan-African Telecommunications Network held in Addis Ababa in 1972, the Pan-African Telecommunications Network is to be considered as an integrated whole. This requires continuous coordination of activities such as preparation of specifications, evaluation of tenders, operating and maintenance procedures, evaluation of tenders adequate training of staff and supervision and acceptance of installations.

- 8. The Committee has noted that the preparation of specifications as well as the submission of final reports by the ITU have progressed satisfactorily. Nontheless, the African Telecommunications administrations are strongly urged that they regularly consult with each other on subregional basis so as to ensure the compatibility of their respective specifications and whenever possible to issue tenders jointly in order to ensure compatibility of equipment and obtain economic prices.
- 9. Noting that the successful utilization of PANAFTEL would essentially depend not only on the operating procedures adopted but also on the efficiency of maintenance achieved on each and every section of it, the African Telecommunication Administrations have been urged to study and adopt efficient traffic operating procedures and to set up appropriate engineering instructions so that all countries would ensure that their standard of maintenance would not fall below a certain agreed minimum.
- 10. A most serious constraint in the development of telecommunication in Africa is undoubtedly the lack of trained manpower in many specialities and levels. The efforts of the countries and the ITU to set up national and multinational centers have been noted with appreciation. Nevertheless, much remains to be done in all sectors of telecommunications such as broadcasting and civil aviation. Existing institutions should be expanded and up-graded and new ones established in order to produce the required manpower.
- 11. The Coordinating Committee also commends the ITU for the various PANARTEL seminars it has organized for the benefit of African countries and recommends that the holding of such seminars should continue as they form one of the most effective ways of up-grading the knowledge of staff at the higher levels of management.
- in the development of an efficient and modern telecommunications network within Africa. The next stage will be the consideration of the complementary systems including satellite communication. Additional national and intercountry trunk circuits need to be provided as time goes by. Each step of such development will go hand in hand with the development of traffic which itself is generated by the facilities provided by earlier steps.

RECOMMENDATIONS

To ensure the continuity of the coordination which has so success-fully been achieved sine the 1972 Addis Ababa Conference, it is <u>recommended</u> that:

- I Another PANAFTEL meeting at the level of Directors General of Telecommunication administration, assisted by their engineers, should be convened by ITU under the auspices of the Coordinating Committee before the end of 1975 in order to:
 - a. review the progress made by the first stage of PANAFTEL Network,
 - b. take necessary steps to formulate and adopt regional recommendations on operating and maintenance procedures,
 - c. study and recommend appropriate tarrifs,
 - d. ensure the provision of the required staff not only for the efficient operation of the network but also for the maintainance,
 - e. identify national and intercountry routes and switching centers which should form the basis for the next stage in the development of the PANAFTEL Network and to ensure that the required studies are undertaken as soon as possible,
 - f. study other matters which are of interest for the general development of telecommunications in Africa,
- II. This 1975 conference should also consider the setting up of the proposes African Telecommunications Union;
- III. The Coordinating Committee should continue to meet regularly in order to:
 - undertake any further directives of the Assembly of Heads of State and Government,

- review the progress being made in the implementation of the present stage of the PANAFTEL Network and to assist the countries whenever necessary in order to ensure the timely execution and the effective operation of the Network,
- review the proposals that may be submitted by the 1975 Conference concerning the planning and implementation of future stages of the PANAFTEL.



Draft Constitution Pan-African Telecommunication Union

The representatives of national telecommunication organizations of Africa:

- persuaded of the need to ensure orderly development of regional telecommunication services at a pace commensurate with the political, economic and social development of the African regions
- considering that there is a need arising out of current Pan-African telecommunication development for collective action in the detailed planning and management of the projected regional telecommunication network;
- convinced of the need for a permanent machinery to co-ordinate operational arrangements between national telecommunication organizations especially as regards technical aspects of signalling, switching, traffic distribution and revenue sharing

hereby agree to set up a regional telecommunication union, which shall be known as the "Pan-African Telecommunication Union" and which shall be governed by the following statutes:

ARTICLE I

Establishment

- 1. The Pan-African Telecommunication Union (hereinafter referred to as the Union) shall be composed of the national telecommunication organizations of members of the Organization of African Unity and of the United Nations Economic Commission for Africa.
- 2. The term telecommunication organization shall apply to any national organization responsible for nation-wide and public, transmission and or reception of electromagnetic signals of video, sound, data or any form of intelligence by wire, radio or other electromagnetic systems.
- 3. The official languages of the Union shall be English and French.

ARTICLE II

Membership of the Union

1. Membership of the Union shall be open to all national telecommunication organizations of member states of OAU and ECA which:

- (a) operate and provide telecommunication services and facilities (point-to-point and or broadcasting) on a nation-wide basis; and
- (b) operate these services and facilities for the benefit of the public generally.
- 2. Associate Membership of the Union shall be on such conditions as the General Assembly may determine and shall be open to:
 - (a) national telecommunication organizations which operate and provide telecommunication services and facilities (point-to-point and or broadcasting) within the territory of a State which is not a member State of the OAU and ECA;
 - (b) telecommunication organizations within the territory of a member State of the OAU and ECA whose services and facilities are not for the benefit of the public generally.

ARTICLE III Objectives

- The objectives of the Union shall be:
 - (a) to provide a rational basis for the development of the national components of an efficient Regional telecommunication network;
 - (b) to seek the standardisation, improvement and co-ordination of telecommunication services of the members of the Union;
 - (c) to seek the co-ordination of the commercial relations between members of the Union in such areas as tariff structures and revenue sharing;
 - (d) to seek the general adoption of rational and conomic operating methods in national and regional telecommunication services;
 - (e) to undertake studies in telecommunications and in other relevant fields of common interest to members of the Union;
 - (f) to promote the establishment of multi-national telecommunications training institutes in Africa, in co-operation with international organizations with legitimate interest in telecommunications in Africa;
 - (g) to examine and adopt in consultation with OAU and ECA a common position on propositions presented at international conferences on telecommunications; and

(h) to encourage the exchange of information end staff between member organizations

ARTICLE IV Institutions

The Union shall have the following organs:

- (a) The General Assembly
- (b) The Council
- (c) The General Secretariat
- (d) Such subsidiary bodies as may be established by the General Assembly.

ARTICLE V

The General Assembly

- 1. The Union shall convene once every two years in General Assembly.
- 2. (a) The General Assembly shall consist of the accredited representatives of members of the Union.
 - (b) Accreditation shall be by means of instruments signed by the Minister responsible for External/Foreign Affairs or by the Minister responsible for Telecommunications and shall confer full powers, including when necessary the right to sign final acts.
- 3. The General Assembly shall elect from among its members, persons to hold the offices of President and Vice Presidents of the Union. The President and Vice Presidents shall each hold office for two years and may be eligible for re-election for a further period of two years to any of these offices provided that no person shall be eligible for re-election to the offices of President, Vice President for more than two consecutive terms.
- 4. The General Assembly shall be presided over by the President of the Union, and shall on his request, meet once in two years in ordinary session. During each session, the venue for the next meeting shall be determined.
- The General Assembly may be convened in extra-ordinary session by the President, on his own initiative or at the request of a member subject to the agreement of two-thirds of the full members of the Union.
- 6. Where the President of the Union is for any reason unable to perform his functions under this Article, a Vice President of the Union chosen by the General Assembly for that purpose, shall perform the functions of the President of the Union.

7. The General Assembly shall adopt its own Rules of Procedure for all its meetings including rules, except as otherwise provided for in this Constitution, relating to time and notice of meeting, representation of a member of the Union by another member of the Union, voting, the participation of the representatives of associate members of the Union and other proceedings thereat.

8.1 The General Assembly shall

- (a) notwithstanding the provisions of paragraph 7 of this Article approve any amendments to this Constitution by the votes of at least two-thirds of the members of the Union, cast at a meeting of the General Assembly;
- (b) determine the general principles and policies governing the activities of the Union;
- (c) review and approve the programme of activities, budget and accounts of the Union;
- (d) assess the annual contributions to be paid by members and associate members of the Union; ,
- (e) submit to the OAU and the ECA a bi-annual report on the activities of the Union;
- (f) establish the General Secretariat, its offices and the appointment of persons to such offices;
- (g) establish such subordinate bodies as it may deem necessary or desirable for the purpose of achieving the objectives of the Union and prescribe for such bodies rules for the conduct of their activities; and
- (h) approve rules governing the financial, administrative and other activities of the Union including the entering into contracts by the Union and the establishment of relationships between the Union and Governments or institutions desirous of assisting the Union or its members in achieving the objectives of the Union.
- 8.2 (a) Subject to the provisions of sub-paragraphs 1 (a) and 4 of this paragraph, the decisions of the General Assembly, shall be supported by a simple majority of votes that may be cast at a meeting of the General Assembly.

- (b) Each member of the Union shall have one vote: provided that a member organization of the Union which is jointly owned by or administered and operated on behalf of more than one of the member States of the OAU and ECA, shall have as many votes as the number of member States of the OAU and ECA who jointly own it or on whose behalf it is administered and operated.
- 8.3 Associate Members of the Union shall be entitled to attend and participate at all meetings of the General Assembly but shall not vote threat or be eligible for election to office.
- 8.4 The General Assembly may dissolve the Union by two-thirds majority of votes cast by all the members of the Union, at a meeting of the General Assembly.
- 8.5 Upon the approval of the General Assembly made in pursuance of subparagraph 4 of this paragraph, the General Assembly shall appoint a Committee for the purpose of liquidating the assests of the Union.
- 8.6 At the end of each meeting of the General Assembly, it shall adopt a Report which shall be circulated to all members and associate members of the Union and to the CAU and ECA.
- 8.7 The President shall where appropriate under the provisions of this Constitution, have a casting vote.

ARTICLE VI

The Council

- 1.1 The Council shall consist of the resident and the four Vice Presidents of the Union.
- 1.2 The President of the Union shall be the president of the Council.
- 1.3 The Council shall meet once a year and shall determine its own rever for its meetings and procedures thereat. Representatives of the OAU and Oa, shall be invited to attend meetings of the Council but shall not be entitled to vote.

2. The Council shall:

- (a) be entrusted with the over-all duty of guiding the administration of the Union;
- (b) keep under review, direct control and co-ordinate the financial, technical and other activities of the organs of the Union including those of its subsidiary bodies established in accordance with this Constitution;
- (c) consider the programme of activities, budget and accounts of the Union and submit them to the General Assembly for approval;
- (d) propose for the approval of the General Assembly the annual subscriptions to be paid by the members and associate members of the Union;
- (e) present a report on the activities of the Union during the two years of office to the General Assembly;
- (f) determine the representation of the Union at meetings where the Union is required to be represented or otherwise;
- (g) propose for the approval of the General Assembly rules governing the financial, administrative and other activities of the Union including the entering into contracts by the Union and the establishment of relationships between the Union and Governments or institutions desirous of assisting the Union or its members in achieving the objectives of the Union; and
- (h) propose for the approval of the General Assembly such subsidiary bodies as it may deem necessary or desirable for the performance of its functions.
- 3. The Council shall act on behalf of the Union for the purpose of Article VIII of this Constitution and may delegate any of its functions to such subsidiary bodies established by the General Assembly or to the General Secretary.

ARTICLE VII

The General Secretariat

1. The General Secretariat shall provide secretarial services to the General Assembly and the Council and convene their meetings in accordance with this Constitution.

- 2. The General Secretariat shall:
 - (a) keep all records of the Union
 - (b) prepare the provisional programme of activities, budget and accounts of the Union and its organs and submit them to the Council; and
 - (c) perform any of the functions that may be delegated to it by the Council.
- 3. The head of the General Secretariat shall be called the Secretary General who shall be appointed by the General Assembly upon recommendation by the Council.
- 4. The Secretary General shall:
 - (a) ensure the efficient functioning of the General Secretariat;
 - (b) attend all meetings of the General Assembly and Council, in an advisory capacity; and
 - (c) unless otherwise provided, represent the Union at meetings where the Union is required to be represented or otherwise.

ARTICLE VIII

Status of the Union

The Council shall conclude with the Government of the State in whose territory the General Secretariat will be situated an agreement relating to the legal capacity and the privileges and immunities to be recognised and granted in connexion with the Union.

ARTICLE IX

Relationship with the CAU, ECA and ITU

- 1. The Union shall maintain special relationship with the Organization of African Unity and the United Nations Economic Commission for Africa and the shall assist the Union in the implementation of its objectives.
- 2. The Union shall establish and maintain close and continuous working relationship with the Organization the African Unity, the United Nations Economic Commission for Africa and/International Telecommunication Union.

ARTICLE X

Relationship with other Bodies

- 1. The Union shall be guided in its associations and activities by the spirit of the Charter of the Organization of african Unity and the Convention of the International Telecommunication Union.
- 2. The Union shall establish such relationships as the General issembly may deem necessary.

ARTICLE XI

Withdrawal and Suspension

- 1. Any member of the Union may withdraw from the Union at any time after the expiration of one year from the date on which it became a member of the Union, by giving written notice of its withdrawal to the President of the Union through the Secretary General. The Secretary General shall forthwith inform all members of the receipt of such notice of withdrawal.
- 2. Mithdrawal shall become effective one year from the date of receipt by the Secretary General of the notice of withdrawal: provided that any member of the Union withdrawing from the Union shall nevertheless, remain liable for the fulfilment of its financial obligations to the Union, including the payment of assessed contributions in respect of the entire year in which the notice of withdrawal takes effect.
- 3. The General Assembly may, by a two-thirds majority of all votes that may be cast at its meeting, suspend a member of the Union who persistently fails to meet its financial obligations towards the Union, fails to furfill my other obligations under its constitution, or fails to comply with the decisions of the General Assembly. The same majority shall be required for a decision of the General Assembly to revoke the suspension imposed on a member of the Union. The suspension of a member of the Union shall not relieve that member from the fulfilment of its financial obligations during the period of suspension.
- 4. The General Assembly may prescribe rules relating to the withdrawal and suspension of associate members of the Union.

ARTICLE XII

Interpretation and Settlement of Disputes

- 1. Any dispute that may arise concerning the interpretation or application of any provision of this Constitution, which cannot be settled by the members of the Union concerned, shall be submitted to the General Assembly.
- 2. If the General Assembly cannot reach a conclusion on the dispute or if the conclusion of the General Assembly is not accepted by the members of the Union concerned, either party to the dispute may request that the matter be submitted to arbitration by an Arbitration Tribunal composed of three members who shall be nominated as follows:
 - (i) each party shall nominate one arbitrator;
 - (ii) the third arbitrator, who shall be the president of the Arbitration Tribunal, shall be chosen by agreement between the arbitrators nominated by the parties.

If the nomination of the members of the Arbitration Tribunal is not made within a period of three months from the date of the request for arbitration, either of the parties to the dispute may request the President of the Union to make the necessary nominations, except that, in cases where the Union is a party to the dispute, the nomination shall be made by the Administrative Secretary General of the Organization of African Unity.

- 3. The decision of the Arbitration Tribunal shall be final and binding on the parties to the dispute.
- 4. The provision of paragraphs 2 and 3 of this Article shall be without prejudice to the choice of any other mode of settlement that the parties concerned may jointly decide upon in keeping with the spirit of the Constitution of the Union.

ARTICLE XIII

Final Provisions

1. This Constitution shall come into force when signed on behalf of at least ten national telecommunication organizations eligible for membership under the terms of this Constitution and whereupon such organizations shall become members of the Union.

- 2. National telecommunication organizations wishing to become members of the Union after the coming into force of this Constitution may do so by communicating to the General Secretariat of the Union, their notice of accession to this Constitution.
- 3. This Constitution of which the English and French texts are equally authentic shall be deposited with the Administrative Secretary General of the Organization of African Unity, who shall transmit certified copies thereof to members or associate members of the Union.

IN WITNESS WHEREOF, the undersigned being duly authorized representatives of their respective national telecommunication organizations have signed this Constitution on the dates appearing under their signatures.
